

CHAPTER xcix.

An Act to confirm certain Pilotage Orders made by the Board of Trade under the Pilotage Act 1913 relating to pilotage in the Pilotage Districts of the Forth (Trinity House of Leith) Borrowstounness Burntisland Charlestown Grangemouth Kirkcaldy Leith and Methil.

[4th August 1922.]

WHEREAS the Board of Trade have made the Pilotage Orders set forth in the schedule hereto under the provisions of the Pilotage Act 1913 but the same do not take effect unless and until confirmed by Parliament:

And whereas it is expedient that the said Pilotage Orders should be confirmed by Parliament:

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

- 1. The Pilotage Orders set out in the schedule hereto Confirmation shall be and the same are hereby confirmed and all the of Orders in provisions thereof shall have full validity and force.
- 2. This Act may be cited as the Pilotage Orders Short title. Confirmation (No. 4) Act 1922.

THE FORTH PILOTAGE ORDER.

The Forth.

1.—(1) There shall be established a Pilotage District Pilotage which shall be called the Forth (Trinity House of Leith) Pilotage District and is hereinafter referred to as "the Pilotage District."

(2) The limits of the Pilotage District shall be as follows:—

The waters of the sea the Firth of Forth and the River Forth bounded seawards by an imaginary line drawn from the North Carr Beacon in the county of Fife to the South Carr Beacon in the county of Haddington and bounded landwards by an imaginary line drawn transversely to the River Forth from a point on its west bank one hundred yards south of the West Pier of the Abbey Ferry at Stirling together with all tidal and closed docks within such area but excluding the Harbours of Rosyth (and the dredged channels leading thereto from St. Margaret's Hope) and Port Edgar Provided that nothing in this section shall extend to authorise a pilot for the Pilotage District to pilot a vessel within any part of this area which lies within the limits of the Port of Leith or of any other pilotage district if such vessel is proceeding to or from or making use of such port or of a port in such district unless he is specifically authorised to do so by the terms of his licence.

2.—(1) There shall be constituted for the Pilotage Pilotage District a Pilotage Authority which shall be a body Authority. corporate with perpetual succession and a common seal by the name of the Forth (Trinity House of Leith) Pilotage Authority (hereinafter referred to as "the Authority ").

(2) The Authority shall consist of eighteen members to be appointed and elected as follows:—

(a) The Master of the Corporation of the Trinity House of Leith ex-officio together with five other members appointed by that Corporation from among their own members;

(b) One member appointed by the Admiralty;

- (c) One member appointed by the Forth Conservancy Board;
- (d) One member appointed by the Corporation of Kirkcaldy;
- (e) One member appointed by the Commissioners for the Harbour and Docks of Leith;
- (f) One member appointed by the Caledonian Railway Company;

(g) One member appointed by the North British Railway Company;

- (h) Three members being shipowners or persons interested in shipping to be appointed by the Leith Shipowners' Society (of whom one shall be a Grangemouth shipowner) or if at any time that body shall in the opinion of the Board of Trade cease to be fairly representative of the shipowners making use of the ports within the Pilotage District then by such body or bodies representing shipowners as shall be nominated for the purpose by the Board of Trade;
 - (i) Three pilots from among the six persons (hereinafter referred to as "Pilots' representatives") elected in manner hereinafter provided by the pilots licensed for the Pilotage District (hereinafter referred to as "licensed pilots") from among persons who either are or have been licensed pilots.
- (3) The members of the Authority shall be appointed and elected at the times and in the manner in the First Schedule hereto provided.

Chairman of the Authority. 3. The Master of the Corporation of the Trinity House of Leith for the time being shall be the chairman of the Authority if he is prepared to serve If at any time he is unable to do so the Authority shall elect a chairman from among their members and the chairman so elected shall hold office until the next triennial appointment and election of members has taken place.

Proceedings of the Authority.

- 4.—(1) The chairman if present shall preside at every meeting of the Authority If the chairman is absent at any meeting the senior member of the Corporation of the Trinity House of Leith then present shall preside.
- (2) Every question at a meeting of the Authority shall be decided by a majority of the votes of the members of the Authority present and voting on that

question and in the case of equality of votes the person presiding at the meeting shall have a second or casting vote.

- (3) The quorum of the Authority shall be five.
- (4) No member of the Authority shall take part in any proceedings of the Authority relating to any question affecting himself personally.
- (5) Subject to the provisions of this Order the Authority may regulate their own procedure.
- (6) No act or proceeding of the Authority shall be invalid on account of any vacancy in their body or on account of the appointment or election of any member having been defective.
- 5. Pilotage shall not be compulsory in the Pilotage District.

Pilotage not to be compulsory.

- 6. Members of the Authority shall hold office until Period of such time as their successors may be appointed or elected office. respectively.
- 7. Members of the Authority going out of office may Retiring members eligible for be re-appointed or re-elected respectively.

re-appointment or re-election.

- 8.—(1) The rights powers and duties hitherto exercised Transfer by other Pilotage Authorities whose Districts are between the eastern and western limits of the Pilotage District in regard to the examination of candidates for pilots' licences and pilotage certificates the granting and renewal of such licences and certificates and the exercise of the disciplinary rities to the powers provided for in the Pilotage Act 1913 so far as Authority. they may involve the revocation or suspension of a pilot's licence or of a pilotage certificate shall be transferred to and vested in the Authority Provided that until the Authority have been fully constituted by the appointment or election of members as provided in this Order the existing Pilotage Authorities in the Firth of Forth or River Forth shall retain all their respective rights powers and duties as existing prior to the commencement of this Order.
- (2) Where a candidate for a pilot's licence or a pilotage certificate or the holder of such a licence or certificate desires that his licence or certificate shall authorise him to pilot a ship in any of such other Pilotage Districts as aforesaid he shall apply to the Pilotage

A.D. 1922. Authority for such District and that Authority shall refer the application to the Authority for the necessary action and shall if they desire be represented on the examining body by an examiner having local knowledge of their District.

> (3) A pilot's licence or a pilotage certificate shall show the name of every pilotage district in respect of which it is valid and for the purposes of this subsection the Port of Leith shall be regarded as a Pilotage District.

Pending proceeding and existing contracts.

- 9.—(1) If at the date of the commencement of this Order any proceeding cause or action is pending or existing by or against the Corporation of the Trinity House of Leith in their capacity as Pilotage Authority the same shall not abate discontinue or be in any way prejudicially affected by reason of anything in this Order but the proceeding cause or action may be continued prosecuted and enforced by or against the Authority as it might have been by or against that Corporation if this Order had not been made but not further or otherwise.
- (2) All contracts deeds bonds agreements and other instruments subsisting immediately before the commencement of this Order and affecting the Corporation of the Trinity House of Leith in their capacity as Pilotage Authority shall be of as full force and effect against or in favour of the Authority and may be enforced as fully and effectively as if instead of that Corporation the Authority had been a party thereto.
- (3) All pilots licences and pilotage certificates granted by the Corporation of the Trinity House of Leith or any other Pilotage Authority in the Firth of Forth prior to the commencement of this Order shall have the same force and validity as if they had been granted by the Authority under the provisions of the Pilotage Act 1913.

Power to provide or arrange for supply of pilot boats and to borrow money therefor.

10.—(1) The Authority may acquire own hire build renew maintain and work vessels for the purposes of this Order and may at their discretion either sell or exchange any such vessels. If a majority of the pilots concerned object to the Authority exercising these powers or if a difference arises between the Authority and the pilots as to the conditions on which these powers should be exercised the matter shall be referred to the Board of Trade whose decision shall be final.

(2) For the purpose of giving effect to the provisions of A.D. 1922. subsection 1 of this section the Authority may borrow at interest on the security of such vessels and of the Pilot The Forth. Fund of the Pilotage District any sum or sums which may. be required therefor provided that all moneys so borrowed by the Authority shall be applied by them to the purposes thereof and not otherwise.

11. The Authority may make byelaws providing for Deep sea the grant of deep sea certificates certifying that persons certificates. to whom such certificates are granted are qualified to act as pilots of ships for any part of the sea or channels outside the District of any other Pilotage Authority constituted under the Pilotage Act 1913 Provided that a pilot holding such a certificate shall not be entitled to supersede any other person as pilot of a ship.

12. While and so long as the Corporation of the Trinity Office of the House of Leith desire it the office of the Authority shall Authority. be the House of the Trinity House of Leith and the said Corporation shall be paid such a sum in respect of such occupation and other services as may be agreed from time to time between the said Corporation and the Authority and failing agreement as may be fixed by the Sheriff of the Lothians and Peebles.

- 13. So soon as the Authority have been fully Repeal. constituted as provided in this Order the enactments specified in the Second Schedule hereto shall cease to have effect and shall for the purposes of section fifty-nine of the Pilotage Act 1913 be deemed to be superseded.

SCHEDULES.

FIRST SCHEDULE.

With respect to the appointment and election of members of the Authority the following provisions shall have effect that is to say:—

- 1. The appointed members shall be appointed by the various bodies authorised to do so as soon as may be after the commencement of this Order and thereafter triennially in the course of the month in which the first appointments were made.
- 2.—(1) The pilots' representatives shall be elected by the licensed pilots as soon as may be after the commencement of this Order and thereafter triennially during the course of the month in which the first election took place.
 - (2) For the purpose of electing the pilots' representatives the clerk to the Leith Trinity House in the case of the first election and thereafter the secretary to the Authority shall send out by registered letter to all the licensed pilots a circular announcing an election and enclosing a list of persons qualified under this Order to be pilots' representatives a voting card and a stamped envelope addressed to himself in which the card when filled in is to be returned within twenty-one days of the issue of the circular.
 - (3) Every licensed pilot shall be entitled to vote for six persons whose names are on the said list but shall not give more than one vote for any one person.
 - (4) At the expiration of twenty-one days from the issue of the said circular the said clerk in the case of the first election and thereafter the said secretary shall examine the voting cards returned to him and shall prepare a list in order of the six persons who have received the greatest number of votes (any uncertainty by reason of two or more persons having received an equal number of votes being decided in favour of the licensed pilot or pilots having the longest service) and such persons shall thereupon be the pilots' representatives This list shall be posted up in the pilots' office.
 - (5) The first three pilots' representatives on the list referred to in the preceding subsection shall be members of the Authority but in the event of one or more of these being unable to attend any meeting of the Authority one or more as the case may be of the three other pilots' representatives may according to the order in which their names appear on the list attend take part in the proceedings and vote in his or their stead.

3. The costs charges and expenses of and preliminary and incidental to the election of pilots' representatives shall be paid by the Authority out of the pilot fund,

4. In the event of any vacancy among the appointed or elected members of the Authority arising otherwise than by effluxion of time the vacancy shall be filled as soon as may be thereafter in the manner prescribed for the triennial appointment or election but any person so appointed or elected shall hold office only until the next triennial appointment or election.

1. The limits of the Burntisland Pilotage District (hereinafter referred to as "the Pilotage District") shall be the waters of the sea within a radius of one nautical mile from the outer Head of the West Pier at Burntisland including any closed-in docks and locks within this area.

2. The Pilotage Authority for the Pilotage District shall be the North British Railway Company (hereinafter referred to as "the Authority").

3. Pilotage shall not be compulsory in the Pilotage District.

1. The limits of the Methil Pilotage District (hereinafter referred to as "the Pilotage District") shall be the waters of the sea within a radius of fifteen hundred yards from the Pier Head at Methil including any closed-in docks and locks within this area.

Pilotage Authority. 2. The Pilotage Authority for the Pilotage District shall be the North British Railway Company (hereinafter referred to as "the Authority").

Pilotage not to be compulsory.

3. Pilotage shall not be compulsory in the Pilotage District.

Transfer of certain powers and duties to the Forth Authority.

- 4.—(1) From and after the commencement of this Order the rights powers and duties hitherto exercised by the North British Railway Company in regard to the examination of candidates for pilots' licences and pilotage certificates the granting and renewal of such licences and certificates and the exercise of the disciplinary powers provided for in the Pilotage Act 1913 so far as they may involve the revocation or suspension of a pilot's licence or of a pilotage certificate shall be transferred to and vested in the Forth (Trinity House of Leith) Pilotage Authority (hereinafter referred to as "the Forth Authority") Provided that until all the members of the Forth Authority have been appointed or elected under the provisions of the Forth Pilotage Order 1922 the North British Railway Company shall retain all their pilotage powers and duties as existing prior to the commencement of this Order.
- (2) The Authority shall submit all applications from candidates desiring pilots' licences or pilotage certificates for the Pilotage District to the Forth Authority for the necessary action but the Authority shall if they so desire be represented by an examiner having local knowledge of the Pilotage District on the examining body appointed by the Forth Authority in respect of such candidates.

Repeal.

5. So soon as the Forth Authority have been fully constituted as provided in the Forth Pilotage Order 1922 sections sixty-four to sixty-six and Schedule (D) of the Leven Harbour Act 1876 section twenty-eight of the Pier and Harbour Orders Confirmation (No. 1) Act 1883 and that part of the Schedule to that Act which relates to pilotage dues and any other enactment or Order

relating to pilotage in the Pilotage District shall cease A.D. 1922. to have effect and shall for the purposes of section fifty-nine of the Pilotage Act 1913 be deemed to be superseded.

6. This Order shall come into force one month after Date of comthe day when the Act confirming this Order is passed.

Date of commencement of Order.

7. This Order may be cited as the Methil Pilotage Short title. Order 1922.
