CHAPTER civ.

An Act to confirm a Provisional Order of the A.D. 1930.

Minister of Health relating to Hendon Rural

District. [10th July 1930.]

WHEREAS under the provisions of the Public 38 & 39 Vict. Health Act 1875 the Minister of Health has c. 55. made a Provisional Order which needs confirmation by Parliament:

Be it therefore enacted by the King's most Excellent
Majesty by and with the advice and consent of the Lords
Spiritual and Temporal and Commons in this present
Parliament assembled and by the authority of the same
as follows:—

- 1. The Order of the Minister of Health which is Order in set out in the schedule to this Act is hereby confirmed schedule and shall have full validity and force.
- 2. This Act may be cited as the Ministry of Health Short title. Provisional Order Confirmation (Hendon Rural) Act 1930.

SCHEDULE.

RURAL DISTRICT OF HENDON.

Hendon (Rural) Order. Provisional Order to enable the Rural District Council of Hendon to put in force the compulsory clauses of the Lands Clauses Acts.

WHEREAS the rural district council of Hendon (in this order referred to as "the Council") require to purchase and take the lands described in the schedule to this order for the purpose of receiving storing disinfecting and otherwise disposing of sewage in pursuance of their powers under section 27 of the Public Health Act 1875:

Now therefore the Minister of Health in pursuance of the powers given to him by section 176 of the Public Health Act 1875 and of all other powers enabling him in that behalf hereby orders as follows:—

Compulsory powers of purchase.

1. For the purposes recited in this order the Council may put in force with reference to the lands described in the schedule to this order (subject to the continuance of existing public rights of highway if any) all or any of the powers of the Lands Clauses Acts as modified by the Acquisition of Land (Assessment of Compensation) Act 1919 with respect to the purchase and taking of lands otherwise than by agreement.

Short title commencement and interpretation.

- 2.—(1) This order may be cited as the Hendon (Rural) Order 1930 and shall come into operation on the date of the Act of Parliament confirming it.
- (2) In the schedule to this order "the deposited plan" means the plan which was deposited for the purposes of this order in the Office of the Minister of Health on the eighteenth day of December nineteen hundred and twenty-nine of which duplicates were on the same day deposited in the Office of the Clerk of the Parliaments House of Lords and in the Committee and Private Bill Office of the House of Commons.
