CHAPTER xcvii.

An Act to confirm certain Provisional Orders of A.D. 1930. the Minister of Health relating to Ashby-de-la-Zouch and Slough. [10th July 1930.]

WHEREAS under the provisions of the Public 38 & 39 Vict. Health Act 1875 the Minister of Health has made c. 55. certain provisional orders which need confirmation by Parliament:

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

- 1. The Orders of the Minister of Health which are Orders in set out in the schedule to this Act are hereby confirmed schedule and shall have full validity and force.
- 2. This Act may be cited as the Ministry of Health Short title. Provisional Orders Confirmation (Ashby-de-la-Zouch and Slough) Act 1930.

For the purpose recited in this order the Council may put in force with reference to the lands described in the schedule to this order (subject to the continuance of existing public rights of highway if any) all or any of the powers of the Lands Clauses Acts as modified by the Acquisition of Land (Assessment of Compensation) Act 1919 with respect to the purchase and taking of lands otherwise than by agreement.

Short title commence-ment and interpreta-tion.

- 2.—(1) This order may be cited as the Ashby-de-la-Zouch Order 1930 and shall come into operation on the date of the Act of Parliament confirming it.
- (2) In the schedule to this order "the deposited plan" means the plan which was deposited for the purposes of this order in the Office of the Minister of Health on the nineteenth day of November nineteen hundred and twenty-nine of which duplicates were on the same day deposited in the Office of the Clerk of the Parliaments House of Lords and in the Committee and Private Bill Office of the House of Commons.
