CHAPTER XXXV.

An Act to confirm certain Provisional Orders of A.D. 1931. the Minister of Health relating to Manchester and the South Staffordshire Joint Small-pox Hospital District. [8th July 1931.]

WHEREAS under the provisions of the Public Health 38 & 39 Vict. Act 1875 the Minister of Health has made certain c. 55. provisional orders which need confirmation by Parliament:

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

- 1. The orders of the Minister of Health which are Orders in set out in the schedule to this Act are hereby confirmed schedule and shall have full validity and force.
- 2. This Act may be cited as the Ministry of Health Short title. Provisional Orders Confirmation (Manchester and South Staffordshire Joint Small-Pox Hospital District) Act 1931.

Manchester Order.

Provisional Order for partially repealing and amending the Manchester Market Act 1846.

WHEREAS the city of Manchester is an urban district of which the lord mayor aldermen and citizens acting by the council are the local authority for the purposes of the Public Health Act 1875 and by the Manchester Market Act 1846 as amended by subsequent local Acts and orders duly confirmed by Parliament the corporation are empowered to establish a cattle market;

And whereas by section 40 of the local Act of 1846 the Corporation are authorised to take in their cattle market the tolls specified in Schedule C to that Act;

And whereas the corporation have applied to the Minister of Health for the issue of a provisional order partially to repeal and amend the local Act in manner following:

Now therefore the Minister of Health in pursuance of the powers given to him by section 303 of the Public Health Act 1875 and of all other powers enabling him in that behalf hereby orders as follows:—

Commencement short title and interpretation.

- 1.—(1) This order may be cited as the Manchester Order 1931 and shall come into operation on the date of the Act of Parliament confirming it.
- (2) In this order "the local Act" means the Manchester Market Act 1846.

Amendment of section 40 of local Act.

- 2. Section 40 of the local Act shall be amended as follows:—
 - (a) for the words "stallages rents and tolls" where they first occur there shall be substituted the words "tolls in respect of the exposure to sale of cattle and other live stock";
 - (b) the words "stallages rents and" where they secondly occur shall be repealed; and
 - (c) at the end of the section the following words shall be added:—

"The council may also in connection with the cattle market provide facilities for the lairage slaughtering and feeding of cattle and other live

SOUTH STAFFORDSHIRE JOINT SMALL-POX HOSPITAL DISTRICT.

Provisional Order altering certain confirming Acts.

South Staffordshire Order.

WHEREAS by virtue of the South Staffordshire Joint Small-pox Hospital Orders 1903 to 1929 (which were confirmed by Parliament) as amended by the Wolverhampton Corporation Act 1926 certain boroughs other urban districts and rural districts constitute a united district called the South Staffordshire Joint Small-pox Hospital District of which the governing body is the South Staffordshire Joint Small-pox Hospital Board;

And whereas it is expedient that the urban district of Brierley Hill should be included in the united district:

Now therefore the Minister of Health in pursuance of the powers given to him by section 297 of the Public Health Act 1875 [Ch. xxxv.] Ministry of Health [21 & 22 Geo. 5.] Provisional Orders Confirmation (Manchester and South Staffordshire Joint Small-Pox Hospital District) Act, 1931.

A.D. 1931. and of all other powers enabling him in that behalf hereby orders as follows:—

Interpretation.

- 1. In this order unless the context otherwise requires—
 - "the orders" means the South Staffordshire Joint Small-pox Hospital Orders 1903 to 1929;
 - "the joint board" means the South Staffordshire Joint Small-pox Hospital Board;
 - "the united district" means the South Staffordshire Joint Small-pox Hospital District;
 - "constituent authority" means an authority mentioned in column 2 of the schedule to this order;
 - "the urban district" means the urban district of Brierley Hill;
 - "the district council" means the council of the urban district;
 - "the appointed day" means the date upon which this order comes into operation.

Short titles and commencement.

- 2.—(1) This order may be cited as the South Staffordshire Joint Small-pox Hospital Order 1931 and the orders and this order may be cited together as the South Staffordshire Joint Small-pox Hospital Orders 1903 to 1931.
- (2) This order shall come into operation on the date of the Act of Parliament confirming it.

Extension of united district.

3. The united district shall be extended so as to include the urban district and (subject to the provisions of this order) references in the orders to constituent districts and constituent authorities shall be deemed to include the urban district and the district council respectively.

Future constitution of joint board.

4. The number of elective members of the joint board shall be increased from fifty-two to fifty-three and the orders shall be amended by the addition of the entries in the several columns of the schedule to this order to the corresponding columns of the schedule to the South Staffordshire Joint Small-pox Hospital Order 1928.

Election of elective member by new constituent authority.

5. The provisions of article XI. of the South Staffordshire Joint Small-pox Hospital Order 1903 shall apply to the first election by the district council of the elective member to represent them on the joint board as if the election related to the filling of a vacancy occurring on the appointed day.

Adjustment of expenses &c.

6. The Minister of Health upon the application of any of the constituent authorities or of the joint board may adjust as between the constituent authorities or as between the constituent authorities and the joint board any expense or liability incurred [21 & 22 Geo. 5.] Ministry of Health [Ch. xxxv.] Provisional Orders Confirmation (Manchester and South Staffordshire Joint Small-Pox Hospital District) Act, 1931.

by or attaching to the joint board before the appointed day or any expense liability or accounts arising out of incidental to connected with or affected by the inclusion of the urban district in the united district or any expense liability or accounts in respect of which doubt or difference may arise after the appointed day.
