

## CHAPTER xxiii.

An Act to confirm a Provisional Order under the A.D. 1932. Private Legislation Procedure (Scotland) Act 1899 relating to Coatbridge Drainage. [16th June 1932.]

HEREAS the Provisional Order set forth in the schedule hereunto annexed has been made by one of His Majesty's Principal Secretaries of State under the provisions of the Private Legislation Procedure 62 & 63 (Scotland) Act 1899 as read with the Secretaries of State Vict. c. 47. Act 1926 and it is requisite that the said Order should 16 & 17 be confirmed by Parliament:

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

- 1. The Provisional Order contained in the schedule Confirmation of Order in hereunto annexed is hereby confirmed. schedule.
- 2. This Act may be cited as the Coatbridge Drainage Short title. Order Confirmation Act 1932.

## SCHEDULE.

## COATBRIDGE DRAINAGE.

Provisional Order to authorise the Coatbridge Town Council to borrow further moneys for the purposes of their sewerage and drainage undertaking and for other purposes.

WHEREAS by the Coatbridge Drainage and Burgh Extension Order 1914 (hereinafter referred to as "the Order of 1914") the provost magistrates and councillors of the burgh of Coatbridge (hereinafter referred to as "the Town Council") were authorised to make and maintain the main and branch sewers and other works described in section 6 (Power to execute works) of that Order and in connection therewith to construct and maintain the sewage purification and sludge disposal works authorised by section 20 (Lands for sewage purification) of that Order and to borrow the sum of eighty thousand pounds for the purposes of the sewerage and drainage undertaking authorised by that Order:

And whereas by the Coatbridge Burgh Order 1920 (hereinafter referred to as "the Order of 1920") the amount which the Town Council were authorised to borrow by the Order of 1914 was increased to two hundred and fifty thousand pounds:

And whereas the works authorised by the said section 6 of the Order of 1914 (estimated in that Order to cost thirty-one thousand five hundred pounds) have been completed but the cost of labour and materials not having been reduced as anticipated by the Town Council when the Town Council's borrowing powers were increased by the Order of 1920 the cost of constructing the said works amounted to one hundred and twelve thousand seven hundred and fifty pounds:

And whereas estimates have been prepared for the construction of the said sewage purification and sludge disposal works authorised by the said section 20 of the Order of 1914:

And whereas such estimates are as follows:--

A.D. 1932.

For the construction of sewage purification and sludge disposal works and relative works at Luggie Glen and Brewsterford including the acquisition of lands at Brewsterford - £212,000

And whereas the said works included in such estimates are permanent works and it is expedient that the cost thereof should be spread over a term of years as provided in the Order of 1914:

And whereas it is expedient that the borrowing powers of the Town Council should be increased so as to authorise the Town Council to borrow a further sum of seventy-five thousand pounds for the purposes of the said works authorised by the Order of 1914 in addition to the moneys which they are authorised to borrow by the Order of 1914 as amended by the Order of 1920:

And whereas the purposes aforesaid cannot be effected without an Order confirmed by Parliament under the provisions of the Private Legislation Procedure (Scotland) Act 1899:

Now therefore in pursuance of the powers contained in the last-mentioned Act as read with the Secretaries of State Act 1926 the Secretary of State orders as follows:—

- 1. This Order may be cited as the Coatbridge Short title. Drainage Order 1932.
- 2. The following words and expressions in this Interpreta-Order have the meanings hereby assigned to them tion. (that is to say):—
  - "Town Council" means the provost magistrates and councillors of the burgh of Coatbridge;
  - "Order of 1914" means the Coatbridge Drainage and Burgh Extension Order 1914;
  - "Order of 1920" means the Coatbridge Burgh Order 1920.
- 3. Section 44 (Power to borrow) of the Order of Further 1914 as amended by section 7 (Additional borrowing borrowing powers) of the Order of 1920 shall be read and construed powers.

A.D. 1932. as if the sum of three hundred and twenty-five thousand pounds were inserted therein in lieu of the sum of two hundred and fifty thousand pounds.

Costs of Order.

4. All costs charges and expenses of and incident to the preparing for obtaining and confirming of this Order or otherwise in relation thereto shall be paid by the Town Council out of any moneys in their hands which are not specifically allocated to any other purpose or out of any moneys borrowed under the powers of the Order of 1914 the Order of 1920 or this Order and if paid out of borrowed moneys shall be repaid out of revenue within five years from the passing of the Act confirming this Order.
