## CHAPTER lxiv.

An Act to confirm a Provisional Order of the A.D. 1935.

Minister of Health relating to the borough of Croydon.

[2nd August 1935.]

WHEREAS under the provisions of the Public 38&39 Vict. Health Act 1875 the Minister of Health has made c. 55. a Provisional Order which needs confirmation by Parliament:

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

- 1. The order of the Minister of Health which is Order in set out in the schedule to this Act is hereby confirmed schedule and shall have full validity and force.
- 2. This Act may be cited as the Ministry of Health Short title. Provisional Order Confirmation (Croydon) Act 1935.

## BOROUGH OF CROYDON.

Provisional order altering a local Act.

WHEREAS the mayor aldermen and burgesses of the county borough of Croydon acting by the council (in this order called "the corporation") are the local authority for the purposes of the Public Health Act 1875 and the Croydon Corporation Act 1930 (in this order called "the Act of 1930") is in force in the borough;

And whereas by section 5 of the Act of 1930 the corporation were authorised to enter on take and use certain lands shown on the deposited plans and described in the deposited book of reference for and in connection with the street works authorised by section 9 of the Act of 1930 and for other purposes of that Act and by section 6 of that Act a period of five years from the thirty-first day of December nineteen hundred and thirty was limited for the exercise of the powers of the corporation for the compulsory purchase of the said lands;

And whereas the corporation have applied to the Minister of Health for the issue of a provisional order to amend the Act of 1930 in the manner following:

Now therefore the Minister of Health in pursuance of the powers given to him by section 303 of the Public Health Act 1875 and of all other powers in that behalf hereby orders as follows:—

Short title and commencement.

1. This order may be cited as the Croydon Order 1935 and shall come into operation on the date of the Act of Parliament confirming it.
