## CHAPTER lxvi.

An Act to confirm a Provisional Order of the A.D. 1935.

Minister of Health relating to the borough of

Morley. [2nd August 1935.]

WHEREAS under the provisions of the Public 38 & 39 Vict. Health Act 1875 the Minister of Health has made c. 55. a Provisional Order which needs confirmation by Parliament:

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

- 1. The order of the Minister of Health which is Order in set out in the schedule to this Act is hereby confirmed schedule and shall have full validity and force.
- 2. This Act may be cited as the Ministry of Health Short title. Provisional Order Confirmation (Morley) Act 1935.

## BOROUGH OF MORLEY.

Provisional order altering the Morley Corporation Act 1923.

WHEREAS the mayor aldermen and burgesses of the borough of Morley acting by the council (in this order called "the corporation") are the local authority for the purposes of the Public Health Act 1875 and the Morley Corporation Act 1923 (in this order called "the local Act") as amended by the Morley Order 1929 and the Morley Order 1934 (which orders were duly confirmed by Parliament) is in force in the borough;

And whereas by section 10 of the local Act the corporation were authorised to purchase by agreement additional lands for the purposes of their water undertaking but the quantity of lands to be held by them in pursuance of the said section at any time was restricted to ten acres;

And whereas the corporation have applied to the Minister of Health for the issue of a provisional order to amend the local Act in the manner following:

Now therefore the Minister of Health in pursuance of the powers given to him by section 303 of the Public Health Act 1875 and of all other powers in that behalf hereby orders as follows:—

Short title and commencement.

- 1. This order may be cited as the Morley Order 1935 and shall come into operation on the date of the Act of Parliament confirming it.
- Purchase of additional lands by agreement.
- 2. For subsection (1) of section 10 of the local Act there shall be substituted the following subsection:—
  - "(1) Subject to the provisions of this Act the corporation in addition to any other lands acquired by them in pursuance of this Act may with the consent of the Minister of Health by agreement purchase take on lease acquire and hold such further lands as they may from time to time require for the purposes of their water undertaking and the corporation may on all or any of such additional lands

> execute for the purposes of or in connection with their A.D. 1935. waterworks any of the works (excepting any wells and works for taking or intercepting water other than Work No. 2 authorised by section 6 of the Morley Corporation Water Act 1890) and exercise any of the powers mentioned in or conferred by section 12 (Undertakers subject to provisions of this and the special Act may execute the works herein named) of the Waterworks Clauses Act 1847."
