CHAPTER lxxviii.

An Act to confirm a Provisional Order of the A.D. 1935.

Minister of Health relating to the Fylde Preston
and Garstang Joint Smallpox Hospital District.

[2nd August 1935.]

WHEREAS under the provisions of the Public 38 & 39 Vict. Health Act 1875 the Minister of Health has c. 55. made a Provisional Order which needs confirmation by Parliament:

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

- 1. The order of the Minister of Health which is Order in set out in the schedule to this Act is hereby confirmed schedule and shall have full validity and force.
- 2. This Act may be cited as the Ministry of Health Short title. Provisional Order Confirmation (Fylde Preston and Garstang Joint Smallpox Hospital District) Act 1935.

FYLDE PRESTON AND GARSTANG JOINT SMALLPOX HOSPITAL DISTRICT.

Provisional order altering certain Confirming Acts.

WHEREAS by virtue of the Fylde Preston and Garstang Joint Smallpox Hospital Orders 1905 to 1926 (in this order called "the hospital orders") as amended by the Lancashire (Central and Western Areas) Review Order 1934 and the County of Lancaster Review Order 1935 the boroughs of Blackpool Fleetwood Lytham Saint Anne's and Preston and certain urban and rural districts constitute a united district called the Fylde Preston and Garstang Joint Smallpox Hospital District of which the governing body is the Fylde Preston and Garstang Joint Smallpox Hospital Board (in this order called "the joint board") consisting of two ex-officio members and thirty-two elective members representing the councils of the said boroughs and urban and rural districts:

And whereas it is expedient that the urban district of Walton-le-Dale should be included in the united district aforesaid and that the hospital orders amended as aforesaid should be altered as in this order provided:

Now therefore the Minister of Health in pursuance of the powers given to him by section 297 of the Public Health Act 1875 and of all other powers enabling him in that behalf hereby orders as follows:—

Date of operation.

1. This order shall come into operation on the first day of October 1935:

Provided that sections 6 and 7 of this order shall come into operation on the date of the Act of Parliament confirming this order.

Extension of united district.

2. The Fylde Preston and Garstang Joint Smallpox Hospital District shall be extended so as to include the urban district of Walton-le-Dale and subject to the provisions of this order references in the hospital orders to the constituent districts shall

be deemed to include the urban district of Walton-le-Dale and references in those orders to the constituent authorities shall be deemed to include the council of the urban district of Walton-le-Dale.

Fylde Preston and Garstang Order.

3. The joint board shall consist of two ex-officio members and thirty-three elective members and the ex-officio members shall be the persons described in column 3 of the schedule to this order and the number of elective members to be elected by each of the constituent authorities shall be that set opposite the name of the constituent authority in column 4 of that schedule.

Ex-officio and elective members of joint board.

4. The hospital orders shall have effect as if the schedule Substitution to this order were substituted for the schedule to the Fylde Preston and Garstang Joint Smallpox Hospital Order 1926.

5. The provisions of article XI of the Fylde Preston and Election of Garstang Joint Smallpox Hospital Order 1905 shall apply to the first election by the council of the urban district of Walton-le-Dale of the elective member to represent that council on the joint board as if the election related to the filling of a vacancy occurring authority. at the commencement of this order.

elective member by new constituent

6. For the purpose of any adjustment of property income Adjustment debts liabilities and expenses which may become necessary in consequence of the provisions of this order section 151 of the Local Government Act 1933 shall apply subject to any necessary modifications.

7. The Minister of Health may hold any inquiry which he Inquiries may deem necessary for the purposes of this order and section and 290 of the Local Government Act 1933 shall apply as if the joint expenses. board were a local authority.

8. This order may be cited as the Fylde Preston and Garstang Short and Joint Smallpox Hospital Order 1935 and the hospital orders and this order may be cited together as the Fylde Preston and Garstang Joint Smallpox Hospital Orders 1905 to 1935.
