CHAPTER cxxiv.

An Act to confirm a Provisional Order under the Land A.D. 1914.

Drainage Act 1861 in the matter of a proposed Drainage
District in the parishes of Brede Udimore Beckley
Peasmarsh Rye and Rye Foreign in the County of Sussex.

[31st July 1914.]

WHEREAS the Board of Agriculture and Fisheries have made the Provisional Order set forth in the schedule hereto under the provisions of the Land Drainage Act 1861: 24

24 & 25 Vict. c. 133.

And whereas it is requisite that the said Order should be confirmed by Parliament:

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

- 1. The Order as set out in the schedule hereto shall be and Order in the same is hereby confirmed and all the provisions thereof shall schedule confirmed. have full validity and force.
- 2. This Act may be cited as the Land Drainage (Tillingham Short title. Valley) Provisional Order Confirmation Act 1914.

SCHEDULE.

LAND DRAINAGE ACT 1861.

PROVISIONAL ORDER.

In the matter of a proposed Drainage District in the parishes of Brede Udimore Beckley Peasmarsh Rye and Rye Foreign in the County of Sussex.

- 1. The Board of Agriculture and Fisheries in pursuance of the powers vested in them by the Land Drainage Act 1861 and the Board of Agriculture and Fisheries Acts 1889 to 1909 do by this Provisional Order constitute the lands shown on a plan sealed by the Board and therein coloured pink a separate drainage district under the Land Drainage Act 1861.
- 2. And they do further by this their Provisional Order make the following regulations with respect to the Drainage Board (that is to say):—
 - (A) The Drainage Board for the said district shall consist of ten members:
 - (B) The following persons shall be members of the first Drainage Board:—

Edmund Austen of Coleman House Brede in the county of Sussex;

Arthur Nicholas Burra of Homestall Faversham in the county of Kent;

Henry Curteis Burra of Springfield Playden in the said county of Sussex;

Colonel Edward Frewen C.B. of Brickwall Northiam in the said county of Sussex;

Moreton Frewen of Brede Place Brede aforesaid;

Alfred Kenward Holmes of Cross House Udimore in the said county of Sussex;

John George Mair-Rumley of the Hammonds Udimore aforesaid;

Charles Frank Reeve of Lea Farm Peasmarsh in the said county of Sussex;

Ernest James Vidler of Rye in the said county of Sussex; and

Harry Willett of Bishopstone Manor Lewes in the said county of Sussex:

- (c) The first meeting of the Drainage Board shall be summoned A.D. 1914. by a notice under the hands of any two or more members of the Drainage Board which shall be published in some newspaper circulating in the said district and shall be posted at the principal entrance doors of the places of public worship in the said parishes of Brede Udimore Beckley Peasmarsh Rye and Rye Foreign at least fourteen days before the day of meeting:
- (D) The qualification of any subsequent member of the Drainage Board shall be that he shall be (1) the proprietor of not less than ten acres of land within the said district or (2) the heir apparent of a proprietor (such proprietor not being himself a member of the Board) of not less than ten acres of land within the said district or (3) the occupying tenant yearly or otherwise of not less than twenty acres of land within the said district or (4) the agent of a proprietor of not less than ten acres of land within the said district such agent acting under a written appointment and his principal not being a member of the Board:
- (E) The members of the first Drainage Board shall vacate their offices on the first Thursday in September in the year following that in which this Provisional Order shall have been confirmed by Parliament:
- (F) The electors for members of the Drainage Board shall be the persons who were during the year immediately preceding such election liable to be rated to any drainage rate of the said district leviable by the Drainage Board and have paid all such rates (if any) levied and due from them at the time of such election.
