

## CHAPTER lxxxvi.

An Act to confirm a Provisional Order under the Land A.D. 1915.

Drainage Act 1861 in the matter of a proposed drainage district in the Parishes of Fangfoss Full Sutton Bolton High Catton Wilberfoss Newton-upon-Derwent Barmby-on-the-Moor Sutton-upon-Derwent Allerthorpe Thornton Storwood Melbourne Wheldrake Thorganby with West Cottingwith East Cottingwith and Bielby in the East Riding of the County of York. [29th July 1915.]

WHEREAS the Board of Agriculture and Fisheries have made the Provisional Order set forth in the schedule hereto under the provisions of the Land Drainage Act 1861:

24 & 25 Vict.

And whereas it is requisite that the said Order should be confirmed by Parliament:

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

- 1. The Order as amended and set out in the schedule hereto Order in shall be and the same is hereby confirmed and all the provisions schedule confirmed. thereof shall have full validity and force.
- 2. This Act may be cited as the Land Drainage Provisional Short title. Order Confirmation Act 1915.

## SCHEDULE.

## LAND DRAINAGE ACT 1861.

## PROVISIONAL ORDER.

- In the matter of a proposed Drainage District in the Parishes of Fangfoss Full Sutton Bolton High Catton Wilberfoss Newton upon Derwent Barmby on the Moor Sutton upon Derwent Allerthorpe Thornton Storwood Melbourne Wheldrake Thorganby with West Cottingwith East Cottingwith and Bielby in the East Riding of the County of York.
- 1. The Board of Agriculture and Fisheries in pursuance of the powers vested in them by the Land Drainage Act 1861 and the Board of Agriculture and Fisheries Acts 1889 to 1909 do by this Provisional Order constitute the lands shown on a plan sealed by the Board and therein coloured pink a separate drainage district under the Land Drainage Act 1861.
- 2. And they do further by this their Provisional Order make the following regulations with respect to the Drainage Board (that is to say):—
  - (A) The Drainage Board for the said district shall consist of six members:
  - (B) The following persons shall be members of the first Drainage Board:—

The Right Hon. Ronald Clarges Viscount St. Vincent;

Jonathan James Beal of Sutton Farm Sutton on Derwent in the county of York;

Richard Massey English of Pocklington in the said county of York;

Andrew Moscrop of Thorganby Hall in the said county of York;

Wilfrid Forbes Home Thomson of Old Nunthorpe in the city of York; and

Herbert John Watson of St. Helen's Cockermouth in the county of Cumberland:

(c) The first meeting of the Drainage Board shall be summoned by a notice under the hands of any two or more members of the Drainage Board which shall be published in some newspaper circulating in the said district and shall be

posted at the principal entrance doors of the places of public A.D. 1915. worship or at other places where notices are usually exhibited in the said parishes of Fangfoss Full Sutton Bolton High Catton Wilberfoss Newton upon Derwent Barmby on the Moor Sutton upon Derwent Allerthorpe Thornton Storwood Melbourne Wheldrake Thorganby with West Cottingwith East Cottingwith and Bielby at least fourteen days before the day of meeting:

- (p) The qualification of any subsequent member of the Drainage Board shall be that he shall be—
  - (1) the proprietor of not less than ten acres of land within the said district; or
  - (2) the heir apparent of a proprietor (such proprietor not being himself a member of the Board) of not less than ten acres of land within the said district; or
  - (3) the occupying tenant yearly or otherwise of not less than twenty acres of land within the said district; or
  - (4) the agent of a proprietor of not less than ten acres of land within the said district such agent acting under a written appointment and his principal not being a member of the Board:
- (E) The members of the first Drainage Board shall vacate their offices on the first Thursday in September in the year following that in which this Provisional Order shall have been confirmed by Parliament:
- (r) The electors for members of the Drainage Board shall be the persons who were during the year immediately preceding such election liable to be rated to any drainage rate of the said district leviable by the Drainage Board and have paid all such rates (if any) levied and due from them at the time of such election.
- 3. Notwithstanding anything in this Order contained the consent of the Treasury shall during the continuance of the present war and twelve months thereafter be required in addition to any other consent for the exercise of any power of borrowing for the purposes of this Order.
- 4. For the purpose of any rate to be levied by the Drainage Board the land within the said district belonging to the North Eastern Railway Company and used as a canal or as station premises or lying within the fences inclosing the railway track shall not be assessed on the basis of a higher value than that of agricultural land in the said district.

In witness whereof the Board of Agriculture and Fisheries have hereunto set their official seal this twenty-sixth day of April nineteen hundred and fifteen.
