CHAPTER xxvi.

An Act to confirm Provisional Orders under the Land A.D. 1918. Drainage Act 1861 in the matter of proposed Drainage Districts in the Parish of Pinchbeck in the Holland Division of the County of Lincoln. [30th July 1918.]

WHEREAS the Board of Agriculture and Fisheries have made the Provisional Orders set forth in the schedule hereto under the provisions of the Land Drainage Act 1861: 24 & 25 Vict.

c. 133.

And whereas it is requisite that the said Orders should be confirmed by Parliament:

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

- 1. The Orders as set out in the schedule hereto shall be and Orders in schedule the same are hereby confirmed and all the provisions thereof shall confirmed. have full validity and force.
- 2. This Act may be cited as the Land Drainage (Pinchbeck) Short title. Provisional Orders Confirmation Act 1918.

- (c) The first meeting of the Drainage Board shall be summoned A.D. 1918. by a notice under the hands of any two or more members of the Drainage Board which shall be published in some newspaper circulating in the said district and shall be posted at the principal entrance doors of the places of public worship in the said parish of Pinchbeck at least fourteen days before the day of meeting:
- (d) The qualification of any subsequent member of the Drainage Board shall be that he shall be-
 - (1) the proprietor of not less than ten acres of land within the said district; or
 - (2) the heir apparent of a proprietor (such proprietor not being himself a member of the Board) of not less than ten acres of land within the said district; or
 - (3) the occupying tenant yearly or otherwise of not less than twenty acres of land within the said district; or
 - (4) the agent of or person appointed for this purpose by a proprietor of not less than ten acres of land within the said district such agent or person acting under a written appointment and his principal not being a member of the Board:
- (e) The members of the first Drainage Board shall vacate their offices on the first Thursday in September in the year following that in which this Provisional Order shall have been confirmed by Parliament:
- (f) The electors for members of the Drainage Board shall be the persons who were during the year immediately preceding such election liable to be rated to any drainage rate of the said district leviable by the Drainage Board and have paid all such rates (if any) levied and due from them at the time of such election.
- 3. This Order shall not in anywise take away affect prejudice or diminish any rights interest powers or jurisdiction of the Black Sluice Commissioners.

- (f) The electors for members of the Drainage Board shall be the persons who were during the year immediately preceding such election liable to be rated to any drainage rate of the said district leviable by the Drainage Board and have paid all such rates (if any) levied and due from them at the time of such election.
- 3. This Order shall not in anywise take away affect prejudice or diminish any rights interest powers or jurisdiction of the Black Sluice Commissioners.
