An Act to confirm a Provisional Order of the A.D. 1936.

Minister of Health relating to the South Stafford
shire Joint Small-pox Hospital District.

[19th March 1936.]

WHEREAS under the provisions of the Public 38 & 39 Vict. Health Act 1875 the Minister of Health has c. 55. made a provisional order which needs confirmation by Parliament:

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

- 1. The order of the Minister of Health which is set Order in out in the schedule to this Act is hereby confirmed and schedule shall have full validity and force.
- 2. This Act may be cited as the Ministry of Health Short title. Provisional Order Confirmation (South Staffordshire Joint Small-pox Hospital District) Act 1936.

SOUTH STAFFORDSHIRE JOINT SMALL-POX HOSPITAL DISTRICT.

Provisional Order altering the South Staffordshire Joint Small-pox Hospital Orders 1903 to 1931.

WHEREAS by virtue of the South Staffordshire Joint Small-pox Hospital Orders 1903 to 1931 (which were confirmed by Parliament) as amended by the Wolverhampton Corporation Act 1926 the County of Worcester Review Order 1933 the Staffordshire Review Order 1934 and the South Staffordshire Joint Small-pox Hospital Amendment Order 1935 certain boroughs urban districts and rural districts constitute a united district called the South Staffordshire Joint Small-pox Hospital District of which the governing body is the South Staffordshire Joint Small-pox Hospital Board;

And whereas it is expedient that the urban district of Aldridge should be included in the united district:

Now therefore the Minister of Health in pursuance of the powers given to him by section 297 of the Public Health Act 1875 and of all other powers enabling him in that behalf hereby orders as follows:—

Interpretation.

- 1. In this order unless the context otherwise requires—
 - "the orders" means the South Staffordshire Joint Small-pox Hospital Orders 1903 to 1931;
 - "the joint board" means the South Staffordshire Joint Small-pox Hospital Board;
 - "the united district" means the South Staffordshire Joint Small-pox Hospital District;
 - "the urban district" means the urban district of Aldridge;
 - "the district council" means the council of the urban district;
 - "the appointed day" means the date upon which this order comes into operation.

Short titles and commencement.

- 2.—(1) This order may be cited as the South Staffordshire Joint Small-pox Hospital Order 1935 and the orders and this order may be cited together as the South Staffordshire Joint Small-pox Hospital Orders 1903 to 1935.
- (2) This order shall come into operation on the date of the Act of Parliament confirming it.

3. The united district shall be extended so as to include the urban district and (subject to the provisions of this order) references in the orders to constituent districts and constituent authorities shall be deemed to include the urban district and the united district council respectively.

The number of elective members of the joint board shall Future conbe increased from fifty-two to fifty-three and the orders shall be amended by the addition of the entries in the several columns of the schedule to this order to the corresponding columns of the schedule to the South Staffordshire Joint Small-pox Hospital Order 1928.

stitution of joint board.

5. The provisions of article XI of the South Staffordshire Election of Joint Small-pox Hospital Order 1903 shall apply to the first election by the district council of the elective member to represent them on the joint board as if the election related to the filling of a vacancy occurring on the appointed day.

elective member by new constituent authority.

6. The Minister of Health upon the application of any of the constituent authorities or of the joint board may adjust as between the constituent authorities or as between the constituent &c. authorities and the joint board any expense or liability incurred by or attaching to the joint board before the appointed day or any expense liability or accounts arising out of incidental to connected with or affected by the inclusion of the urban district in the united district or any expense liability or accounts in respect of which doubt or difference may arise after the appointed day.
