CHAPTER xxiii.

An Act to confirm a Provisional Order of the A.D. 1936.

Minister of Health relating to the borough of

Luton. [21st May 1936.]

WHEREAS under the provisions of the Public 38 & 39 Health Act 1875 the Minister of Health has Vict. c. 55. made a Provisional Order which needs confirmation by Parliament:

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

- 1. The order of the Minister of Health which is Order in set out in the schedule to this Act is hereby confirmed schedule and shall have full validity and force.
- 2. This Act may be cited as the Ministry of Health Short title. Provisional Order Confirmation (Luton) Act 1936.

Luton Order.

BOROUGH OF LUTON.

Provisional Order amending the Luton Corporation Act 1911.

WHEREAS the mayor aldermen and burgesses of the borough of Luton acting by the council (in this order called "the corporation") are the local authority for the purposes of the Public Health Act 1875 and there are in force in the borough the unrepealed provisions of the Luton Corporation Act 1911 (in this order called "the local Act") as amended by the Luton (Extension) Order 1928 which was confirmed by Parliament;

And whereas by Part VIII of the local Act provision is made with respect to the borrowing of moneys by the corporation for the purposes of that Act and with respect to the repayment of loans;

And whereas the corporation have applied to the Minister of Health for the issue of a provisional order to amend the local Act in the manner following:

Now therefore the Minister of Health in pursuance of the powers given to him by sections 297 and 303 of the Public Health Act 1875 and of all other powers enabling him in that behalf hereby orders as follows:—

Short title and commencement.

- 1.—(1) This order may be cited as the Luton Order 1936.
- (2) This order shall come into operation on the date of the Act of Parliament confirming it.

Interpretation.

- 2. In this order unless the context otherwise requires—
 - "statutory borrowing power" has the meaning assigned to that expression by article 1 of the Local Authorities (Stock) Regulations 1934 but excludes any power of borrowing under paragraph (a) of subsection (1) of section 215 of the Local Government Act 1933;
 - "statutory security" has the meaning assigned to that expression in section 218 of the Local Government Act 1933 but excludes any securities of the corporation; and
 - "the Minister" means the Minister of Health,

3.—(1) Notwithstanding anything contained in any Act or order on and after the thirty-first day of March nineteen hundred and thirty-six the corporation may if they think fit establish Luton Order. a fund to be called "the consolidated loans fund" to which shall Consolidated loans fund. be paid—

- (a) all moneys borrowed by the corporation whether by issue of stock or other security together with any moneys borrowed without security in connection with the exercise of any statutory borrowing power;
- (b) all moneys of a capital nature received by the corporation whether from the sale of capital assets or otherwise except such as are applied by the corporation with due authority to another capital purpose; and
- (c) the appropriate sums provided in each year out of other funds of the corporation to comply with the terms and conditions as to repayment attaching to their several borrowing powers or otherwise provided for the repayment of debt;

and there shall also be carried to the credit of the consolidated loans fund the unapplied balances of all moneys so borrowed or received and of all sums provided by the corporation as aforesaid before the date on which the consolidated loans fund is established.

- (2) The moneys of the consolidated loans fund shall be used or applied by the corporation—
 - (a) in the redemption of stock or any other securities issued by the corporation the purchase of stock for extinction or the repayment of any moneys borrowed by the corporation; and
 - (b) in the exercise of any statutory borrowing power by transfer of the required amount to the appropriate account of the corporation;

and the moneys of the consolidated loans fund not used or applied in these ways or about to be so used or applied within a reasonable * period shall be invested in statutory securities and the sums realised by the sale of such securities shall be repaid on receipt to the consolidated loans fund and the moneys of the consolidated loans fund shall not except with the consent of the Minister be used or applied otherwise than as provided in this subsection.

(3) There shall also be transferred to the consolidated loans fund such sums as are necessary to meet interest charges and the financing and other revenue expenses connected with the management of that fund and separate account shall be kept of these sums and their application.

(4) Save as in this section expressly provided all the obligations of the corporation to the holders of stock or other securities of the corporation shall continue in force.

(5) Nothing in this section shall apply to moneys borrowed from the Public Works Loan Commissioners.

- (6) (a) The powers conferred by this section shall not be put into operation by the corporation except in accordance with a scheme to be approved by the Minister and such scheme may make provision for any matters incidental to the establishment and administration of the consolidated loans fund.
- (b) Any scheme approved under this section may be altered amended or revoked by a scheme approved in like manner and subject to the like provisions as the original scheme.
