CHAPTER lxxi.

An Act to confirm a Provisional Order of the Minister of Health relating to the borough of Lancaster. A.D. 1936.
[16th July 1936.]

WHEREAS under the provisions of the Public Health Act 1875 the Minister of Health has made a provisional order which needs confirmation by Parliament : 38 & 39 Vict. c 55.

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows :—

1. The order of the Minister of Health which is set out in the schedule to this Act is hereby confirmed and shall have full validity and force. Order in schedule confirmed.

2. This Act may be cited as the Ministry of Health Provisional Order Confirmation (*Lancaster*) Act 1936. Short title.

BOROUGH OF LANCASTER.

*Provisional order amending certain local Acts and
provisional orders.*

WHEREAS the mayor aldermen and burgesses of the borough of Lancaster acting by the council (in this order called "the corporation") carry on a water undertaking in pursuance of the local Acts and provisional orders mentioned in the schedule to this order and supply water within certain limits;

And whereas the corporation have applied to the Minister of Health for the issue under the Public Health Act 1875 of a provisional order to amend the local Acts and provisional orders in the manner following:

Now therefore the Minister of Health in pursuance of the powers given to him by sections 297 and 303 of the Public Health Act 1875 and of all other powers enabling him in that behalf hereby orders as follows:—

Short title
and com-
mencement.

1.—(1) This order may be cited as the Lancaster (Water) Order 1936 and the Acts and orders mentioned in the schedule to this order and this order may be cited together as the Lancaster (Water) Acts and Orders 1852 to 1936.

(2) This order shall come into operation on the date of the Act of Parliament confirming it.

Interpreta-
tion.

2. In this order unless the context otherwise requires—

"the added areas" means the areas added by this order to the water limits;

"the local Acts and orders" means the local Acts and provisional orders mentioned in the schedule to this order;

"the water limits" means the limits within which the corporation are authorised to supply water by the local Acts and orders.

Extension
of existing
water limits.

3.—(1) The water limits shall be extended so as to include the parishes of Heaton with Oxcliffe Middleton and Overton in the rural district of Lancaster.

(2) For the purposes of the supply of water within the added areas the corporation may exercise the powers which they are authorised to exercise by the local Acts and orders and shall be

subject to the obligations to which they are subject under the local Acts and orders. A.D. 1936.

(3) The provisions of the local Acts and orders shall subject to such modifications as may be necessary extend to the added areas.
