An Act to confirm a Provisional Order of the A.D. 1936.

Minister of Health relating to the Tees Valley

Water Board.

[16th July 1936.]

WHEREAS under the provisions of the Public 38 & 39
Health Act 1875 the Minister of Health has Vict. c. 55.
made a provisional order which needs confirmation by
Parliament:

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

- 1. The order of the Minister of Health which is Order in set out in the schedule to this Act is hereby confirmed schedule and shall have full validity and force.
- 2. This Act may be cited as the Ministry of Health Short title. Provisional Order Confirmation (Tees Valley Water Board) Act 1936.

TEES VALLEY WATER BOARD.

Provisional order altering a local Act and a provisional order.

WHEREAS by the Tees Valley Water Acts and Orders 1907 to 1933 the Tees Valley Water Board (in this order called "the board") are authorised to construct certain waterworks and to supply water within a large area in the county of Durham and the north riding of the county of York;

20 & 21 Geo. 5. c. lxix. And whereas sections 5 and 14 of the Tees Valley Water Act 1930 (hereinafter called "the Act of 1930") authorised the board to acquire certain lands and easements and to make and maintain the several works mentioned in the said section 5;

And whereas it is enacted by section 20 of the Act of 1930 as amended by the Tees Valley Water Order 1933 that the powers of the board for the compulsory purchase of lands for the purposes of Works Nos. 1 and 4 (Conduits Nos. 15 and 18) mentioned in the said section 5 shall cease on the first day of October one thousand nine hundred and thirty-eight and for the other purposes of the Act of 1930 shall cease on the first day of October one thousand nine hundred and thirty-six;

And whereas it is enacted by section 21 of the Act of 1930 as amended by the Tees Valley Water Order 1933 that if the works authorised by the Act of 1930 are not completed within the period expiring on the first day of October one thousand nine hundred and forty-three the powers granted by the Act of 1930 for the making thereof or otherwise in relation thereto shall cease except as to so much thereof as is then completed;

And whereas the board have applied to the Minister of Health for the issue of a provisional order further to amend the Act of 1930 in the manner following:

Now therefore the Minister of Health in pursuance of the powers given to him by sections 297 and 303 of the Public Health Act 1875 and of all other powers enabling him in that behalf hereby orders as follows:—

Short title and commencement.

1. This order may be cited as the Tees Valley Water Order 1936 and shall come into operation on the date of the Act of Parliament confirming it.
