## CHAPTER lxxvi.

An Act to confirm a scheme of the Charity Commissioners for the application or management of the Charity of Arthur Frederick Buckingham for a cottage hospital, in the borough of Dunstable, in the county of Bedford.

[31st July 1936.]

WHEREAS the Charity Commissioners in their report to His Majesty of their proceedings during the year one thousand nine hundred and thirty-five reported that they had approved and certified a scheme for the application or management of the Charity of Arthur Frederick Buckingham for a cottage hospital in the borough of Dunstable in the county of Bedford founded by Will proved in the Principal Registry on the thirty-first day of May one thousand nine hundred and eighteen and comprised in a scheme of the Charity Commissioners of the twenty-third day of February one thousand nine hundred and thirty-four.

And whereas it is expedient that the scheme as the same is set out and defined in the Schedule to this Act should be confirmed:

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

## [Ch. lxxvi.] Buckingham's Charity [26 Geo. 5. & (Dunstable) Scheme 1 Edw. 8.] Confirmation Act, 1936.

A.D. 1936. shall be held to interfere with the ordinary jurisdiction over endowed charities now exerciseable or hereafter to become exerciseable by the High Court of Justice and the Charity Commissioners.

Short title. 2. This Act may be cited as Buckingham's Charity (Dunstable) Scheme Confirmation Act, 1936.

## SCHEDULE.

A.D. 1936.

- Scheme for the application or management of the Charity of Arthur Frederick Buckingham for a cottage hospital in the borough of Dunstable in the county of Bedford founded by Will proved in the Principal Registry on the 31st May 1918 and comprised in a scheme of the Charity Commissioners of the 23rd February 1934.
- 1. The Trustees of the above-mentioned charity (hereinafter called the Charity Trustees) may pay the funds of the charity (including the fund representing the bequest of Flora Lucretia Blackwell for the building fund of the charity but excluding the fund representing the bequest of Flora Lucretia Blackwell for the upkeep of the cottage hospital of the charity) to the Trustees of the piece of land specified in the schedule hereto (hereinafter called the General Hospital Trustees) for application towards the cost of erecting on the said piece of land a general hospital for the benefit of Luton Dunstable and the neighbourhood Provided as follows:—
  - (a) The funds may be paid in such instalments as the Charity Trustees think fit;
  - (b) No payment shall be made by the Charity Trustees until the General Hospital Trustees have applied to the Charity Commissioners for an Order establishing a scheme for the administration and management of the general hospital to be erected as aforesaid providing inter alia (a) that one or more of the members for the time being of the board of management of the general hospital shall be appointed from time to time by the council of the borough of Dunstable and (b) that one of the wards in the general hospital shall be named "The Arthur Frederick Buckingham Ward."
- 2. From and after the date on which the general hospital to be erected as aforesaid is opened for use the fund representing the bequest of Flora Lucretia Blackwell for the upkeep of the cottage hospital of the charity shall be an endowment of the general hospital and the income derived therefrom shall be applicable towards the upkeep of the general hospital.
- 3. The Charity Commissioners may from time to time in the exercise of their ordinary jurisdiction establish schemes for the alteration of any of the provisions of this scheme as if those provisions had been made by the founder in the case of a charity having a founder.


- 4. Any question as to the construction of this scheme or as to the regularity or the validity of any acts done or about to be done under this scheme shall be determined conclusively by the Charity Commissioners upon such application made to them for the purpose as they think sufficient.
- 5. The date of this scheme shall be the date of the Act of Parliament confirming the same.

## SCHEDULE OF PROPERTY.

A piece of land situate lying and being at the corner of Dunstable Road West and Lewsey Road formerly in the parish of Leagrave but now incorporated in the borough of Luton in the county of Bedford containing by admeasurement 9a. 3r. 38p. 7 sq. yrds. or thereabouts which piece of land is comprised in a conveyance dated 19th June 1935 and recorded in the Books of the Charity Commissioners under s. 29 (4) of the Settled Land Act 1925 on the 15th July 1935 and is held under the said conveyance as a site for a general hospital for the benefit of Luton Dunstable and the neighbourhood.
