## RIVER STOUR (KENT) CATCHMENT BOARD.

#### ORDER.

1. The Minister of Agriculture and Fisheries (in this Order called the Minister) in exercise of the powers conferred upon him by the Land Drainage Act 1930 and of every other power in that behalf hereby confirms the Scheme (together with the map referred to therein as amended) submitted to him by the River Stour (Kent) Catchment Board (in this Order called the Catchment Board) under section 4 (1) (b) of the said Act in relation to the Internal Drainage District under their jurisdiction a copy of which Scheme is annexed hereto with the following modification (which has been incorporated in the Scheme) (that is to say):—

The amendment of paragraph 3 so as to read:—"The seaward boundaries of the said Internal Drainage District in so far as they follow the line of low-water mark of ordinary tides shall extend to that line as it exists from time to time and land lying between such line and the seaward boundaries coloured on the said map shall be deemed to be included in the said district."

2. The expenses of the Minister in connection with the making and confirmation of this Order shall be borne by the Catchment Board and shall be part of the administrative expenses of the Catchment Board.

# THE RIVER STOUR (KENT) CATCHMENT BOARD.

### SCHEME.

- 1. As from a day to be appointed by the Minister of Agriculture and Fisheries the area of the Internal Drainage District under the jurisdiction of the River Stour (Kent) Catchment Board the powers duties liabilities obligations and property in relation to which were transferred to the said Catchment Board by an Order of the Minister under section 11 of the Land Drainage Act 1930 dated the twentieth day of August nineteen hundred and thirty-one and confirmed the twelfth day of October nineteen hundred and thirty-one shall be extended and the area of the district shall be the area shown in pink colour and edged red on the map in four parts sealed by the Catchment Board in relation to this Scheme which district shall hereafter be known as the "River Stour (Kent) Internal Drainage District."
- 2. The Drainage Board for the said Internal Drainage District shall be the River Stour (Kent) Catchment Board.
- 3. The seaward boundaries of the said Internal Drainage District in so far as they follow the line of low-water mark of ordinary tides shall extend to that line as it exists from time to time and land lying between such line and the seaward boundaries coloured on the said map shall be deemed to be included in the said district.
