CHAPTER xiii.

An Act to confirm a Provisional Order made A.D. 1938.
under section one of the Electricity (Supply) —
Act 1922 relating to the North West Midlands
Joint Electricity Authority. [17th May 1938.]

WHEREAS under the provisions of section one of
the Electricity (Supply) Act 1922 the Minister of 12 & 13
Transport has confirmed a Provisional Order made by Geo. 5. c. 46.
the Electricity Commissioners which needs confirmation
by Parliament:

Be it therefore enacted by the King's most Excellent
Majesty by and with the advice and consent of the Lords
Spiritual and Temporal and Commons in this present
Parliament assembled and by the authority of the same
as follows:—

1. The Order set out in the schedule to this Act is Order in
hereby confirmed and shall have full validity and force. schedule
confirmed.

2. This Act may be cited as the North West Short title.

SCHEDULE.

NORTH WEST MIDLANDS JOINT ELECTRICITY
AUTHORITY.

Order made by the Electricity Commissioners and confirmed by the Minister of Transport under the Electricity (Supply) Acts 1882 to 1936 for increasing the borrowing powers of the North West Midlands Joint Electricity Authority.

Short and
collective
titles.

1.—(1) This Order may be cited as the North West Midlands Joint Electricity Authority (Increase of Borrowing Powers) Order 1937.

(2) The North West Midlands Electricity District Order 1928 (in this Order referred to as "the Order of 1928") and this Order may be cited together as the North West Midlands Electricity District Orders 1928 and 1937.

2. The Order of 1928 shall have effect as if for the reference to one and a half million pounds in section 27 (Power to borrow and maximum amount which may be borrowed) of the schedule thereto there were inserted a reference to two million five hundred thousand pounds and accordingly the maximum amount which may be borrowed by the North West Midlands Joint Electricity Authority shall be two million five hundred thousand pounds.

Costs of
Order.

3. All costs charges and expenses preliminary to and of and incidental to the preparing applying for and obtaining of this Order and otherwise incurred in reference thereto as taxed by the taxing officer of the House of Lords or of the House of Commons shall be paid by the North West Midlands Joint Electricity Authority out of moneys to be borrowed by the Authority under the Order of 1928 and this Order but may in the first instance be paid by the Authority as part of their
