CHAPTER xviii.

An Act to confirm a Scheme of the Charity Commissioners for the application or management of the Charity called the Poor's Allotment in the ancient parish of Hanwell in the county of Middlesex. [26th May 1938.]

WHEREAS the Charity Commissioners in their report to His Majesty of their proceedings during the year one thousand nine hundred and thirty-seven reported that they had approved and certified a Scheme for the application or management of the Charity called the Poor's Allotment in the ancient parish of Hanwell, in the county of Middlesex comprised in an Inclosure Award made pursuant to the Inclosure Act 53 Geo. III. cap. vi. (Private) and a Scheme of the Charity Commissioners of the first day of March one thousand nine hundred and seven :

And whereas it is expedient that the Scheme as the same is fully set out and defined in the Schedule to this Act should be confirmed :

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this

1. The said Scheme is hereby confirmed Provided always that nothing in this Act or in the said Scheme shall be held to interfere with the ordinary jurisdiction over endowed charities now exerciseable or hereafter to become exerciseable by the High Court of Justice and the Charity Commissioners.

2. This Act may be cited as the Poor's Allotment in Hanwell Charity Scheme Confirmation Act 1938.

SCHEDULE.

A.D. 1938.

Scheme for the application or management of the Charity called the Poor's Allotment in the ancient parish of Hanwell in the county of Middlesex comprised in an Inclosure Award made pursuant to the Inclosure Act 53 Geo. III. cap. VI. (Private) and a Scheme of the Charity Commissioners of the first day of March one thousand nine hundred and seven.

1. The Trustees of the above-mentioned charity may under the authority of an Order of the Charity Commissioners sell the land containing 1a. 0r. 37p. or thereabouts at Hanwell in the county of Middlesex belonging to the Charity to the Council of the Borough of Ealing at the price of one thousand pounds subject to the following conditions:—

- (a) the said Council shall agree that the said land shall be maintained and used as an open space or recreation ground and that no buildings shall be erected thereon except such as are incidental to such use:
- (b) all the costs charges and expenses attending or incidental to the sale including the costs of the deduction and verification of any title which may be required to be shown to the said land shall be paid by the Council.

2. The said sum of one thousand pounds when received by the Trustees shall be immediately paid by them to the banking account at the Bank of England of "The Official Trustees of Charitable Funds" and shall be invested by the said official trustees in their name in trust for the Charity in one or more of the stocks funds or securities (other than real securities) authorised by law for the investment of trust funds.

3. The income derived from the investments for the time being representing the said sum of one thousand pounds shall be applied by the Trustees in manner prescribed by the above-mentioned award for the application of the income of the Charity that is to say in the purchase of fuel to be distributed among the poor inhabitants of the ancient parish of Hanwell in such shares and proportions at such times in every year and according to such rules and directions as shall from time to time be made and prescribed by the Trustees.

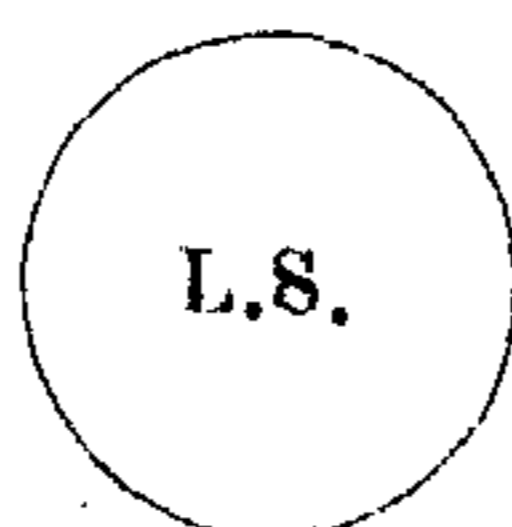

4. Any question as to the construction of this Scheme or as to the regularity or the validity of any acts done or about to be done under this Scheme shall be determined conclusively by the Charity Commissioners upon such application made to them for the purpose as they think sufficient.

5. The date of this Scheme shall be the date of the Act of Parliament confirming the same.
