# CHAPTER xix

An Act to confirm a Provisional Order under the Private Legislation Procedure (Scotland) Act 1936 relating to Aberdeen Extension. [1st August 1952.]

HEREAS the Provisional Order set forth in the schedule hereunto annexed has been made by the Secretary of State under the provisions of the Private Legislation Procedure (Scotland) Act 1936 and it is requisite that the said Order should be confirmed by Parliament:

Be it therefore enacted by the Queen's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

- 1. The Provisional Order contained in the schedule hereunto Confirmation annexed is hereby confirmed.

- 2. This Act may be cited as the Aberdeen Extension Order Short title. Confirmation Act 1952.

## SCHEDULE

## ABERDEEN EXTENSION

Provisional Order to extend the boundaries of the city and royal burgh of Aberdeen and for other purposes.

WHEREAS the lord provost magistrates and town council of the city and royal burgh of Aberdeen (hereinafter referred to as "the Corporation") are vested with the municipal government of the said city and royal burgh (hereinafter referred to as "the city") and are the local authority therein:

And whereas the lands available within the city for the purpose of providing housing accommodation for the inhabitants of the city relieving the overcrowding which prevails in parts of the city and redeveloping built up areas in the city are limited in extent and it is necessary to provide for the erection of houses on lands outwith the existing boundaries of the city:

And whereas the area described in Part I of the First Schedule to this Order (hereinafter referred to as "the added area") is situated in the county of Aberdeen and immediately adjoins the city:

And whereas the Corporation have acquired certain lands within the added area and are proceeding with the erection of houses thereon and also own certain further lands within the added area:

And whereas it is expedient and in the public interest that the municipal administration of the city and the added area should be under one authority and that the city and the added area should be education area:

And whereas it is expedient that the boundaries of the city should be extended to include the added area and that all franchises rights privileges and immunities and all public and general and local and personal Acts and Orders relating to and in force for the time being in or applicable to the city should as provided in this Order be applied to the added area:

And whereas the city is a county of a city under the name of the county of the city of Aberdeen and it is expedient that the added area should be separated and disjoined from the county of Aberdeen and be incorporated with and form part of the county of the city of Aberdeen:

And whereas it is expedient as provided in this Order that the added area should be added to and form part of the municipal wards of the city which adjoin the same:

And whereas it is expedient that the other provisions contained in this Order should be enacted:

And whereas the purposes aforesaid cannot be effected without an Order confirmed by Parliament under the provisions of the Private Legislation Procedure (Scotland) Act 1936:

Now therefore in pursuance of the powers contained in the lastmentioned Act the Secretary of State orders as follows:—

- 1. This Order may be cited as the Aberdeen Extension Order 1952 Short and and this Order and the Aberdeen City Acts 1936 to 1942 may be collective titles. cited together as the Aberdeen City Acts 1936 to 1952.
- 2. In this Order unless there be something in the subject or context Interpretation. repugnant to such construction words and expressions to which meanings are assigned by the Aberdeen City Acts 1936 to 1942 shall have the same respective meanings and the following words and expressions shall have the meanings hereinafter respectively assigned to them (that is to say):—
  - "Act of 1947" means the Local Government (Scotland) Act 1947;
  - "added area" means the portion of the county of Aberdeen described in Part I of the First Schedule to this Order and by this Order incorporated with the existing city;
  - "city" means the city and royal burgh of Aberdeen as extended by this Order;
  - "city Acts" means the Aberdeen City Acts 1936 to 1942;
  - "Corporation" means the lord provost magistrates and town council of the existing city or of the city as the case may be;
  - "county" means the county of Aberdeen;
  - "county council" means the county council of the county of Aberdeen;
  - "existing city" means the city and royal burgh of Aberdeen existing immediately before the commencement of this Order;
  - "lord provost" means the lord provost of the existing city or of the city as the case may be;
  - "Order of 1939" means the Aberdeen Corporation (Administration Finance &c.) Order 1939;
  - "town clerk" means the town clerk of the existing city or of the city as the case may be.
- 3. This Order except where otherwise expressly provided shall be Commencement deemed to have commenced and to have had effect as on and from of Order. the twenty-eighth day of May one thousand nine hundred and fifty-two (which date is hereinafter in this Order referred to as the commencement of this Order).

4. The city shall include and comprehend in addition to the area Extension of embraced in the existing city the added area and the city shall be boundaries comprised within the boundaries set forth and described in Part II of of city. the First Schedule to this Order and shown on the map referred to in subsection (3) of the section of this Order of which the marginal note is "Deposit of map of city" and the city Acts shall be read and construed accordingly.

5.—(1) A map of the city (distinguishing the added area) of which Deposit of thirteen copies have been signed by Matthew George Fisher Counsel map of city, to the Secretary of State under the Private Legislation Procedure (Scotland) Act 1936 shall within four weeks after the date of the passing of the Act confirming this Order be deposited as follows (that is to say)

One copy in the office of the Clerk of the Parliaments House of Lords one copy in the Private Bill Office of the House of Commons one copy in the Scottish Office London one copy with the town clerk at his office in Aberdeen one copy with the sheriff clerk of the county of Aberdeen at his office in Aberdeen one copy with the Minister of Agriculture and Fisheries one copy with the Commissioners of Inland Revenue one copy with the Commissioners of Customs and Excise one copy with the Board of Trade one copy with the Postmaster-General one copy with the Registrar-General of Births Deaths and Marriages in Scotland one copy with the Minister of Transport and one copy with the Minister of Fuel and Power.

- (2) If there is any discrepancy between the said map and the description in Part II of the First Schedule to this Order the said map shall be deemed to be correct and shall prevail.
- (3) The copy of the map of the city deposited with the town clerk in pursuance of subsection (1) of this section (which copy shall also show the boundaries of the several wards of the city as described in Part II of the Second Schedule to this Order) shall be substituted for the map referred to in subsection (2) of section 6 (Boundaries of city) of the Order of 1939 and references in the Order of 1939 to the city map as therein defined shall be deemed to be references to the said map deposited with the town clerk in pursuance of subsection (1) of this section.

Boundary of county of city.

6. The added area shall subject to the provisions of this Order and for the purposes of Part II (General administration) of the Order of 1939 be incorporated with and form part of the county of the city of Aberdeen and be disjoined and separated from the county and the city Acts shall be read and construed accordingly.

Added area to form part of adjoining wards and boundaries of wards.

- 7.—(1) The portion of the added area firstly described and the portion of the added area secondly described in Part I of the Second Schedule to this Order shall be added to and shall form part of Ward No. 6 (Cairnery) and of Ward No. 7 (Rosemount) of the existing city respectively as those wards respectively existed immediately before the commencement of this Order.
- (2) Unless and until otherwise determined the numbers names and boundaries of the wards of the city shall be those respectively set forth and described in Part II of the Second Schedule to this Order and shown on the map referred to in subsection (3) of the section of this Order of which the marginal note is "Deposit of map of city".
- (3) If there is any discrepancy between the said map and the descriptions in Part II of the Second Schedule to this Order the said map shall be deemed to be correct and shall prevail.
- (4) Section 8 (Division into wards) of the Order of 1939 and the Local Government (Scotland) (Aberdeen Wards) Order 1951 made by the Secretary of State under subsection (1) of section 21 of the Act of 1947 are hereby repealed and the Order of 1939 as amended by this Order shall be read and construed as if for the references therein to the wards of the city there were substituted references to the wards of the city described in Part II of the Second Schedule to this Order and shown on the above-mentioned map.

- 8.—(1) After the commencement of this Order and notwithstanding Register of anything to the contrary in any Act the following provisions shall apply electors. and have effect with respect to the registration of electors in the city (that is to say):—
  - (i) In order to enable the city assessor to make up for the added area the register of electors for the year commencing the sixteenth day of March one thousand nine hundred and fifty-three he shall be entitled to access to the books and schedules of any registration officer acting under the Representation of the People Acts for the county so far as they relate to the added area and such registration officer shall give the city assessor all necessary and reasonable facilities for that purpose; and
  - (ii) All rights and liabilities under any contracts entered into before the commencement of this Order by the county council or by any registration officer as to the printing of the list or register of parliamentary and local government electors shall so far as applying to the added area be transferred to and vested in the city assessor and the Corporation and all expenses connected with the making up of the register of such electors for the added area shall be borne in accordance with and in terms of the provisions of the Representation of the People Acts.
- (2) In the event of a municipal by-election occurring between the commencement of this Order and the fifteenth day of March one thousand nine hundred and fifty-three in Ward Number 6 (Cairnery) or Ward Number 7 (Rosemount) as the said wards are respectively described in Part II of the Second Schedule to this Order. it shall be the duty of the city assessor to prepare a register of local government electors for the purpose of such by-election and such register shall consist of the existing register of local government electors for such ward together with such portion of the register of electors for any registration area as contains the names of local government electors registered in respect of lands and heritages or premises situated in the part of the added area forming part of the ward in which such by-election occurs:

Provided that for the purpose of preparing any register of electors for the purpose of this subsection the city assessor shall be entitled to access to the books and schedules of any registration officer acting under the Representation of the People Acts for the county so far as such books and schedules relate to the added area and such registration officer shall give the city assessor all necessary and reasonable facilities for that purpose.

9. In the event of circumstances arising in connection with any Sheriff may vary such by-election as is referred to in subsection (2) of the immediately procedure for preceding section of this Order which may render it necessary or by-elections. expedient to fix postpone alter or vary any date (other than the commencement of this Order) or any procedure prescribed by or in pursuance of the provisions of the Representation of the People Acts or this Order or to make up any register or list of electors or any other matter relating to such by-election register or list the sheriff may on a summary application by the town clerk forthwith fix any such date or sanction any such postponement alteration or variation

or dispense with any procedure in the making up of such register or list or any other matter as may in his judgment be best fitted to meet the circumstances of the case and the whole procedure following upon such application and any order made by the sheriff shall be valid and unchallengeable.

Property of existing city vested in Corporation.

10. Subject to the provisions of this Order the common good and all property heritable and movable (including all means revenues and income of every description arising therefrom) belonging to or leviable within the existing city or to which the existing city is entitled or which is held or administered by any person for or on behalf of the community of the existing city or for the public ends and purposes thereof shall be vested in and be held by the Corporation for the behoof and benefit of the city or as the case may be administered by such person for or on behalf of the community of the city or for the public ends and purposes thereof and all debts and obligations due by or exigible from the existing city shall be due by and exigible from the city and all debts due to the Corporation by any person before the commencement of this Order may be demanded and recovered from such person and received and applied by the Corporation for behoof of the city.

Powers extended

11. The Corporation the lord provost the magistrates and the over added area. dean of guild of the city shall (subject to the provisions of this Order) have possess and may exercise the same powers and authorities including powers of assessment respectively in and over the city and over the inhabitants thereof as the Corporation the lord provost the magistrates and the dean of guild of the existing city have possess and exercise in their several characters and capacities in and over the existing city whether by usage or at common law or by statute.

Officers in existing city.

12. The several officers of or appointed by the Corporation shall have possess and exercise in their several characters and capacities the same powers and authorities in and over the city as they have possess and exercise in their several characters and capacities in and over the existing city whether by usage or at common law or by statute but without prejudice to the right of the Corporation to make such arrangements in regard to the said officers and their respective duties as before the commencement of this Order they were entitled to make with reference to the officers of the existing city.

Application of general and local Acts.

13. All public and general and local and personal Acts relating to and in force in the existing city and all byelaws rules regulations orders and directions made thereunder shall subject to the provisions of this Order be exercised over and be applicable to the city.

Separate jurisdictions to cease.

- 14. Subject to the provisions of this Order and in so far as necessary to give full effect thereto—
  - (1) All separate magistracies councils commissions authorities and jurisdictions in the added area shall cease and determine;
  - (2) All actions prosecutions or processes both in civil and criminal causes before the justice of peace courts for the added area in dependence at the date of the passing of the Act confirming this Order shall be adjudged and finally disposed of by the said justice of peace courts notwithstanding anything in this Order to the contrary.

- 15. Subject to the provisions of this Order all jurisdictions rights Powers of local powers and duties which before the commencement of this Order authorities were exercised or exercisable by the county council or any other local to cease in added area or licensing or other authority within the added area or any parts thereof shall cease and determine.
- or approval under the Town and Country Planning (Scotland) Act 1947 or for a determination under section 15 of that Act made to the county council before the date of the passing of the Act confirming this Order and not determined before that date shall so far as it relates to land within the added area be treated as a like application made to the Corporation and shall be treated as having been so made at that date:

Provided that it shall not be necessary for the Corporation to consult with any authority or person with whom consultation has already taken place in relation to that application.

- (2) Any order agreement permission approval determination consent notice proceeding or decision made taken or given by the county council as local planning authority under the said Act of 1947 or having effect as if so made taken or given and in force immediately before the date of the passing of the Act confirming this Order shall so far as it relates to any land within the added area have effect as if it had been made taken or given by the Corporation as such authority in respect of that land.
- (3) Any direction approval consent or decision given by the Secretary of State or the Minister of Transport under or in pursuance of the said Act of 1947 or any enactment thereby repealed affecting the county council as local planning authority and in force immediately before the date of the passing of the Act confirming this Order shall so far as it relates to any land within the added area have effect as if the same had been given to the Corporation as local planning authority.
- (4) An office copy of every entry in the register relating to any land within the added area kept by the county council under section 12 of the said Act of 1947 shall within one month after the date of the passing of the Act confirming this Order be supplied to the town clerk by the clerk of the county council.
- 17. Nothing in this Order shall affect the Aberdeen and District Joint town Joint Town Planning Scheme 1933 so far as the said scheme is in planning operation at the commencement of this Order provided that the scheme. Corporation shall be the responsible authority within the meaning and for the purposes of the said scheme in the added area as well as within the existing city.
- 18.—(1) Any special lighting drainage and scavenging districts of Abolition of the county council so far as situated in the added area shall be and are special districts. hereby abolished and to that extent all resolutions of the county council and all orders and decrees of the sheriff or of any other

authority constituting or relating to the said special districts shall be of no force or effect and the county council shall be relieved from all obligations in respect of the said special districts so far as situated in the added area.

(2) The Corporation shall not in respect of such special districts be under any obligations nor except by agreement with the local authority of such districts exercise any powers in such districts in so far as these are beyond the city.

Transfer of property and liabilities.

- 19.—(1) Subject to the provisions of this Order and except as may be otherwise agreed all property and assets of every description vested in held by or due or belonging to the county council or other authorities in the added area are by virtue of this Order and without the necessity of recording in the register of sasines any conveyance notice of title or other deed or writing transferred to and vested in and shall be held by and be due and belong to the Corporation and shall form part of the property and assets of the Corporation for all the estate and interest therein of the county council or such authorities and shall be received held and enjoyed by the Corporation accordingly.
- (2) All the liabilities contracts and agreements of the county council and of such authorities in relation to the added area are by virtue of this Order transferred and shall attach to the Corporation and shall form part of the liabilities contracts and agreements of the Corporation and be enjoyed performed paid and discharged by them.
- (3) For the purpose of enabling the Corporation to complete a title if thought fit to any heritable property transferred to and vested in them by virtue of this Order by expeding a notarial instrument notice of title or otherwise this Order shall be deemed to be and may be used as a general disposition or assignation as the case may be of such property in favour of the Corporation.
- (4) Subject to the provisions of any general Act of Parliament and of the city Acts and this Order the Corporation shall determine any question which arises as to the department of the Corporation to which any part of such property or assets ought to belong for the purposes of administration and any question as to the fund of the Corporation out of which such liabilities and obligations shall be defrayed.

Roads streets and footpaths.

20. Subject to the provisions of this Order all bridges highways roads streets footpaths and lanes in the added area which were vested in the county council or other authorities or which the county council or the said authorities by minute or otherwise at or before the commencement of this Order had taken over or had agreed to take over and maintain or have maintained are by virtue of this Order transferred to and vested in and shall be managed maintained and repaired by the Corporation subject to the provisions of the city Acts and the county council and the said authorities shall be freed and relieved of the liability to repair and maintain all such bridges highways roads streets footpaths and lanes in all time coming.

Adjustment of property and liabilities.

21. The provisions of section 141 of the Act of 1947 shall apply to this Order as if the alteration of area made by this Order were an alteration of area made under Part VI of that Act.

- 22. All legal or other proceedings begun before the commencement Proceedings of this Order and relating to any property or liabilities transferred to not to abate. the Corporation under this Order may be carried on with the substitution of the Corporation as party to the proceedings in lieu of the authority from whom the property or liabilities was or were transferred and any such proceedings may be amended in such manner as may be necessary for that purpose.
- 23.—(1) All books documents (including certified copies of agree- Books to be ments relating to the added area) maps and plans directed or authorised evidence. to be kept by the county council or any other authorities in the added area by any Act or otherwise shall so far as they relate to the added area belong and be transferred to the Corporation and in so far as they would at the commencement of this Order be receivable in evidence shall be admitted as evidence in all courts and proceedings notwithstanding the cesser of the powers of the county council or such authorities.
- (2) This section shall not apply to the books documents maps and plans kept by the county council and other authorities which relate to parts of the county other than the added area but the Corporation and their officers shall be entitled to access to such books documents maps and plans in so far as may be necessary in relation to matters affecting the added area and the respective clerks or other officers of the county council and of the said authorities shall afford all necessary and reasonable facilities for that purpose.
- 24. Notwithstanding anything contained in the Act of 1947 or any Saving for other enactment or this Order any member of the county council or of county any district council who at the commencement of this Order represents councillors. any electoral division situated partly within and partly without the added area shall in ordinary course continue to be a member of the county council or of such district council as the case may be until the next election of county councillors or district councillors as the case may be after the commencement of this Order.
- 25. Nothing in this Order shall prejudice or interfere with the Saving recovery powers of the county council to recover all rates and assessments of rates by imposed by and due to them in respect of subjects in the added area county council. for any year before the commencement of this Order.
  - 26. Nothing in this Order shall affect—

(1) The city or the county or the limits thereof or the electors members to thereof so far as regards the election of members to serve in Serve in Parliament Parliament and the city and the county shall for parliamentary teinds etc. purposes remain the same as if the Act confirming this Order had not been passed;

- Saving of election of
- The teinds payable out of the lands situated within the city or the rights privileges and emoluments of the ministers kirk sessions and session clerks of the parishes within the same;
- (3) The holdings or tenure of any lands or heritages; and

(4) The right of any superiors owners or other persons by whom or by whose predecessors roads streets sewers bridges footpavements and footpaths in the added area have been formed to recover the cost or any proportion of the cost of forming the same from feuars or other persons under any agreements made between the parties respectively.

Saving for British Transport Commission and for gas and electricity undertakers.

27. Nothing in this Order shall transfer or be deemed or construed to transfer to the Corporation any property in the added area belonging to the British Transport Commission or to the gas or electricity authorised undertakers in the added area or any powers exercised or exercisable in the added area by the said commission or by such authorised undertakers.

Borrowing powers.

28. The Corporation in addition to any other powers of borrowing which they now have may borrow for the purpose of the payment of any capital sum in respect of any property and assets taken over by the Corporation under the provisions of this Order such sums of money as may be necessary for that purpose:

Provided that money so borrowed shall be repaid within thirty years from the date of borrowing.

Saving for emergency restrictions on borrowing.

29. Nothing in this Order shall authorise the exercise of any powers of borrowing money or the making of any issue of capital otherwise than in compliance with the provisions of the Local Authorities Loans Act 1945 or of any order for the time being in force made under section 1 of the Borrowing (Control and Guarantees) Act 1946 or of section 259 of the Act of 1947 as amended by section 4 (1) of the Local Government (Scotland) Act 1951.

Sheriff Court Houses Acts etc. not to be affected.

30. Nothing in this Order shall affect the provisions of the Sheriff Court Houses Acts 1860 to 1884 or the Aberdeen County and Municipal Buildings Act 1866 or any Act amending the same or interfere with or affect the powers of the commissioners under the said last-mentioned Act.

Crown rights.

31. Nothing in this Order shall affect prejudicially any estate right power privilege or exemption of the Crown or shall subject to the provisions of this Order any lands buildings or works vested in or occupied by the Crown or any department of Her Majesty's Government except to such extent as Her Majesty or such department may voluntarily agree.

Costs of Order. 32. The costs charges and expenses of and incident to the preparing obtaining and confirming of this Order or otherwise in relation thereto shall be paid by the Corporation out of any funds (not being in the nature of capital) rates or revenues belonging to them or under their control or out of moneys borrowed by them for that purpose.

Commencing in the navigation channel opposite the seaward extremity of the North Pier and the South Breakwater on the parliamentary boundary between the Aberdeen North Burgh Constituency and the Aberdeen South Burgh Constituency thence south-westward along the said boundary to Market Street thence south-eastward along the centre of Market Street and the Victoria Bridge to the centre of the river Dee thence south-westward along the centre of the river Dee to the south-west boundary of the railway thence southeastward along the said boundary of the railway to Wellington Road thence southward along the centre of Wellington Road to the city boundary thence north-eastward and eastward along the said city boundary to a point known as the "Needles Eye" thence due east one nautical mile thence northward at a distance of one nautical mile measured from any point taken in the high-water mark of ordinary spring tides to a point one nautical mile due east of the point of commencement and thence due west to the point of commencement.
