



CHAP. clxxxviii.

An Act to confirm certain Provisional Orders under "The Sewage Utilization Acts," relating to the districts of Hillmorton and Hurworth. A.D. 1871.
[14th August 1871.]

WHEREAS the Secretary of State for the Home Department, being one of Her Majesty's Principal Secretaries of State, has, under the provisions of the Sewage Utilization Act, 1865, and the Local Government Act, 1858, duly made certain Provisional Orders which are contained in the schedule to this Act annexed; and it is provided by the aforesaid Local Government Act that no such Orders shall be of any validity whatever until they shall have been confirmed by Parliament; and it is expedient that the said Orders should be so confirmed:

Be it therefore enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:

1. The Provisional Orders contained in the Schedule hereunto annexed shall, from and after the passing of this Act, be absolute, and be as binding and of like force and effect as if the provisions of the same had been expressly enacted in this Act. Provisional Orders in Schedule confirmed.

2. The Hillmorton Provisional Order in the Schedule to this Act shall not convey any further right of purchase in respect of the piece of land referred to in the proviso thereto, and described in the second paragraph of the Schedule thereof, beyond the right to purchase an easement therein for the passage of a sewer upon a raised embankment across the same. Proviso as to Hillmorton.

3. In citing this Act in any other Act of Parliament, or in any proceeding, instrument, or document whatever, it shall be sufficient to use the words and figures "The Sewage Utilization Supplemental Act, 1871." Short title.

HILLMORTON.

Provisional Order putting in force the Lands Clauses Consolidation Act, 1845, within the parish of Hillmorton, for the Purchase of Lands by the Surveyor, acting as Sewer Authority in the place of the Vestry of the said parish, for the purposes of Sewage Outfall and Irrigation.

WHEREAS Henry Manning, of Rugby, in the county of Warwick, surveyor, acting as sewer authority for the parish of Hillmorton, in the said county of Warwick, in the place of the vestry of the said parish, has, in pursuance of the provisions of the 7th section of the Sewage Utilization Act, 1865, and the 75th section of the Local Government Act, 1858, and after complying with the requirements of that section by duly giving and serving all notices thereby directed, presented a petition, under his hand and seal, to one of Her Majesty's Principal Secretaries of State, for authority to put in force the Lands Clauses Consolidation Act, 1845, to enable him as such sewer authority as aforesaid to purchase, otherwise than by agreement, certain pieces of land required for sewage outfall and utilization of the sewage of the said parish in the way of irrigation:

And whereas the said petition, and the schedule thereto annexed, duly set forth and described the pieces of land intended to be taken by such sewer authority for such purposes, and the names of the owners, lessee, and occupier of the aforesaid pieces of land who have assented, dissented, and are neuter in respect of the taking such pieces of land, or who have returned no answer to the notice issued by such sewer authority; and such petition prayed that the said sewer authority might, with reference to such land, be allowed to put in force the powers of the Lands Clauses Consolidation Act aforesaid with respect to the purchase and taking of land otherwise than by agreement; and on the receipt of such petition Her Majesty's Principal Secretary of State for the Home Department directed Arnold Taylor, Esq., the inspector appointed for the purpose, to

visit the said parish, and the said inspector has now inquired in the parish
aforesaid into the subject matter of such petition, and has duly reported thereon: A.D. 1871.

Now, therefore, I, as Her Majesty's Principal Secretary of State for the
Home Department, do hereby, in pursuance of the powers vested in me by the
Local Government Act, 1858, make order and direct,—

That from and after the passing of any Act of Parliament confirming this
Order,—

1. The aforesaid sewer authority of the parish of Hillmorton shall be empowered
to put in force, with reference to the lands referred to and described in the
schedule to this Order annexed, the powers of the Lands Clauses Consoli-
dation Act, 1845, with respect to the purchase and taking of land otherwise
than by agreement, for the purposes herein-before set forth and described:
Provided that the piece of land secondly described in the schedule to this
Order, containing one acre one rood and thirty perches, shall not be used
for irrigation, but, except so much as shall be occupied for the carriage of
sewage by pipes on a raised bank across the same, the said piece of land
shall be occupied as pasture or garden ground only.

SCHEDULE referred to in the preceding Order.

The PIECES of LAND proposed to be taken as described in the foregoing
Order are:—

- A certain close, piece, or parcel of meadow land containing by admeasurement
four acres three roods and twenty-nine perches, situate in the parish of
Hillmorton in the county of Warwick, now in the occupation of Thomas
Vann, bounded on or towards part of the north by the brook called Rains
Brook, on or towards other part of the north by the road leading from
Hillmorton to Clifton-upon-Dunsmore, on or towards the south and west
by lands now in the occupation of the said Thomas Vann, and on or
towards the east by land also in the occupation of the said Thomas Vann.
- A piece or parcel of land (forming part of a certain other close, piece, or parcel
of land in the occupation of the said Thomas Vann,) containing one acre
one rood and thirty perches, also situate in the parish of Hillmorton afore-
said, and bounded on or towards the north and east by the said road leading
from Hillmorton to Clifton-upon-Dunsmore, on or towards the south by
the remainder of the said close of land of which the said piece or parcel of
land intended to be taken forms a part, and on or towards the west by the
said close, piece, or parcel of land firstly herein-before described.

HURWORTH.

Provisional Order putting in force the Lands Clauses Consolidation Act, 1845, within the Township of Hurworth, for the Purchase of Lands by the Sewer Authority of the said Township for the purposes of Sewage Irrigation.

WHEREAS the sewer authority of the township of Hurworth, in the county of Durham, have, in pursuance of the provisions of the 7th section of the Sewage Utilization Act, 1865, and the 75th section of the Local Government Act, 1858, and after complying with the requirements of that section by duly giving and serving all notices thereby directed, presented a petition, under the hand of the chairman of the committee of the said sewer authority, to one of Her Majesty's Principal Secretaries of State, for authority to put in force the Lands Clauses Consolidation Act, 1845, to enable the aforesaid sewer authority to purchase, otherwise than by agreement, certain pieces of land required for the utilization of the sewage of their parish by irrigation :

And whereas the said petition, and the schedule thereto annexed, duly set forth and described the pieces of land intended to be taken by such sewer authority for such purpose, and the names of the owners, lessees, and occupiers of the aforesaid pieces of land who have assented, dissented, and are neuter in respect of the taking such pieces of land, or who have returned no answer to the notice issued by such sewer authority ; and such petition prayed that the said sewer authority might, with reference to such land, be allowed to put in force the powers of the Lands Clauses Consolidation Act aforesaid with respect to the purchase and taking of land otherwise than by agreement ; and on the receipt of such petition Her Majesty's Principal Secretary of State for the Home Department directed Arnold Taylor, Esq., the inspector appointed for the purpose, to visit the said township, and the said inspector has now inquired in the township aforesaid into the subject matter of such petition, and has duly reported thereon :

Now, therefore, I, as Her Majesty's Principal Secretary of State for the Home Department, do hereby, in pursuance of the powers vested in me by the Local Government Act, 1858, make order and direct,—

That from and after the passing of any Act of Parliament confirming this Order,—

1. The aforesaid sewer authority of the township of Hurworth shall be empowered to put in force, with reference to the lands referred to and described in the schedule to this Order annexed, the powers of the Lands Clauses Consolidation Act, 1845, with respect to the purchase and taking of land otherwise than by agreement, for the purpose herein-before set forth and described.
