# Cap. lxxxiv.

An Act for the more easy and speedy Recovery of Small Debts within the City and Borough of New Sarum and other Places in the Counties of Wilts, Hunts, and Dorset. [21st June 1841.]

HEREAS the City and Borough of New Sarum in the County of Wilts is a Market Town, and very populous, and the several Boroughs, Parishes, Townships, and Places in the several Hundreds herein-after mentioned, viz., Alderbury, Clarendon Park, Grimstead East, Grimstead West, Idmiston, Laverstock and Ford, Melchet Park, Pitton and Farley, Plaitford, West Dean, Winterborne Dantsey, Winterborne Earls, Winterborne Gunner, and West Winterslow, in the Hundred of Alderbury; Allington, Amesbury, Boscombe, Bulford, Cholderton, Durnford, Durrington, East Winterslow, Figheldean, Kingstone Deverell, Ludgershall, Milstone and Brigmistone, Newton Toney, North Tidworth, and West Wellow, in the Hundred of Amesbury; Berwick Saint James, Fisherton Anger, Fugglestone Saint Peter, Groveley Woods, Great Wishford, Little Langford, Maddington, Orcheston Saint Mary, Shrewton, South Newton, Stapleford, Steeple Langford, Winterborne Stoke, and Wilton, in the Hundred of Branch and Dole; Barford Saint Martin, Baverstock, Bramshaw, Britford and Longford, Burcombe , [Local.] 22 D

combe South, Coombe Bissett, Fovant, Groveley Woods, Hommington, Netherhampton, Odstock, Stratford Toney, Sutton Mandeville, West Harnham, and Whichbury, in the Hundred of Cawden and Cadworth; Alvidestone, Berwick Saint John, Bower Chalke, Broad Chalke, Ebbesborne Wake, Fysield Bavant, Semley, and Tollard Royal, in the Hundred of Chalke; Bishops Fonthill, Bishopstone, Downton, East Knoyle, Hindon, Nunton and Bodenham, Standlinch, and No Man's Land, in the Hundred of Downton; Anstey, Berwick Saint Leonard, Chicklade, Chilmark, Donhead Saint Andrew, Donhead Saint Mary, Fonthill Gifford, Sedghill, Swallowcliffe, Tisbury, Teffont Evias, and Wardour, in the Hundred of Dunworth; Landford, Whiteparish, and The Earldoms, in the Hundred of Frustfield; Kingstone Deverell, Knoyle West, Maiden Bradley, Mere, and Stourton, in the Hundred of Mere; Great Woodford, Little Woodford, Milford, Stratford under the Castle, and Wilsford and Lake, in the Hundred of Underditch; Compton Chamberlain, Damerham South, East Martin, West Martin, and Tiddpitt, in the Hundred of Damerham South, all in the County of Wilts; Christchurch, Holdenhurst, Hordle, Milford, Milton, and Sopley, in the Hundred of Christchurch; Breamore, Charford North, Charford South, Ellingham, Fordingbridge, Hale, Ibsley, and Rockbourne, in the Hundred of Fordingbridge; Harbridge and Ringwood, in the Hundred of Ringwood; Bossington, Broughton, Buckholt Farm, Dean East, Embley, Frenchmore Ville, Lockerley, Mottisfont, Sherfield English, Shipton, Titherleigh East, Titherleigh West, Wallop Nether, Wallop Over, and Wellow East, the Town and Borough of Lymington, and the Parishes of Boldre and Brockenhurst, in the Hundred of Thorngate, all in the County of Hants; Chalbury cum Didlington, Gussage St. Michael, Hinton Martell, Hinton Parva, Horton, More Critchill, Shapwick, and Wimborne Minster, in the Hundred of Badbury; Canford Magna, Corfe Mullen, Hamworthy, Kinson or Kingston, Longsleet, Lytchett Matravers, Lytchett Minster, Parkstone, and Sturminster Marshall, in the Hundred of Cogdean; Ashmore, Belchalwell, Cranborne, Edmondsham, Farnham Royal, Farnham Tollard, Hampreston, Okeford Shilling, Pentridge, Tarrant Gunville, Tarrant Rushton, Turnworth, West Parley, and Witchampton, in the Hundred of Cranborne; Chettle and Tarrant Monckton, in the Hundred of Monckton up Wimborne, all in the County of Dorset, are also populous, and are much increasing in Population; that in the said City of New Sarum, and in many of the said Boroughs, Parishes, Townships, and Places, various important Trades and Manufactures are carried on, which employ great Numbers of People, who, along with divers other Persons, residing or trading within the said City, Boroughs, Parishes, Townships, and Places, contract many Small Debts, which, in the whole, amount yearly to a very large Sum of Money; and although many of such Debtors are well able to pay their respective Debts, they often refuse to pay the same, by reason of which their respective Creditors are either obliged to forego their respective Debts, or for the Recovery thereof to incur an Expence sometimes far exceeding, and in all Cases disproportionate to the Sums in dispute; that it would be a Source of great Benefit and public Advantage to the said City and Borough of New Sarum, and the several Boroughs, Parishes, Town-

ships, and Places before mentioned, and tend much to the Support and Protection of useful Credit within the same, if an easy and speedy Method of recovering Small Debts within the same were provided; but it cannot be effected without the Aid and Authority of Parliament: May it therefore please Your Majesty that it may be enacted; and be it enacted by the Queen's most Excellent Majesty, by and with the Advice and Consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the Authority of the same, That the Judge and his Successors, to be Constitution appointed as herein-after mentioned, shall be a Court of Justice for of the Court. the Recovery of Small Debts within the City and Borough of New Sarum, and the several Boroughs, Parishes, Townships, and Places aforesaid, by the Name of the "Salisbury and South Wilts Court of Requests."

II. And be it enacted, That the said Court shall be holden at any Where Courts convenient Place or Places within the City and Borough of New are to be Sarum, and the Boroughs, Parishes, Townships, or Places of Ames-held. bury, Hindon, Fordingbridge, Ringwood, Christchurch, Lymington, and Wimbourne Minster, as the Judge of the said Court shall from Time to Time see fit, and at such Times as the said Judge shall appoint; and it shall be lawful for the Judge of the said Court to appoint such other Place or Places as he shall think fit for the Purpose of holding Courts therein, but so that the Intervals between the holding of any Two such Courts shall in no Case be more than Two Calendar Months.

Stoke, Wilsford and Lake, and Shipton, unless the said Summons be made returnable at the said Township or Parish of Amesbury; and that no Summons shall be issued, under the Powers given by this Act. against any Person residing, trading, or dealing within the Borough or Township of Christchurch, and the Parishes or Places of Holdenhurst, Milton, Sopley, West Parley, Kinson or Kingstone, and Parkstone, unless the said Summons be made returnable at the said Borough or Township of Christchurch; and that no Summons shall be issued, under the Powers of this Act, against any Person residing, trading, or dealing within the Borough or Township of Lymington, and the Parishes or Places of Hordle, Milford, Boldre, and Brocken. hurst, unless the said Summons be made returnable at the said Borough or Township of Lymington; and that no Summons shall be issued, under the Powers given by this Act, against any Person residing, trading, or dealing within the Township or Parish of Wimborne Minster, and the Parishes or Places of Chalbury cum Didlington, Gussage Saint Michael, Hinton Martell, Hinton Parva, Hinton, More Critcell, Shapwick, Canford Magna, Corfe Mullen, Hamwerthy, Longfleet, Lytchett Matruvers, Lytchett Minster, Sturminster Marshall, Edmondsham, Hampreston, Okeford Shilling, Tarrant Gunville, Tarrant Rushton, Turnworth, Witchampton, Chettle and Tarrant Monckton, unless the said Summons be made returnable at the said Township or Parish of Wimborne Minster; and that no Summons shall be issued, under the Powers given by this Act, against any Person residing, trading, or dealing within the Township or Parish of Hindon, and the Parishes or Places of Kingston Deverille, Fovant, Sutton Mandeville, Alvidestone, Berwick Saint John, Bower Chalk, Broad Chalk, Ebbesborne Wake, Fifield Bavant, Semley, Tollard Royal, Bishops Fonthill, East Knoyle, Ansty, Berwick Saint Leonard, Chicklade, Chilmark, Donhead Saint Andrew, Donhead Saint Mary, Fonthill Gifford, Sedghill, Swallowcliffe, Tisbury, Teffont Evias, Wardour, Knoyle West, Maiden Bradley, Mere, and Stourton, unless the said Summons be made returnable at the said Township or Parish of Hindon; and that no Summons shall be issued, under the Powers given by this Act, against any Person residing, trading, or dealing within the Township or Parish of Fordingbridge, and the Parishes or Places of Farnham Royal, Farnham Tollard, Ashmore, Cranborne, Breamore, Charford North, Charford South, Hale, Rockbourne, Belchalwell, Damerham South, East Martin, West Martin, Tidpitt, Whichbury, Downton, Standlinch, No Man's Land, and Pentridge, unless the said Summons be made returnable at the said Township or Parish of Fordingbridge; and that no Summons shall be issued, under the Powers given by this Act, against any Person residing, trading, or dealing within the Township or Parish of Ringwood, and the Parishes or Places of Harbridge, Ellingham, and Ibsley, unless the said Summons be made returnable at the said Township or Parish of Ringwood.

Judge of the Court to be appointed.

IV. And be it enacted, That it shall be lawful for the Lord Chancellor, Lord Keeper or Lords Commissioners of the Great Seal of England, for the Time being, at any Time after the passing of this Act, and from Time to Time when any Judge to be appointed under this Act shall die, resign, or be removed, to appoint to be Judge of the said

said Court any Person who either shall have been called to the Bar, and shall have practised as a Barrister for at least Seven Years, or who shall be an Attorney of one of Her Majesty's Superior Courts of Common Law at Westminster, and shall have been certified by Three or more Judges of the said Superior Courts to the Lord Chancellor, Lord Keeper or Lords Commissioners of the Great Seal, for the Time being, as a fit Person to be appointed Judge of the said Court; and it shall be lawful for the Lord Chancellor, Lord Keeper or Lords Commissioners of the Great Seal, for the Time being, if he or they shall think fit, to remove any Judge of the said Court for Misbehaviour, or upon a Petition to be preferred to him or them for that Purpose by the Justices of the Peace in Quarter Sessions assembled for the respective Counties of Wilts, Hants, and Dorset, or by Three Justices of the said Counties residing within the Parishes, Townships, or Places aforesaid, or some of them.

V. And be it enacted, That in case of the Illness or unavoidable In case of Absence of the Judge of the said Court it shall be lawful for such Illness or of Judge to appoint some Person, being a Barrister of Seven Years Absence the standing, or an Attorney of one of Her Majesty's Superior Courts Judge may at Westminster, who has been in Practice Seven Years at the least, appoint a to act as his Deputy during such Illness or unavoidable Absence; Deputy. and such Deputy shall, during the Time for which he shall be so appointed, have the same Power of deciding, pronouncing Judgment, making Orders, and issuing Executions in any Actions brought before him in the said Court as the Judge by whom he shall have been so appointed.

VI. And be it enacted, That the Justices of the Peace in Quarter Justices to Sessions assembled for the Southern Divison of the County of Wilts appoint shall from Time to Time, with the Approbation of the Judge of the Clerks and other Officers. said Court for the Time being, appoint a fit Person, being an Attorney of one of Her Majesty's Superior Courts at Westminster, and not being the Judge, or the Partner of the Judge of the said Court, to be Clerk of the said Court, and the said Justices may remove any such Clerk upon sufficient Cause: Provided always, that in case Twenty Days shall intervene between the Death, Removal, or Resignation of any Clerk of the said Court and the then next General Quarter Sessions of the Peace in and for the said Southern Division of the County of Wilts, it shall be lawful for the Judge of the said Court to appoint some fit Person, qualified as aforesaid, to be Clerk of the said Court, until the Appointment of a Clerk by the said Court of Quarter Sessions as aforesaid.

VII. And be it enacted, That in case of the Illness or unavoidable Clerk may Absence of the Clerk of the said Court, it shall be lawful for the appoint a said Clerk (with the Approbation of the Judge) to appoint from Deputy. Time to Time some Person, being an Attorney of one of the Superior Courts at Westminster, to act as his Deputy during such Illness or unavoidable Absence, and to remove such Deputy at his Pleasure; and such Deputy, during the Time for which he shall be so appointed, shall have the like Powers as if he were Clerk of the said Court for the Time being.

Judge to appoint inferior Officers.

VIII. And be it enacted, That the Judge of the said Court shall from Time to Time appoint and may remove the Bailiffs and other inferior Officers of the said Court.

Justices to appoint a Treasurer.

IX. And be it enacted, That the Justices in Quarter Sessions assembled for the said Southern Division of the County of Wilts shall appoint a fit Person to be the Treasurer of the said Court, who shall not be the Judge, Clerk, or other Officer of the Court, and who shall be resident in the said City of New Sarum; and such Justices may remove any such Treasurer, and appoint any other Person in his Room: Provided always, that Notice of the Intention to propose that any Treasurer be removed shall be given at the Sessions before that at which the Motion for his Removal shall be and the second of the second o made.

Clerk and Treasurer

X. And be it enacted, That it shall not be lawful for the Clerk of the said Court, or the Partner of such Clerk, or any Person in the not to be the Service or Employ of such Clerk or of his Partner, to act as Treasurer of the said Court, nor for the Treasurer of the said Court, or the Partner of such Treasurer, or any Person in the Service or Employ of such Treasurer or of his Partner, to act as Clerk of the said Court; and if any Person shall accept both the Offices of Clerk and Treasurer of the said Court, or if any Person being the Partner of any such Clerk, or a Person in the Service or Employ of any such Clerk or of his Partner, shall accept the Office of Treasurer, or in any Manner officiate for the Treasurer, or being the Partner of any such Treasurer, or a Person in the Service or Employ of any such Treasurer or of his Partner, shall accept the Office of Clerk in the Execution of this Act, or shall in any Manner officiate for such Clerk, every such Person so offending shall for every such Offence forfeit and pay the Sum of Fifty Pounds to any Person who shall sue for the same in any of Her Majesty's Courts of Record at Westminster, by Action of Debt or on the Case.

Treasurer and Officers to give Security.

XI. And be it enacted, That the Treasurer, and also every Clerk, Bailiff, and Officer of the said Court who shall receive any Monies in the Execution of their Duty, shall give Security for such Sum, and in such Manner and Form, as the Justices of the Peace in Quarter Sessions assembled for the Southern Division of the County of Wilts shall see Reason to direct, for the due Performance of their several Offices, and for the due Payment of all Monies received by them under this Act.

Duties of the Clerk and Bailiffs.

XII. And be it enacted, That the Clerk of the said Court shall issue all Summonses, Warrants, Precepts, and Writs of Execution, and register all Orders and Judgments of the said Court, and keep an Account of all such Summonses, Executions, and other Process of the Court issued by him, and shall take charge of and keep an Account of all Court Fees and Fines payable or paid into Court, and of all Suitors Money paid into and out of Court, and shall enter an Account of all such Fees, Fines, and Monies in a Book to be kept by him for the Purpose, which Book shall be open to the Inspection of all Parties desirous of inspecting the same on Payment of One Shilling for each

and

and every such Inspection; the Bailiffs of the said Court shall serve all such Summonses, and execute all such Orders, Warrants, Precepts, and Writs; and a List of the Names and Places of Abode of every Bailiff appointed to execute the Process of the said Court shall be put up in a conspicuous Place in the Court and in the Clerk's Offices.

XIII. And be it enacted, That the Treasurer of the said Court Duties of shall from Time to Time, quarterly or oftener, audit or settle the Treasurer. Accounts of the said Clerk and other Officers of the said Court, and receive the Balance of such Monies as such Clerk and other Officers may have received under this Act belonging to the Suitors of the said Court, or applicable to the General Fund herein-after mentioned, and shall make all such Payments as it shall be requisite to make in accordance with the Provisions of this Act.

XIV. And be it enacted, That if any Person, having resigned or Upon the having been removed from the Office of Treasurer of the said Court, shall neglect, within Twenty-one Days after Notice in Writing for such Person to account for and pay to the Treasurer of the said Successor Court for the Time being, or to such Person as he shall appoint to receive the same, all such Sums of Money as shall remain in his Hands applicable to the Purposes of this Act, it shall be lawful for his Hands. the Treasurer of the said Court for the Time being, by his Name and Description of Office, to sue for and recover the same from such Person, with full Costs, in any of Her Majesty's Courts of Record at Westminster, by Action of Debt, in which Action it shall be sufficient for such Treasurer to declare as for Money had and received to the Use of such Treasurer for the Purposes of this Act; and the Court in which the Action shall be brought may, at the Instance of either of the Parties, refer the Account in dispute in a summary Manner to be audited by any Officer of the Court, or other fit Person, who may examine both Plaintiff and Defendant upon Oath (which Oath the said Referee shall have Power to administer), and upon the Report of the Referee, unless either of the Parties shall show good Cause to the contrary, the Court may make a Rule, either for the Payment of such Sum as upon the Report shall appear to be due, or for staying the Proceedings in the Action, and upon such Terms and Conditions as to the Court shall appear reasonable, or the Court may order Judgment to be entered up by Confession for such Sum as upon the Report shall appear to be due.

XV. And be it enacted, That in case of the Death of any Person Mode of Produring the Time that he shall be holding the Office of Treasurer, or ceeding after he shall have resigned or been removed from such Office, the Representa-Treasurer for the Time being may, by his Name and Description of tives of a. Office, sue for and recover, from the Executors and Administrators of deceased such Person deceased, all such Sums of Money as shall have been Treasurer. remaining in his Hands applicable to the Purposes of this Act, by an Action of Debt in any of Her Majesty's Courts of Record at Westminster, in which Action it shall be sufficient for the Plaintiff to declare that the Deceased was indebted to the Plaintiff for Money

had

had and received to his Use for the Purposes of this Act, whereby an Action hath accrued to the Plaintiff to demand and have the same from such Executors or Administrators; and in all such Actions the Defendants may plead in like Manner, and avail themselves of the like Matters of Defence, as in any Action founded upon simple Contracts of the Testator or Intestate; and the Court may refer the Account in dispute, and such Proceedings may thereupon be had as herein before provided in case of Actions against the Treasurer during his Lifetime.

Remedies
against Bailiffs and other
Officers.

XVI. And be it enacted, That if any Bailiff or Officer of the said Court, acting under Colour or Pretence of the Process of the said Court, shall be guilty of Extortion, or shall not duly pay or account for any Money levied by him under the Authority of this Act, it shall be lawful for the said Judge to make such Order for the Repayment of any Money extorted, or for the due Payment of any Money so levied as aforesaid, and for the Payment of such Damages and Costs to the Parties aggrieved, as the Court shall think just; and in default of Payment of any Money so ordered to be paid by such Bailiff within the Time specified for the Payment thereof in such Order, it shall be lawful for the Judge of the said Court, by Warrant under his Hand and Seal, to cause such Sum to be levied by Distress and Sale of the Goods of the Offender, together with the reasonable Charges of such Distress and Sale, and in default of such Distress to commit the Offender to any Common Gaol or Prison in the said Counties of Wilts, Hants, and Dorset, for any Period not exceeding Three Calendar Months.

Fees to be taken according to the Schedule.

XVII. And be it enacted, That there shall be payable to the Judge of the said Court, and to the Clerk and Bailiffs thereof, on every Proceeding in the Court, such Fees as are set down in the Schedule to this Act annexed, or as shall be from Time to Time directed to be taken by the Justices of the Peace in Quarter Sessions assembled for the Southern Division of the County of Wilts, and none other, and a Table of such Fees shall be hung up in some conspicuous Place in such Court and in the Clerk's Office; and the Fees on every Proceeding shall be paid, in the first instance, by the Plaintiff or Party on whose Behalf the same shall be taken, on or before such Proceeding, and the Fees upon Executions shall be paid into Court at the Time of the Issue of the Warrant of Execution, and shall be paid by the Clerk of the Court to the Bailiff upon the Return of the Warrant of Execution, and not before.

Treasurer and other Officers to be paid by Salary.

XVIII. And be it enacted, That the Treasurer of the said Court, and all other Officers and Servants employed in or about the Court exclusively of the Judge, Clerk, and Bailiffs, shall receive Salaries for their respective Services, such Salaries to be fixed from Time to Time by the Judge of the Court, and to be paid out of the General Fund herein-after mentioned.

Officers taking Fees beXIX. And be it enacted, That if any Clerk, Bailiff, or other Officer employed under this Act shall exact or take any greater Fee

or Reward whatsoever than such Fees as are or shall be appointed youd those and allowed respectively as aforesaid, every such Person so offending shall, upon Proof thereof before the said Court, be for ever incapable of serving or being employed in any Office under this Act.

XX. And be it enacted, That the Treasurer of the said Court Treasurer to shall, as soon as conveniently may be, pay off and discharge the Costs and Expences attending the passing of this Act, and shall, under the Houses, &c. Direction of the Justices of the said Southern Division of the County of Wilts in Quarter Sessions assembled, provide suitable Buildings, with all necessary Appurtenances, for holding the said Court under the Authority of this Act, and for the Offices necessary for carrying on the Business of the said Court; and all Lands, Tenements, and Hereditaments belonging to the said Court shall vest in the Treasurer for the Time being, and in his Successors in that Office, in Trust for the Purposes of this Act.
