



## CHAPTER lxxvii.

An Act to authorise the Corporation of London to borrow and reborrow under the Local Loans Act 1875. A.D. 1892.

[20th June 1892.]

**W**HEREAS doubts have arisen as to whether the Mayor and Commonalty and Citizens of the City of London (in this Act referred to as the Corporation) are for the purposes of borrowing or reborrowing any moneys which they are authorised to borrow or reborrow under any of the Acts specified in the schedule hereto a local authority within the meaning of the Local Loans Act 1875 :

And whereas it is expedient to remove the aforesaid doubts :

And whereas the objects aforesaid cannot be attained without the authority of Parliament :

May it therefore please Your Majesty that it may be enacted and be it enacted by the Queen's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows (that is to say) :—

1. This Act may be cited for all purposes as the Corporation of London (Loans) Act 1892. Short title.

2. The Corporation shall for the purposes of borrowing or re-borrowing any moneys which they are authorised to borrow or reborrow on bonds under any of the Acts specified in the schedule hereto be deemed to be a local authority within the meaning of the Local Loans Act 1875 and the Corporation may for any of the purposes in those Acts mentioned or in connexion therewith borrow or reborrow under any of the provisions of the said Act of 1875 in lieu of any of the provisions of the Acts specified in the schedule.
