

CHAPTER cxxviii.

An Act to confirm certain Provisional Orders of the Local A.D. 1893. Government Board relating to the Haslingden and Rawtenstall Outfall Sewerage District, the Urban Sanitary Districts of Manchester and Plymouth, the Stourbridge Main Drainage District and the Upper Stour Valley Main Sewerage District. [27th July 1893.]

WHEREAS the Local Government Board have made the Provisional Orders set forth in the schedule hereto, under the provisions of the Public Health Act, 1875:

38 & 39 Vict. c. 55.

And whereas it is requisite that the said Orders should be confirmed by Parliament, and that the provisions herein contained should be enacted with reference thereto:

Be it therefore enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:—-

1. The Orders as altered and set out in the schedule hereto shall Orders be and the same are hereby confirmed, and all the provisions thereof in schedule confirmed. shall have full validity and force.

2. The sanitary authorities mentioned in the Orders relating Restriction to the Haslingden and Rawtenstall Outfall Sewerage District, the of power to take houses Urban Sanitary District of Manchester, the Stourbridge Main of labouring Drainage District and the Upper Stour Valley Main Sewerage class. District hereby confirmed, shall not purchase or acquire, either compulsorily or by agreement, in any city, borough, or other urban sanitary district, or in any parish or part of a parish not being within an urban sanitary district, ten or more houses included in the schedules to those Orders which on the fifteenth day of December

A.D. 1893. last were occupied either wholly or partially by persons belonging to the labouring class as tenants or lodgers, or except with the consent of the Local Government Board ten or more houses which were not so occupied on the said fifteenth day of December, but have been or shall be subsequently so occupied.

Special provisions as to Plymouth.

- 3. The following provisions shall apply to the sanitary authority for the Urban Sanitary District of Plymouth:—
 - (1.) The sanitary authority shall not purchase or acquire. either compulsorily or by agreement, in the district ten or more houses included in the schedule to the Order relating to the district hereby confirmed, which after the passing of this Act have been, or on the fifteenth day of December last were, occupied either wholly or partially by persons belonging to the labouring class as tenants or lodgers, unless and until—
 - (a.) They shall have obtained the approval of the Local Government Board to a scheme for providing new dwellings for such number of persons as were residing in such houses on the fifteenth day of December last, or for such number of persons as the Local Government Board shall, after inquiry, deem necessary, having regard to the number of persons on or after that date residing in such houses and working within one mile therefrom, and to the amount of vacant suitable accommodation in the immediate neighbourhood of such houses, or to the place of employment of such persons, and to all the circumstances of the case; and
 - (b.) They shall have given security to the satisfaction of the Local Government Board for the carrying out of the scheme.
 - (2.) The approval of the Local Government Board to any scheme under this section may be given either absolutely or conditionally, and after the Local Government Board have approved of any such scheme they may from time to time approve either absolutely or conditionally of any modifications in the scheme.
 - (3.) Every scheme under this section shall contain provisions prescribing the time within which it shall be carried out, and shall require the new dwellings proposed to be provided under the scheme to be completed fit for occupation before the persons residing in the houses in respect of which the scheme is made are displaced:

Provided that the Local Government Board may dispense with the last-mentioned requirement, subject to such conditions, if any, as they may see fit.

- (4.) Any provisions of any scheme under this section, or any conditions subject to which the Local Government Board may have approved of any scheme, or of any modifications of any scheme under this section, or subject to which they may have dispensed with the above-mentioned requirement, shall be enforceable by writ of mandamus to be obtained by the Local Government Board out of the High Court.
- (5.) If the sanitary authority acquire or appropriate any house or houses for the purposes of this Act or of the Order hereby confirmed in contravention of the foregoing provisions, or displace or cause to be displaced the persons residing in any house or houses in contravention of the requirements of the scheme, they shall be liable to a penalty of five hundred pounds in respect of every such house, which penalty shall be recoverable by the Local Government Board by action in the High Court, and shall be carried to and form part of the Consolidated Fund of the United Kingdom:

Provided that the Court may, if it think fit, reduce such penalty.

(6.) Subject to the provisions of this section, the sanitary authority and the Local Government Board and their inspectors shall have and may exercise for any purpose in connexion with any scheme under this section all or any of the powers vested in them under the Public Health Act, 1875, in the same manner in every respect as if the preparation and carrying into effect of such scheme were one of the general purposes of that Act:

Provided that all lands on which any buildings have been erected or provided by the sanitary authority in pursuance of any scheme under this section shall, for a period of twenty-five years from the date of the scheme, be appropriated for the purpose of dwellings, and every conveyance, demise, or lease of such lands and buildings shall be endorsed with notice of this enactment:

Provided also, that the Local Government Board may at any time dispense with all or any of the requirements of this sub-section, subject to such conditions, if any, as they may see fit.

(7.) The sanitary authority shall pay to the Local Government Board a sum to be fixed by that Board in respect of the preparation and issue of any Provisional Order in pursuance of this section, and any expenses incurred by that Board in relation to any inquiries under this section, including the expenses of any witnesses summoned by the inspector holding the inquiry, and a sum to be fixed by that Board, not exceeding three guineas a day, for the services of such inspector.

Definition of labouring class.

4. For the purposes of sections two and three of this Act, the expression "labouring class" includes mechanics, artisans, labourers, and others working for wages, hawkers, costermongers, persons not working for wages but working at some trade or handicraft without employing others except members of their own family, and persons, other than domestic servants, whose income does not exceed an average of thirty shillings a week, and the families of any of such persons who may be residing with them.

Short title.

5. This Act may be cited as the Local Government Board's Provisional Orders Confirmation (No. 7) Act, 1893.

Outfall Sewerage Board, from and after the date of the Act of Parliament confirming this Order, to put in force, with reference to the lands described in the Schedule hereto, subject to the continuance of any existing public rights of highway, and for the purpose aforesaid, the powers of the Lands Clauses Acts with respect to the purchase and taking of lands otherwise than by agreement, or any of them.

BOROUGH OF PLYMOUTH.

Plymouth Order.

Provisional Order to enable the Urban Sanitary Authority for the Borough of Plymouth to put in force the Compulsory Clauses of the Lands Clauses Acts.

To the Mayor, Aldermen, and Burgesses of the Borough of Plymouth, being the Urban Sanitary Authority for that Borough; —

And to all others whom it may concern.

WHEREAS the Mayor, Aldermen, and Burgesses of the Borough of Plymouth, as the Urban Sanitary Authority for that Borough (herein-after referred to as "the Corporation"), require to purchase and take the lands described in the Schedule hereto for the purpose of widening, opening out, and otherwise improving certain streets in the Borough called King Street West, Regent Street otherwise Belair Street, Kinterbury Street, Beaumont Road, Quay Lane, Mill Street otherwise Mill Lane, Longfield Place, Tavistock Road, and Tavistock Place, Cambridge Street, and for constructing a new street leading from Marine Place to the southern end of Cattedown Village;

And whereas the execution of the works in connection with the construction of the new street leading from Marine Place to the southern end of Cattedown Village (hereinafter referred to as "the new street") will interfere with or affect the railway lands, works, and property of the London and South Western Railway Company (hereinafter referred to as "the South Western Company"),

Plymouth Order, and the railway lands, works, and property of the Plymouth and Dartmoor Railway Company (hereinafter referred to as "the Plymouth and Dartmoor Company"), which last mentioned railway lands, works, and property are either wholly or in part run over, worked, or used by the South Western Company, and it is expedient that the provisions hereinafter contained shall have effect.

Now therefore, We, the Local Government Board, in pursuance of the powers given to Us by Section 176 of the Public Health Act, 1875, and by any other Statutes in that behalf, do hereby empower the Corporation, from and after the date of the Act of Parliament confirming this Order, to put in force, with reference to the lands described in the Schedule hereto, subject to the continuance of any existing public rights of highway, and for the purposes aforesaid, the powers of the Lands Clauses Acts with respect to the purchase and taking of lands otherwise than by agreement, or any of them, but subject to the following conditions, viz:—

Provisions for the protection of the London and South Western and Plymouth and Dartmoor Railway Companies:

- 1. The Corporation shall not enter upon or interfere with the railway lands, works, or property of the South Western Company, or the Plymouth and Dartmoor Company, or execute any work whatsoever affecting the same or within three yards thereof respectively, until there shall have been delivered to the South Western Company by the Corporation plans, drawings, and specifications (hereinafter referred to as "the plans of the works") of the new street and works (hereinafter referred to as "the works") intended to be executed so far as they may interfere with or affect those railways or either of them (which plans shall show or define the manner of executing the works and the materials to be used for the purpose), nor until the plans of the works have been examined and approved in writing by the chief engineer of the South Western Company, or in the event of his failing to approve or disapprove of the same within one month after the plans of the works have been so delivered until the same have been examined and approved by an engineer to be appointed (failing agreement) by the president for the time being of the Institution of Civil Engineers.
- 2. The works shall be executed by the Corporation at their sole expense, and shall respectively be subsequently maintained by the Corporation in all things according to the plans of the works so approved under the superintendence and to the reasonable satisfaction of the chief engineer of the South Western Company, and if and whenever the Corporation fails to comply with this requirement, and after 24 hours notice in writing of such default (or in case of emergency without notice), the South Western Company may make, do, and execute any works of maintenance or repair which they from time to time may think requisite in that behalf, and the sums from time to time certified by their engineer to be the amount of expenditure in that behalf shall be repaid to them by the Corporation, and in default of full repayment the amount due may be recovered with full costs by the South Western Company from the Corporation in any court of competent jurisdiction.
- 3. The works shall be constructed, maintained, and used so as not to prevent or impede the convenient passage of engines and carriages along the railways and sidings of the South Western Company and the Plymouth and Dartmoor Company as heretofore, or otherwise interfere with the works or property of the two companies across or alongside which the new street is intended to pass.

4. The Corporation shall bear, and on demand pay to the South Western Company, the expense of the employment by them during the construction of the works on or adjacent to the lands of the South Western Company or the Plymouth and Dartmoor Company of a sufficient number of inspectors and watchmen to be appointed by them at their sole discretion for watching the said railways or either of them with reference to and during the construction of the works, and for preventing as far as may be all interference, obstruction, danger, and accident from any of the operations or from the acts or defaults of the Corporation, or any person or persons in their employ, or their contractors or others, with reference thereto or otherwise.

- 5. If by reason of any works or proceedings or any act or omission of the Corporation or any person or persons in their employ, or their contractors or others, with reference to the works, there shall be any obstruction of, or interference with, the railways of the South Western Company, or the Plymouth and Dartmoor Company, so as to prevent or impede the convenient passage of engines and carriages along the same, the Corporation shall pay to the South Western Company all costs and expenses to which that Company and the Plymouth and Dartmoor Company may be put, as well as full compensation for the loss and inconvenience sustained by them by reason of such obstruction or interference, such costs and expenses and compensation to be recoverable with full costs by the companies in any court of competent jurisdiction.
- 6. Except as is shown on the plans of the works, no land belonging to the South Western Company or the Plymouth and Dartmoor Company shall be taken by the Corporation without the consent in writing of the South Western Company or the Plymouth and Dartmoor Company under their respective common seals first had and obtained.
- 7. Any difference which may arise between the South Western Company and the Plymouth and Dartmoor Company, or either of them, and the Corporation touching any of the matters referred to in these conditions shall be decided by arbitration by an engineer to be agreed upon or failing agreement to be appointed on the application of either party by the president for the time being of the Institution of Civil Engineers, and the costs of such arbitration and of the parties thereto shall be in the discretion of the arbitrator.
