

CHAPTER cxxxiii.

An Act to confirm a Provisional Order of the Local A.D. 1893.

Government Board relating to the Contributory Place of Shevington.

[27th July 1893.]

WHEREAS the Local Government Board have made the Provisional Order set forth in the schedule hereto, under the provisions of the Public Health Act, 1875:

And whereas it is requisite that the said Order should be c. 55 confirmed by Parliament:

Be it therefore enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:—

- 1. The Order set out in the schedule hereto shall be and the Order in same is hereby confirmed, and all the provisions thereof shall have confirmed. full validity and force.
- 2. This Act may be cited as the Local Government Board's Short title. Provisional Order Confirmation (No. 17) Act, 1893.

CONTRIBUTORY PLACE OF SHEVINGTON.

Provisional Order for altering the Liverpool Waterworks and Improvement Act, 1887.

- To the Mayor, Aldermen, and Citizens of the City of Liverpool, being the Urban Sanitary Authority for that City; —
- To the Mayor, Aldermen, and Citizens of the City of Manchester, being the Urban Sanitary Authority for that City; —
- To the Standish with Langtree Local Board, being the Sanitary Authority for the Urban Sanitary District of Standish with Langtree, in the County of Lancaster; —
- To the Guardians of the Poor of the Wigan Union, in the County of Lancaster, being the Sanitary Authority for the Rural Sanitary District of that Union;—

And to all others whom it may concern.

WHEREAS by Section 81 of the Manchester Corporation Waterworks Act, 1879 (herein-after referred to as "the Manchester Act"), the Mayor, Aldermen, and Citizens of the City of Manchester, acting by the Council (herein-after referred to as "the Manchester Corporation"), are empowered to supply, in bulk, to (inter alia) any Urban or Rural Sanitary Authority demanding the same, whose District is situated in the neighbourhood of the aqueduct ninthly described in and authorised by Section 10 of that Act, such daily quantity of water as any such Authority may from time to time require and agree thereafter to take upon the terms therein mentioned;

And whereas by Section 11 of the Liverpool Waterworks and Improvement Act, 1887 (herein-after referred to as "the Liverpool Act"), the Mayor, Aldermen, and Citizens of the City of Liverpool, acting by the Council (herein-after referred to as "the Liverpool Corporation"), are empowered to supply water, by agreement, in bulk or otherwise, and for domestic or other purposes, to any Local or Sanitary Authority, any part of whose District was situate within twenty miles of the Vyrnwy or Rivington Aqueducts, upon the terms and conditions in that section mentioned;

And whereas by Section 12 of the Liverpool Act' the Liverpool Corporation were precluded from supplying water, either directly or indirectly, to (inter alia) any Local or Sanitary Authority for use or consumption in any part of the area in that section more particularly defined, which area comprised the Urban Sanitary District of Standish with Langtree, in the County of Lancaster, the

contributory place of Coppul, in the Rural Sanitary District of the Chorley Union, in the same County, and the contributory place of Shevington, in the Rural Sanitary District of the Wigan Union, in the same County;

A.D. 1893. Shevington Order,

And whereas by a Provisional Order of the Local Government Board dated the Twelfth day of May, One thousand eight hundred and ninety-one, and duly confirmed by the Local Government Board's Provisional Orders Confirmation 54 & 55 Vict. (No. 11) Act, 1891, the Liverpool Corporation were authorised to supply water, by agreement, in bulk to the Standish with Langtree Local Board (herein-after referred to as "the Local Board"), in such quantity as might be necessary to enable the Local Board to supply the whole of their District with water, and to furnish water to the Rural Sanitary Authority of the Chorley Union by agreement, in such quantity as would be sufficient to furnish an adequate supply of water for domestic or other purposes in the said contributory place of Coppul, and by an agreement made in pursuance of the said Provisional Order between the Liverpool Corporation and the Local Board, the Liverpool Corporation are now supplying water, in bulk, to the Local Board for use in the District of the Local Board and the said contributory place of Coppul;

And whereas the said contributory place of Shevington is situate within the neighbourhood of the aqueduct referred to in Section 81 of the Manchester Act, and the Rural Sanitary Authority of the said Wigan Union are desirous of obtaining a supply of water, in bulk, for use in that contributory place by means of the water mains that have been laid by the Local Board;

And whereas the Manchester Corporation have, at the request of the Rural Sanitary Authority of the said Wigan Union, consented to the Liverpool Corporation furnishing the Local Board with such a supply of water as aforesaid for use in the said contributory place of Shevington:

Now therefore, We, the Local Government Board, in pursuance of the powers given to Us by Section 303 of the Public Health Act, 1875, and by any other 38 & 39 Vict. Statutes in that behalf, do hereby Order that, from and after the date of the c. 55, Act of Parliament confirming this Order, the Liverpool Act shall be altered so that the following provisions shall take effect; viz.,-

Art. I. Notwithstanding anything contained in the Liverpool Act to the contrary, the Liverpool Corporation may supply water, by agreement, in bulk to the Local Board in such quantity as may be necessary to enable the Local Board to furnish water to the Rural Sanitary Authority of the said Wigan Union. by agreement, in such quantity as will be sufficient to furnish an adequate supply of water for domestic or other purposes in the said contributory place of Shevington.

Art. II. Subject to the second proviso to Section 11 of the Liverpool Act any agreement between the Liverpool Corporation and the Local Board for the purposes of this Order shall be on such terms and conditions in all respects, and for such period, as the Liverpool Corporation and the Local Board may from time to time, with the approval of the Local Government Board, agree.

Art. III. The Liverpool Corporation shall carry all moneys received by them under any agreement made under this Order to the credit of the Liverpool Water Account.

Art. IV. Nothing herein contained shall prejudice the right of the Manchester Corporation to supply water within the said contributory place of Shevington, if and so far as may be hereafter agreed between them and the Local Authority for the time being of such contributory place.
