

## CHAPTER civ.

An Act to confirm certain Provisional Orders of the Local A.D. 1896. Government Board relating to the Bromley and Beckenham Calverley Dewsbury North Bierley Pontefract Rochester-and-Chatham Tamworth Thornton Warwick and Wirral Joint Hospital Districts. [20th July 1896.]

WHEREAS the Local Government Board have made the Provisional Orders set forth in the schedule hereto under the provisions of the Public Health Act 1875:

And whereas it is requisite that the said Orders should be confirmed by Parliament:

Be it therefore enacted by the Queen's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—-

1. The Orders as altered and set out in the schedule hereto shall Orders in schedule be and the same are hereby confirmed and all the provisions thereof confirmed. shall have full validity and force.

2. This Act may be cited as the Local Government Board's Short title. Provisional Orders Confirmation (No. 9) Act 1896.

Act 1881 (which Order and Act are herein-after respectively referred to as "the Order" and "the Confirming Act") the several Urban Districts of Bromley and Beckenham and the Rural District of Bromley (such Urban and Rural Districts being herein-after referred to as "the Constituent Districts") constitute a United District called the Bromley and Beckenham Joint Hospital District (herein-after referred to as "the United District") of which the governing body is the Bromley and Beckenham Joint Hospital Board (herein-after referred to as "the Joint Board");

And whereas by virtue of the Order the Joint Board now consists of three exofficio and six elective members elected by the several district councils mentioned in column 2 of the Schedules hereto (herein-after referred to as "the Constituent Authorities");

And whereas it is expedient to make the alterations in the Order herein-after provided for:
