An Act to confirm certain Provisional Orders of the Local A.D. 1896.

Government Board relating to the Brighouse Fulstoneand-Hepworth Hanley-Stoke-and-Fenton Hertford-andWare Isle-of-Thanet Sittingbourne-and-Milton Stone
Stroud and Wallsend-and-Willington-Quay Joint
Hospital Districts. [21st May 1896.]

WHEREAS the Local Government Board have made the Provisional Orders set forth in the schedule hereto under the provisions of the Public Health Act 1875:

If at any time any new district is formed including the whole or any part of any of the Constituent Districts or the boundaries of any of the Constituent Districts are otherwise altered or the whole of any of the Constituent Districts is created or included in a municipal borough or any repeal or alteration is made in the law affecting the United District or the Joint Board or any of the Constituent Districts or Authorities in matters touching their relation to the United District or the Joint Board then and in every such case the Local Government Board may by Order to be published as they shall direct make such provision as to them seems fit for adapting the provisions of the Order as altered by the adapting Order or of this Order to the alteration so made and to the incidents and consequences thereof and every such Order shall have effect as if the terms thereof were inserted in this Order.

Provisional Order for altering a Confirming Act.

To the Wallsend Willington Quay and Howdon Joint Hospital Board; -To the Urban District Council of Wallsend; --

To the Urban District Council of Willington Quay; —

And to all others whom it may concern.

WHEREAS by virtue of a Provisional Order of the Local Government Board dated the Twelfth day of May One thousand eight hundred and ninety-two and confirmed by the Local Government Board's Provisional Orders Confirmation 55 & 56 Vict. (No. 7) Act 1892 (which Order and Act are herein-after respectively referred to c. exeviii. as "the Order" and "the Confirming Act") and of the County of Northumberland (Wallsend) Confirmation Order 1894 (being an Order made by the Local Government Board confirming an Order of the County Council of Northumberland for uniting the Urban District of Howdon to the Urban District of Willington Quay) the Urban Districts of Wallsend and Willington Quay (such Districts being herein-after referred to as "the Constituent Districts") constitute a United District called the Wallsend Willington Quay and Howdon Joint Hospital District (herein-after referred to as "the United District") of which the governing body is the Wallsend Willington Quay and Howdon Joint Hospital. Board (herein-after referred to as "the Joint Board");

And whereas the Joint Board now consists of two ex-officio members and of nine elective members five of the latter being elected by the Urban District Council of Wallsend and four by the Urban District Council of Willington Quay (which two District Councils are herein-after referred to as "the Constituent Quay Order. Authorities");

> And whereas it is expedient to make the alterations in the Order herein-after provided for:

Now therefore We the Local Government Board in pursuance of the powers given to Us by Section 297 of the Public Health Act 1875 and by any other Statutes in that behalf do hereby order that from and after the date of the Act of Parliament confirming this Order the Confirming Act so far as it relates to the Order shall be altered as follows:--

- Art. I. The name of the United District shall be altered to the Wallsend and Willington Quay Joint Hospital District and the name of the Joint Board shall be altered to the Wallsend and Willington Quay Joint Hospital Board.
- Art. II.—(1.) Article II. of the Order shall be altered by the substitution of the words "two ex-officio and ten elective members" for the words "three ex-officio and nine elective members."
- (2.) The Urban District Council of Wallsend shall elect from among its own members an additional representative on the Joint Board and the provisions of Article IX. of the Order as hereby altered shall apply as if such election related to the filling of a casual vacancy occurring on the day of the date of the Act of Parliament confirming this Order.
- Art. III. The following provision shall be substituted for Article V. of the Order viz.:-

- "Art. V. Such of the provisions of Section 46 of the Local Government "Act 1894 as relate to members of councils of districts other than "boroughs shall mutatis mutandis apply to members of the Joint " Board."
- Art. IV. Article IX. of the Order shall be altered by the omission of the words "by Order" and by the substitution for the words "name and address" of the words "names address and occupation."
- Art. V. Article X. of the Order shall be altered by the addition thereto of the ollowing provision:---
 - "The Joint Board may from time to time appoint committees consisting of "members of the Joint Board for the exercise of any powers which in
 - "the opinion of the Joint Board can be properly exercised by committees
 - " but the acts of every such committee shall unless otherwise directed by
 - "the Joint Board be submitted to the Joint Board for approval Provided
 - "that a committee so appointed shall in no case be authorised to borrow
 - "money or to issue any precept for contributions or to enter into any " contract and it shall be subject to the provisions of Part IV. of the

 - "First Schedule to the Local Government Act 1894 so far as they are " applicable,"

- (b) By the insertion in lieu of the words and figures "Sections 258 to 267 both inclusive" of the words and figures "Sections 258 to 263 and 265 to 267 all inclusive"; and
- (c) By the insertion before the words and figures "Sections 306 to 309" of the words and figures "Section 298 as to costs of Provisional Orders."

Art. VII. Article XV. of the Order shall be altered by the omission of the words "and in each of the wards of the hospital or hospitals."

Art. VIII. The Schedule A hereto shall be substituted for the Schedule A to the Order.

Art. IX. The Joint Board shall for the purpose of the sections of the Public Health Act 1875 with regard to the "Prevention of epidemic diseases" be a local authority so as to enable the Local Government Board by any regulations under those sections to confer powers and to impose duties on the Joint Board and so far as regards any powers so conferred and any duties so imposed but nothing, in this Order contained shall prevent the Local Government Board from imposing any duties by any regulations under the said sections on the Constituent Authorities or any of them or affect the powers of such authorities so far as the same may be required to be exercised in pursuance of such regulations.

Art. X. If at any time any new district is formed including the whole or any part of either of the Constituent Districts or the boundaries of either of the Constituent Districts are otherwise altered or the whole of either of the Constituent Districts is created or included in a municipal borough or any repeal or alteration is made in the law affecting the United District or the Joint Board or either of the Constituent Districts or Authorities in matters touching their relation to the United District or the Joint Board then and in every such case the Local Government Board may by Order to be published as they shall direct make such provision as to them seems fit for adapting the provisions of the Order or of this Order to the alteration so made and to the incidents and consequences thereof and every such Order shall have effect as if the terms thereof were inserted in this Order.

Art. XI. The Order of 1892 may be cited as the Wallsend and Willington. Quay Joint Hospital Order 1892 this Order may be cited as the Wallsend and Willington Quay Joint Hospital Order 1896 and the Order and this Order may be cited together as the Wallsend and Willington Quay Joint Hospital Orders 1892 and 1896.
