

CHAPTER xci.

An Act to confirm a Provisional Order made by the Local A.D. 1896.

Government Board for Ireland under the Public Health
(Ireland) Act 1878 relating to the Rural Sanitary District of the Sligo Union.

[2nd July 1896.]

WHEREAS the Local Government Board for Ireland have made the Provisional Order set forth in the schedule hereto under the provisions of the Public Health (Ireland) Act 1878:

And whereas it is requisite that the said Order should be confirmed c. 52. by Parliament:

Be it therefore enacted by the Queen's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

- 1. The Order set out in the schedule hereto is hereby confirmed Order and all the provisions thereof shall have full validity and force.

SLIGO UNION-CARROWNANTY BURIAL GROUND.

PROVISIONAL ORDER.

WHEREAS the Guardians of the Poor of the Sligo Union (herein-after called the Burial Board) are the Burial Board of the rural sanitary district consisting of the said union (except the town of Sligo) and have determined at a special meeting convened in pursuance of the Public Health (Ireland) Act 1878 that a new burial ground shall be provided for the said district near the town of Ballymote and have presented a petition to the Local Government Board for Ireland (herein-after called the Local Government Board) praying that they may be empowered to put in force the powers of the Lands Clauses Acts with respect to the purchase and taking of lands otherwise than by agreement with reference to certain lands and premises required for the said new burial ground:

And whereas the owners lessees and occupiers of all dwelling-houses nearer than one hundred yards to the proposed new burial ground have consented in writing to the appropriation of the said lands and premises as a burial ground:

And whereas the burial board have deposited at the office of the Local Government Board in Dublin plans and a book of reference (herein-after called the deposited plans and book of reference) showing the said lands and premises and all notices and advertisements required by the Public Health (Ireland) Act 1878 having been previously published served and given the Local Government Board have caused a local inquiry to be made as to the propriety of assenting to the prayer of the said petition and it appears to be proper to assent thereto:

It is ordered by the Local Government Board as follows:—

Compulsory powers to take lands.

1. From and after the confirmation of this Order by Parliament the burial board shall be empowered to put in force the powers of the Lands Clauses Acts with respect to the purchase and taking of land otherwise than by agreement with reference to the part of the townland of Carrownanty in the parish of Emlaghfad and county Sligo containing about two acres statute measure and shown in the deposited plans and book of reference.

Provision as to dwellinghouses. 2. No part of the said new burial ground shall be made within three hundred yards of any house of the annual value of fifty pounds or of any garden or pleasure ground occupied therewith except with the consent in writing of the owner lessee and occupier thereof.

3. The powers of compulsory purchase given by this Order shall not be exercised after the expiration of three years from the confirmation of this order.

Sligo. **Duration** of compulsory powers.

4. All costs charges and expenses of and incidental to the application for Costs of Order. obtaining and confirming this Order shall be paid by the burial board in the manner provided by section 234 of the Public Health (Ireland) Act 1878.

5. This Order may be cited and referred to for all purposes as the Carrownanty Burial Ground Provisional Order 1896.
