CHAPTER ccxiv.

An Act to confirm certain Provisional Orders of the A.D. 1898. Secretary of State under the Military Lands Act 1892. [12th August 1898.]

TATHEREAS the Secretary of State has made the Provisional Orders set out in the schedule to this Act under the provisions of the Military Lands Act 1892 and it is requisite that 55 & 56 Viet. those Orders should be confirmed by Parliament:

c. 43.

Be it therefore enacted by the Queen's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:---

1.—(1.) The Orders set out in the schedule to this Act are by this Confirmation Act confirmed and all the provisions thereof shall have full validity of Orders in and force from the date of the passing of this Act.

- (2.) The powers for the compulsory purchase of land under the said orders may be exercised within a period of three years after the date of the passing of this Act but shall cease after the expiration of that period.
- 2. This Act may be cited as the Military Lands Provisional Short title. Orders Confirmation (No. 2) Act 1898.

SCHEDULE.

I.—WOKING BARRACKS.

A Provisional Order made in pursuance of Section Two of the Military Lands Act 1892 authorising the taking of certain lands for the purpose of the building and enlarging of Barracks at or near Woking in the County of Surrey.

55 & 56 Viet. c. 43. Whereas by section two of the Military Lands Act 1892 the Secretary of State is empowered to make Provisional Orders authorising the taking of land for the military purposes defined in that Act:

And whereas under section twenty-three of the Military Lands Act 1892 the term "military purposes" is defined to include the building and enlarging of barracks:

And whereas it is expedient for the military purposes aforesaid that the Secretary of State should be empowered to purchase under the Military Lands Act 1892 the lands described in this Order:

And whereas a plan showing the lands to be purchased has been signed by the Secretary of State and has been deposited with the clerk of the County Council of Surrey:

And whereas the Secretary of State has with reference to the purchase of the said lands caused such notices to be served and such local inquiry to be held as are required by the provisions of the Military Lands Act 1892 and after that inquiry he is satisfied that the lands should be taken:

Now therefore I the Secretary of State in pursuance of the powers given to me by section two of the Military Lands Act 1892 and any other enactment in that behalf do hereby order that from and after the date of the Act of Parliament confirming this Order the following provisions shall take effect:—

Power to purchase lands and rights under the Military Lands Act 1892.

- 1. The Secretary of State may for the military purposes aforesaid purchase under section two of the Military Lands Act 1892 and the Acts incorporated therewith the lands situated in the parish of Woking in the county of Surrey which are more particularly delineated on the plan signed by the Secretary of State and deposited as aforesaid and are thereon coloured yellow and contain seven acres one rood and two perches or thereabouts.
 - 2. This Order may be cited as the Woking Barracks Order 1898.
