



CHAPTER lxxvi.

An Act to confirm a Provisional Order made by one of Her Majesty's Principal Secretaries of State under the Metropolitan Police Act 1886 and the Metropolitan Police Courts Act 1897. A.D. 1898.
[25th July 1898.]

WHEREAS the Right Honourable Sir Matthew White Ridley Baronet one of Her Majesty's Principal Secretaries of State has made the Provisional Order set out in the schedule hereunto annexed under the Metropolitan Police Act 1886 and the Metropolitan Police Courts Act 1897 : 49 & 50 Vict.
c. 22.

And whereas it is requisite that the said Order should be confirmed by Parliament : 60 & 61 Vict.
c. 26.

Be it therefore enacted by the Queen's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows :—

1. The Order as set out in the schedule hereunto annexed is hereby confirmed. Order in

2. If and so soon as Mark Bromet shall have cleared of buildings the site in Shepherdess Walk City Road described in the Second Schedule to this Act and shall have given notice thereof to the Receiver for the Metropolitan Police District the said Receiver shall within two months of the receipt of such notice serve upon the said Mark Bromet and the Governors of the Bishopsgate Foundation a notice to treat for such land as he may require or failing such service within the said two months shall be deemed to have abandoned the powers over the said land contained in this Act. 3. This Act may be cited as the Metropolitan Police Provisional Order Confirmation Act 1898. Short title.

SCHEDULE.

Order made by the Secretary of State under the Metropolitan Police Act 1886 and Metropolitan Police Courts Act 1897.

To the Receiver for the Metropolitan Police District and all whom it may concern.

WHEREAS power is given to me by the Metropolitan Police Act 1886 on the petition of the Receiver for the Metropolitan Police District to make an order authorising him to put in force with reference to land required for police stations offices and buildings the powers of the Lands Clauses Acts with respect to the purchase and taking of land otherwise than by agreement :

And whereas by section 4 of the Metropolitan Police Courts Act 1897 similar powers are conferred with respect to land and buildings required for the purposes of the Metropolitan Police Courts :

And whereas as required by section 4 sub-section 3 of the said Metropolitan Police Act the Receiver has presented to me a petition describing certain lands which he proposes to purchase viz. the lands described in the schedule hereunto annexed and stating the purposes for which such lands are required and stating also the names (as inserted in the said schedule) of the owners and lessees or reputed owners and lessees and occupiers of the said lands and whether such owners lessees and occupiers (other than the Receiver) have respectively assented dissented or are neuter in respect of the taking of the said lands and praying for an order authorising him with reference to the said lands to put in force the powers of the Lands Clauses Acts with respect to the purchase and taking of land otherwise than by agreement :

And whereas I have considered such petition and the proof submitted to me of the publication of the proper advertisements and of the service of the proper notices required by section 4 sub-section 2 of the said Act :

I hereby in pursuance of the power conferred on me by the said Act do authorise the said Receiver to put in force with reference to the said lands viz. the lands described in the schedule hereto annexed the powers of the Lands Clauses Acts with respect to the purchase and taking of land otherwise than by agreement.
