An Act for more effectually keeping in repair several Roads in the County of Carmarthen, usually called the Llandovery District of the Lampeter Roads, and for making and maintaining certain new Lines of Road to communicate therewith.

[22d April 1831.]

THEREAS an Act was passed in the Twenty-eighth Year of the Reign of His late Majesty King Country tuled An Act for amending, widening, and keeping in repair 28G. 3.c. 109. the Road from Carmarthen to Lampeter Pont Stephen in the County of Cardigan, and from Llandovery in the County of Carmarthen to Lampeter Pont Stephen aforesaid: And whereas by the said recited Act the Road from Llandovery to Lampeter Pont Stephen is made a separate District, called "The Llandovery District," and placed under the Care of separate and distinct Trustees from the other Roads comprised in the said Act: And whereas an Act was passed in the Forty-ninth Year of the Reign of His said Majesty King George the Third, intituled An Act for enlarging the Term and Powers of an Act 49G.3.c.15. of His present Majesty, for repairing several Roads in the Counties of Carmarthen and Cardigan, so far as relates to the Llandovery District, and for amending certain other Roads communicating therewith: And whereas the Trustees appointed in and by virtue of the said Two recited Acts have made great Progress in the Execution thereof, and have for that Purpose borrowed considerable Sums upon the Credit 11 R $\lceil Local. \rceil$

of the respective Tolks thereby granted, which still remain due and cannot be paid off, nor can the said Roads be effectually amended, diverted, widened, improved, and kept in repair, unless the Term of the said Two recited Acts be further continued, the Tolls altered, varied, and increased, and some of the Powers thereof altered, amended, and enlarged: And whereas it would be of Benefit and Advantage to the Counties of Glamorgan, Brecon, Carmarthen, and Cardigan, and of great Convenience and Utility to the Public in general, if Power were given to make and maintain the new Lines of Road and Deviations herein-after described, and to erect and build a Bridge over the River Towy in the Situation and in the Manner herein-after mentioned: May it therefore please Your Majesty that it may be enacted; and be it enacted by the King's most Excellent Majesty, by and with the Advice and Consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the Authority of the same, That from and after the passing of this Act the said recited Acts shall be and the same are hereby repealed, except as hereafter provided.

Recited Acts repealed.

This Act to take effect for the Purposes herein mentioned.

II. And be it further enacted, That from and after the said passing of this Act the same shall commence and take effect and be put into execution for and during the Term herein-after mentioned, as well for the Purpose of more effectually amending, widening, altering, improving, and keeping in repair the Roads following; (that is to say,) the present Turnpike Road leading from the Town of Llandovery in the County of Carmarthen, over Dokhirion Bridge, to and as far as the Bridge over the River Tivy, called Lampeter Pont Stephen Bridge, and extending to and through the several Parishes of Llandingat, Cilycwm, Llanwrda, Conwil Gayo, Llansawel, Llanycrwys, and Pencarreg in the County of Carmarthen (save and except as herein-after mentioned); and also the present Turnpike Road leading from the present Turnpike Gate near Dolehtrion, by or near Nantdu and Nantymeyn, to Penygareg in the Parish of Llanfairarybrin in the said County of Carmarthen, and from Penygarreg aforesaid, through Cwmgwenffrwd, by or near Bwlch y rhiw and Garthynty, to or near Glancothy otherwise Blaencothy on the Confines of the Parish of Llanddewybrevy, in the County of Cardigan, and from or near Glancothy otherwise Blaencothy aforesaid, through the said Parish of Llanddewybrevy, to meet the High Road leading from Lampeter Pont Stephen aforesaid in the said County of Cardigan to the Town of Tregaron in the County of Cardigan aforesaid at or near the Village of Lland dewybrefy, and which said last-mentioned Line of Road extends to and through the several Parishes of Llandingat, Llanfairarybrin, Cilycwm, and Conwil Gayo in the County of Carmarthen, and the Parish of Llanddewybrevy in the County of Cardigan; and from the Place where the Finger Post stood on Bwlchcefensarth, or near thereto, in the Parish of Conwilgayo in the said County of Carmarthen, through the Village of Llansawell, to Llanybydder Bridge in the Parish of Llany bydder in the County of Carmarthen aforesaid (except as hereinafter mentioned), and which said last-mentioned Line of Road extends to and through the several Parishes of Conwil Gayo, Llansawell, Pencarreg, and Llanybydder in the County of Carmarthen aforesaid; and also

also to enable the Trustees of the said Road to make, complete, divert, and maintain certain new Lines, Branches, and Diversions of Roads to communicate with some of the Roads contained in the said Two recited Acts; (that is to say,) a new Line or Branch of Road from the Town of Llandovery, by a certain Farm called Cerrig, or by certain Lands of John Josiah Holford Esquire and James Price Holford Esquire, or One of them, David Jones Esquire, David Rice Rees and David Rees Gentlemen, lying between the said Town of Llandovery and the River Towy, and across the said River Towy by a Suspension Bridge which the said Trustees are hereby authorized to erect and build below a Pool in the said River, called Pwllywarren, and not lower down than Two Furlongs and Three Chains from the present wooden Foot Bridge across the said River Towy, through the Lands of Edward Jones Esquire and David Jones Banker, both or one of them, to the High Road leading from the Town of Llandilofawr in the said County to the Town of Llandovery aforesaid, and on the North-west Side of the said River Towy, through the Lands called Llwynhowel, Blaenos, Nantyrhog fan, and Ystrad, as far as the Finger Post near Llwyn Jack Ford on the said River Towy, and which said last-mentioned new Line of Road will extend through the Parish of Llanding at in the County of Carmarthen aforesaid; and also another new Line, Branch, or Diversion of Road from the Northern End of Erryd Bridge, and from thence by, through, and along certain Farms and Lands called Erryd, Aberdunant, Gilwen, Penygroes, Glandunant, Penybank isaf Cwmdynant, Penybank Uchaf, Caewgan, Pentrecwm, and Porthyrhyd Uchaf, and to the old Llandovery and Lampeter Turnpike Road at or near a Place called Porthyrhyd, and by and from Porthyrhyd, by or through certain Lands called Brynbietin, Poli, Maestwynog, and Pencilmaren, to or near the Tile Quarry at Bwlch Cefensarth, and from or near the Tile Quarry on the old Line of Turnpike Road near Bwlch Cefensarth, over certain Farms and Lands called Cwmbachstel, Goleugoedganol, Goleugoed Uchaf, Goleugoed isaf, Castell y gwint, Felin Newydd, Ynysau isaf, and Ynysau Ganol, to or near to Ynysau Toll Gate, and which said last-mentioned intended new Lines of Road are situate in the Parishes of Llanwrda, Cilycwm, and Conwilgayo in the said County of Carmarthen; and also to alter and divert Part of the said old Turnpike Road near the Meeting House near Twrch Bridge, by or through certain Lands called Bryneglwys, Penpontpren, and Brynmayog, and situate in the Parish of Conwilgaio in the said County of Carmarthen; and also to enable the said Trustees to divert, make, complete, and maintain a new Line of Road from the present Turnpike Road from the Town of Llandovery to the Town of Lampeter Pont Stephen, at or near to a Place on the Eastern Side of Lampeter Mountain called Aberdauddwr, through certain Farms and Lands called Caegwyn and Derlwyn, over Part of Lampeter Mountain called Bwlchymynydd, to and over certain Farms called Tyhowel, Tyrgwylym, Gellywrol, Coediddig, Talyfol, Lacks, Tynyrhoes, and Tynyrheol, to communicate with the said Turnpike Road leading from the Town of Llandovery to Lampeter Pont Stephen Bridge aforesaid at or near to a Tenement called New York, and which said last-mentioned new Line of Road is situate in the Parishes of Llanycrwys and Pencarreg in the said County of Carmarthen; and also another new Line of Road from a certain Tile Quarry

Quarry on or near the said Place called Bwlch Cefensarth, over certain Open Grounds or Commons thereto adjoining, and over certain Farms and Lands called Llaethigau, Cwmbachstel, and about Three hundred Yards on the Llansawel Road beyond New Inn Fach, and which said last-mentioned Line of Road will extend through the Parish of Conwilgayo in the said County of Carmarthen; and also another new Line or Branch of Road from the Llansawel Branch of the present Turnpike Road from Caemalwas Gate, and over Llanybydder Mountain, through Llwyd-coed Farm, to a Place called Capel Iago, and which said last-mentioned Diversion or new Line of Road is situate in the Parish of Llanybydder in the said County of Carmarthen.

After the Roads herein-before mentioned are completed, certain Roads to be abandoned.

III. And be it further enacted, That when and so soon as the making and finishing of the several herein-before mentioned new Roads and Diversions of the Line of Road from the Northern End of Erryd Bridge to or near to Porthyrhyd aforesaid, and from or near to Porthyrhyd to the Tile Quarry near Bwlchcefensarth, and thence to the Ynysau Toll Gate aforesaid, and from or near the North-west End of Twrch Bridge to or near the Meeting House, and from Aberd-dauddwr to or near to New York aforesaid, and also from Bwlchcefensarth to about Three hundred Yards on the Llansawell Road beyond New Inn Fach aforesaid, and also from or near to Capel Iago aforesaid to the said Common Gate called Caemalwas Gate, and the said new Roads respectively shall be by Five of the said Trustees and Two of His Majesty's Justices of the Peace for the said County of Carmarthen certified to be properly made and finished and completed, such of them as shall be so certified to be properly made, finished, and completed as aforesaid shall from thenceforth be considered as forming a Part of the Roads to be repaired or liable to be repaired by the said Trustees and comprised in this present Act; and the said Trustees shall from and after the making and finishing as aforesaid of the said new Lines of Road respectively, during the Continuance of this Act, be discharged and released from the Care, Repairs, and Management of such Parts of the old Road as lie between the Third Mile Stone near New Inn and Berrisbrook, near Porthyrhyd, between Porthyrhyd and Bwlchcefensarth, and between the Finger Post at Bwlchcefensarth and the Ynysau Toll Gate, between the North End of Twrchbridge and near the Meeting House aforesaid, between Aberdauddwr and New York aforesaid, between Bwlchcefensarth and New Inn Fach, and about Three hundred Yards on the Llansawell Road, and between Capel Iago and Caemalwas Gate afore said, or from such Parts thereof respectively as the new Line corresponding therewith shall be so made and certified as aforesaid.

Power to appoint additional Trustees.

V. And be it further enacted, That it shall and may be lawful for the said Trustees and they are hereby authorized, at any of their Meetings to be holden for that Purpose, to elect, nominate, and appoint any additional Number of Trustees, not exceeding Three in the whole; and such Trustees so elected and appointed, being duly qualified as aforesaid, shall be Trustees for the Purposes of this Act, and shall have the same Powers and Authorities for executing the same as if they had been herein named and appointed.

First Meeting of Trustees.

VI. And be it further enacted, That the said Trustees shall hold their First Meeting at the Magistrates Room in the Town of Llandovery in the County of Carmarthen, or at some other convenient House or Place in the Town of Llandovery aforesaid, on the First Wednesday in the Month next after the passing of this Act, or as soon as conveniently may be after that Day, and shall proceed to carry this Act into execution.

Maps and Books of Reference to remain the Peace, and be open to Inspection.

VII. And whereas several Maps or Plans describing the Lines of the said Roads and Bridge, and the Lands, Hereditaments, and Premises through or over which the same are to be made or carried, with Clerk of together with Books of Reference containing a List of the Names of the Owners and Occupiers of such Lands, Hereditaments, and Premises, have been deposited in the Office of the Clerk of the Peace for the said County of Carmarthen; be it therefore further enacted, That the said several Maps or Plans and Books of Reference shall remain in the Custody of the said Clerk of the Peace for the said County of Carmarthen, to the end that all Persons may, at seasonable Times, have Liberty to inspect and peruse the same, and to take Copies or Extraots thereof, at their Will and Pleasure, paying the said Clerk of the Peace the Sum of One Shilling for every such Inspection, and

at the Rate of Sixpence for every One hundred Words of such Copies or Extracts of such Maps or Plans and Books of Reference; and Not to dethe said Trustees in making the said Roads shall not deviate more viate more than One hundred Yards from the Lines described in the said Maps than One or Plans, without the Consent in Writing of the Person or Persons, Wards. Bodies Politic, Corporate, or Collegiate, through whose Lands or Grounds such Deviation shall be made.

VIII. And be it further enacted, That it shall be lawful for the Misnomers said Trustees to make the said Roads and Bridge into, through, not to preacross, or over the several Lands, Hereditaments, and Premises of ecution of any Person or Persons who is or are or may be Owner or Owners of the Act. Lands or Premises over which the same is or are set out and described in the said Maps or Plans as aforesaid, although such Lands and Premises, or the Name or Names of such Person or Persons, may happen to be omitted or mis-stated in the said Books of Reference, in case it shall appear to any Two or more Justices of the Peace for the said County of Carmarthen, and be certified by Writing under their Hands, that such Error or Omission proceeded from Mistake.

IX. Provided always, and be it further enacted, That the Powers Trustees not and Authorities hereby given shall not extend or be construed to extend to authorize or empower the said Trustees, in making the said Houses, &c. Roads or Bridge, to take or pull down, injure or damage, any Dwelling House or other Building, or to take in or make use of any the Owners Orchard, Garden, Yard, Park, Paddock, Lawn, Shrubbery, Plantation, (except those planted Walk, or Avenue to a House, or any inclosed Ground set in the Scheapart as a Nursery for Trees, or any Part thereof respectively, (save dule). and except as particularized in the Schedule hereunto annexed,) without the Consent in Writing of the Owner thereof or other Person interested therein first had and obtained.

X. And be it further enacted, That if the said Trustees shall not If Property within the Space of Three Years, to be computed from the passing not purof this Act, agree for or cause to be valued and paid for, as herein- chased within Three Years, after mentioned, the several Buildings, Lands, Tenements, and Here-Powers of ditaments specified in the Schedule to this Act annexed, which they purchasing are hereby empowered to purchase as aforesaid, or so much thereof to cease. as they shall deem necessary or proper for the Purposes of this Act, then and from thenceforth all the Powers which are hereby granted to them for such Purposes only shall cease and be utterly void (save and except with the Consent in Writing of the Owners and Occupiers thereof respectively).

XI. And be it further enacted, That the several existing Tolls Present Tolls heretofore payable on the said Roads by virtue of the said recited to continue Acts shall continue to be demanded, collected, and received until until First the First Day of November One thousand eight hundred and thirty- vember next. one, and shall then cease, determine, and be no longer payable; and that instead thereof, from the said First Day of November, it shall be lawful for the said Trustees, or for their Collectors or Lessees of Tolls, to demand and take at each Toll Gate or Side Gate, Chain or Bar, which now is or hereafter shall be standing upon, across, or at the Side

Side of the several Roads included in this Act, on every Day, (such Day to be computed from Twelve of the Clock at Night till Twelve of the Clock the next succeeding Night,) from the Owner or Owners of or Person or Persons using or attending any Horse, Beast, Cattle, or Carriage, before any such Horse, Beast, Cattle, or Carriage of any Description shall be permitted to pass through the same, the Tolks following; (that is to say,)

Tolls.

For every Horse or other Beast of Draught drawing any Coach, Stage Coach, Diligence, Berlin, Landau, Sociable, Chariot, Curricle, Calash, Hearse, Chaise, Phaeton, Whiskey, or Chair, or any other such Carriage of any Name or Description whatsoever, the Sum of Sixpence:

For every Horse or other Beast of Draught drawing any Waggon, Wain Cart, or Caravan, or other such Carriage of any other Description whatsoever, having the Fellies of the Wheels Six Inches broad or upwards, the Sum of Four-pence Halfpenny:

For every Horse or other Beast of Draught drawing any such Waggon, Wain, Cart, or Caravan, or other such Carriage, having the Fellies of the Wheels of less Breadth than Six Inches and not less than Four and a Half Inches, the Sum of Five-pence Halfpenny:

For every Horse or other Beast of Draught drawing any Waggon, Wain, Cart, or other Carriage, having the Fellies of the Wheels of less Breadth than Four and a Half Inches, the Sum of Sixpence: Provided always, that all such of the before-mentioned Carriages as shall be solely drawn by Oxen shall pay One Third less than the said before-mentioned Tolls:

For every Horse or Mule, laden or unladen, and not drawing, the Sum of One Penny Halfpenny:

For every Horse, Mule, or Ass drawing any Sledge, or any other such Carriage allowed by Law, the Sum of Two-pence:

For every Drove of Oxen, Cows, or Neat Cattle, per Score, the Sum of One Shilling and Eight-pence, and so in proportion for any greater or less Number:

For every Drove of Calves, Swine, Sheep, or Lambs, per Score, the Sum of Ten-pence, and so in proportion for any greater or less Number.

Double Tolls for not having a Roller affixed.

XII. And be it further enacted, That from and after the First Day of May One thousand eight hundred and thirty one there shall be charged and paid Double the aforesaid Tolls for every Horse or other Beast drawing any Waggon, Wain, Cart, or other such Carriage which shall not have attached to some conspicuous Part of the Outside of such Carriage a Roller annexed and appendant thereto in the proper and usual Manner, at the Time of passing through every Turnpike Gate, Toll Gate, or Side Bar on any Part of the said Roads, for the Purpose of blocking or stopping such Carriage while resting.

Tolls on Steam Carriages.

XIII. And be it further enacted, That for every Coach, Waggon, Steam Engine, or other Carriage which shall pass by, along, or across

any of the said Roads, and shall be in any Manner propelled or drawn by Steam, Gas, or any other like Means, and for every Waggon or Carriage attached thereto, of any Description whatsoever, the same Tolls shall be paid as would have been payable for every such Steam Engine or Carriage as aforesaid if drawn by Four Horses; and the said Tolls shall be paid for every such Coach, Waggon, Steam Engine, or other Carriage, for each Time of passing along the said Roads.

XIV. And be it further enacted, That in case Toll shall have been Tolls to be paid for or in respect of any Horse, Beast, or Cattle passing through paid but once any of the Turnpikes, Toll Gates, or Side Bars now erected or hereafter to be erected and continued by virtue of this Act, no Toll shall be demanded or taken for or in respect of the same Horse, Beast, or Cattle for returning, passing, or repassing through the same Turnpike, Toll Gate, or Side Bar on the same Day before Twelve of the Clock at Night, and upon a Note or Ticket denoting the Payment of the Toll being produced, such Horse, Beast, or Cattle shall (except in the Cases herein-after mentioned) be permitted to pass through such Turnpike, Toll Gate, or Side Bar Toll-free.

XV. XVIII. And be it further enacted, That the Tolls hereby made payable shall be paid for and in respect of all. Horses or Beasts of Draught let out to Hire, and drawing any Post Chaise or other Carriage, every Time of passing along the said Roads, or any of them, as often as any new Hiring thereof shall take place.

No Priority of Mortgage.

XIX.
