3 Control of spread of pests in Great Britain. E+W+S

- (1) A competent authority may from time to time make such orders as the authority thinks expedient [F7 or called for by any [F4EU] obligation] for preventing the spread of pests in Great Britain [F8 or the conveyance of pests by articles exported from Great Britain].
