(2) [F2. . . F3 section 33 of the MICourts Martial (Appeals) Act 1968] (payment out of moneys provided by Parliament of expenses of witnesses in connection with appeals to the Courts-Martial Appeal Court). . . ^{F4}shall apply in relation to a registered medical practitioner making a written report to a court in pursuance of a request to which this subsection applies as [F5it applies] in relation to a person called to give evidence at the instance of the court.... (3) The last foregoing subsection applies to a reguest to a registered medical practitioner to make a written or oral report on the medical condition of an offender or defendant, being a request made by a court for the purpose of determining whether or not to make an order under [F6 section 3 of the M2 Powers of Criminal Courts Act 1973] (probation orders requiring treatment for mental condition) or section 60 of the M3 Mental Health Act 1959 (hospital orders and guardianship orders) or otherwise for the purpose of determining the most suitable method of dealing with an offender; in exercise of the powers conferred by [F7 section 30 of the Magistrates' Courts Act 1980] (remand of a defendant for medical examination and requirement of such an examination on committing a defendant for trial on bail).
