**13 Payment of deferred annuities. U.K.**

All deferred annuities payable in respect of Scottish contributions to the deferred annuity fund established under the <sup>M1</sup>Elementary School Teachers (Superannuation) Act 1898 shall be paid by the Secretary of State; and any sums required by the Secretary of State for making payments under this section shall be charged on and issued out of the Consolidated Fund.
