#### PENSIONS OUT OF LOCAL FUNDS

##### *Probation and after-care service*

- 53 A pension payable in accordance with regulations under Schedule 4 to the <sup>M1</sup>Local Government Superannuation Act 1953 [<sup>F1</sup>or section 7 of the <sup>M2</sup>Superannuation Act 1972] in respect of service as a probation officer or as a person appointed to assist a probation officer in the performance of his duties by a probation and after-care committee, by the Secretary of State or, before 1st July 1944, by a probation officer.
