COMPENSATION FOR DEPRECIATION CAUSED BY USE OF PUBLIC WORKS

18 Interest on compensation.

- (1) Compensation under this Part of this Act shall carry interest, at the rate for the time being prescribed under section 32 of the ^{M1}Land Compensation Act 1961, from—
- (a) the date of service of the notice of claim; or
 - (b) if that date is before [^{F1}the first claim day], from [^{F1}the first claim day], until payment.
