



# Friendly Societies Act 1974

## 1974 CHAPTER 46

An Act to consolidate the Friendly Societies Acts 1896 to 1971 and certain other enactments relating to the societies to which those Acts apply with amendments to give effect to recommendations of the Law Commission and the Scottish Law Commission. [31st July 1974]
