

# Sex Discrimination Act 1975 (repealed)

## **1975 CHAPTER 65**

## PART I

## DISCRIMINATION TO WHICH ACT APPLIES

## [<sup>F1</sup>1 Direct and indirect discrimination against women

- (1) In any circumstances relevant for the purposes of any provision of this Act, other than a provision to which subsection (2) applies, a person discriminates against a woman if—
  - (a) on the ground of her sex he treats her less favourably than he treats or would treat a man, or
  - (b) he applies to her a requirement or condition which he applies or would apply equally to a man but—
    - (i) which is such that the proportion of women who can comply with it is considerably smaller than the proportion of men who can comply with it, and
    - (ii) which he cannot show to be justifiable irrespective of the sex of the person to whom it is applied, and
    - (iii) which is to her detriment because she cannot comply with it.
- (2) In any circumstances relevant for the purposes of a provision to which this subsection applies, a person discriminates against a woman if—
  - (a) on the ground of her sex, he treats her less favourably than he treats or would treat a man, or
  - [<sup>F2</sup>(b) he applies to her a provision, criterion or practice which he applies or would apply equally to a man, but—
    - (i) which puts or would put women at a particular disadvantage when compared with men,
    - (ii) which puts her at that disadvantage, and
    - (iii) which he cannot show to be a proportionate means of achieving a legitimate aim.]

(3) Subsection (2) applies to—

- (a) any provision of Part 2,
- [ sections 29 to 31, except in so far as they relate to an excluded matter,]  $F^{3}(aa)$ 
  - (b) sections 35A and 35B  $^{F4}$ , and
  - (c) any other provision of Part 3, so far as it applies to vocational training.
