5 Assistance to ^{F1}Assembly^{F1} from public authorities and other persons.

(1) The ^{F2}Assembly^{F2} may appoint a local authority, ^{F3}a National Park authority^{F3}, the development corporation of a new town or any other body or person to act as ^{F4}its^{F4} agent to carry out the ^{F5}Assembly's^{F5} functions mentioned in section 1(3)(a) ^{F6}, (da)^{F6} and (f) to (i) above ^{F7}or section 21C below^{F7}.

(2) For the purpose of assisting the ^{F2}Assembly^{F2} to carry out any of the functions referred to in subsection (1) above, a local authority, ^{F3}a National Park authority^{F3} or a development corporation, or any other body of a public nature, on being so requested by the ^{F9}Assembly^{F9}, may place the services of any of their staff at the ^{F5}Assembly's^{F5} disposal, on such terms as may be agreed with the ^{F2}Assembly^{F2}.
