THE ADOPTION SERVICE

The Adoption Service

1 **Establishment of Adoption Service.** **E+W**

- (1) It is the duty of every local authority to establish and maintain within their area a service designed to meet the needs, in relation to adoption, of—
- (a) children who have been or may be adopted,
 - (b) parents and guardians of such children, and
 - (c) persons who have adopted or may adopt a child,

and for that purpose to provide the requisite facilities, or secure that they are provided by [^{F1}appropriate voluntary organisations].

(2) The facilities to be provided as part of the service maintained under subsection (1) include—

- (a) temporary board and lodging where needed by pregnant women, mothers or children;
- (b) arrangements for assessing children and prospective adopters, and placing children for adoption;
- (c) counselling for persons with problems relating to adoption.

(3) The facilities of the service maintained under subsection (1) shall be provided in conjunction with the local authority's other social services and with [^{F2}appropriate voluntary organisations] in their area, so that help may be given in a co-ordinated manner without duplication, omission or avoidable delay.

^{F3}[(3A) In this Part, references to adoption are to the adoption of children, wherever they may be habitually resident, effected under the law of any country or territory, whether within or outside the British Islands.]

(4) The services maintained by local authorities under subsection (1) may be collectively referred to as “the Adoption Service”, and a local authority or [^{F4}appropriate voluntary organisation] may be referred to as an adoption agency.

[^{F5}(5) In this Act “appropriate voluntary organisation” means a voluntary organisation which is an adoption society in respect of which a person is registered under Part II of the Care Standards Act 2000.]

Welfare of children

6 Duty to promote welfare of child. E+W

In reaching any decision relating to the adoption of a child a court or adoption agency shall have regard to all the circumstances, first consideration being given to the need to safeguard and promote the welfare of the child throughout his childhood; and shall so far as practicable ascertain the wishes and feelings of the child regarding the decision and give due consideration to them, having regard to his age and understanding.

7 Religious upbringing of adopted child. E+W

An adoption agency shall in placing a child for adoption have regard (so far as is practicable) to any wishes of a child's parents and guardians as to the religious upbringing of the child.

8 Inactive or defunct adoption societies. E+W

- (1) If it appears to the Secretary of State that [^{F17}a body which is or has been an appropriate voluntary organisation], is inactive or defunct he may, in relation to any child who is or was in the care of the [^{F18}organisation], direct what appears to him to be the appropriate

11 **Restriction on arranging adoptions and placing of children.** **E+W**

- (1) A person other than an adoption agency shall not make arrangements for the adoption of a child, or place a child for adoption, unless—
- the proposed adopter is a relative of the child, or
 - he is acting in pursuance of an order of the High Court.

[^{F28}(2) An adoption society which is—

- approved as respects Scotland under section 3 of the [Adoption \(Scotland\) Act 1978](#); or
- registered as respects Northern Ireland under Article 4 of the [Adoption \(Northern Ireland\) Order 1987](#),

but which is not [^{F29}an appropriate voluntary organisation], shall not act as an adoption society in England and Wales except to the extent that the society considers it necessary to do so in the interests of a person mentioned in section 1 of the Act of 1978 or Article 3 of the Order of 1987.]

- shall be guilty of an offence and liable on summary conviction to imprisonment for a term not exceeding 3 months or to a fine not exceeding [^{F30}level 5 on the standard scale] or to both.
- (4) In any proceedings for an offence under paragraph (a) of subsection (3), proof of things done or of words written, spoken or published (whether or not in the presence of any party to the proceedings) by any person taking part in the management or control of a body of persons, or in making arrangements for the adoption of children on behalf of the body, shall be admissible as evidence of the purpose for which that body exists.

ADOPTION ORDERS

The making of adoption orders

12 Adoption orders. **E+W**

- (1) An adoption order is an order [^{F32}giving parental responsibility for a child to] the adopters, made on their application by an authorised court.
- (2) The order does not affect [^{F33}parental responsibility so far as it relates] to any period before the making of the order.
- (3) The making of an adoption order operates to extinguish—
 - [^{F34}(a) the parental responsibility which any person has for the child immediately before the making of the order;
 - (aa) any order under the Children Act 1989]

- (b) any duty arising by virtue of an agreement or the order of a court to make payments, so far as the payments are in respect of the child's maintenance [^{F35}or upbringing for any period after the making of the order.]
- (4) Subsection (3)(b) does not apply to a duty arising by virtue of an agreement—
 - (a) which constitutes a trust, or
 - (b) which expressly provides that the duty is not to be extinguished by the making of an adoption order.
- (5) An adoption order may not be made in relation to a child who is or has been married.
- (6) An adoption order may contain such terms and conditions as the court thinks fit.
- (7) An adoption order may be made notwithstanding that the child is already an adopted child.

13 Child to live with adopters before order made. **E+W**

- (1) Where—
 - (a) [^{F36}(subject to subsection (1A))]the applicant, or one of the applicants, is a parent, step-parent or relative of the child, or
 - (b) the child was placed with the applicants by an adoption agency or in pursuance of an order of the High Court,

an adoption order shall not be made unless the child is at least 19 weeks old and at all times during the preceding 13 weeks had his home with the applicants or one of them.
- [^{F37}(1A) Where an adoption is proposed to be effected by a Convention adoption order, the order shall not be made unless at all times during the preceding six months the child had his home with the applicants or one of them.]
- (2) Where subsection (1)[^{F38}or (1A)] does not apply, an adoption order shall not be made unless the child is at least 12 months old and at all times during the preceding 12 months had his home with the applicants or one of them.
- (3) An adoption order shall not be made unless the court is satisfied that sufficient opportunities to see the child with the applicant, or, in the case of an application by a married couple, both applicants together in the home environment have been afforded—

33 Duty of local authorities to secure well-being of protected children. **E+W**

39 Status conferred by adoption. **E+W**

- (1) An adopted child shall be treated in law—
- where the adopters are a married couple, as if he had been born as a child of the marriage (whether or not he was in fact born after the marriage was solemnized);
 - in any other case, as if he had been born to the adopter in wedlock (but not as a child of any actual marriage of the adopter).

41 Adoptive relatives. **E+W**

A relationship existing by virtue of section 39 may be referred to as an adoptive relationship, and—

- (a) a male adopter may be referred to as the adoptive father;
- (b) a female adopter may be referred to as the adoptive mother;
- (c) any other relative of any degree under an adoptive relationship may be referred to as an adoptive relative of that degree.

- (4) The Registrar General shall, in addition to the Adopted Children Register and the index thereof, keep such other registers and books, and make such entries therein, as may be necessary to record and make traceable the connection between any entry in the Registers of Births which has been marked “Adopted” and any corresponding entry in the Adopted Children Register.
- (5) The registers and books kept under subsection (4) shall not be, nor shall any index thereof be, open to public inspection or search, and the Registrar General shall not furnish any person with any information contained in or with any copy or extracted from any such registers or books except in accordance with section 51 or under an order of any of the following courts, that is to say—
 - (a) the High Court;
 - (b) the Westminster County Court or such other county court as may be prescribed; and
 - (c) the court by which an adoption order was made in respect of the person to whom the information, copy or extract relates.

- (1) The Registrar General shall maintain at the General Register Office a register to be called the Adoption Contact Register.
- (2) The register shall be in two parts—
 - (a) Part I: Adopted Persons; and
 - (b) Part II: Relatives.
- (3) The Registrar General shall, on payment of such fee as may be prescribed, enter in Part I of the register the name and address of any adopted person who fulfils the conditions in subsection (4) and who gives notice that he wishes to contact any relative of his.

TRANSITIONAL PROVISIONS AND SAVINGS
