1 Finance for forestry. **E+W+S**

[^{F1}(1) The Forestry Commissioners may, with Treasury approval [^{F2}as regards England ^{F3}..., ^{F4}...], make grants and loans to owners and lessees of land [^{F5}in England ^{F6}...] for and in connection with the use and management of the land for forestry purposes.

[^{F7}(2) Any such grant or loan shall be payable in accordance with section 41 of the Forestry Act 1967.]
