### CRIMINAL JURISDICTION AND PROCEDURE

#### *Jurisdiction to issue process and deal with charges*

#### **1 Issue of summons to accused or warrant for his arrest. **E+W****

[<sup>F1</sup>(1) On an information being laid before a justice of the peace that a person has, or is suspected of having, committed an offence, the justice may issue—

- (a) a summons directed to that person requiring him to appear before a magistrates' court to answer the information, or
- (b) a warrant to arrest that person and bring him before a magistrates' court.]

(2) <sup>F2</sup>.....

(3) No warrant shall be issued under this section unless the information is in writing <sup>F3</sup>.....

(4) No warrant shall be issued under this section for the arrest of any person who has attained [<sup>F4</sup> the age of 18 years] unless—

- (a) the offence to which the warrant relates is an indictable offence or is punishable with imprisonment, or
- (b) the person's address is not sufficiently established for a summons to be served on him.

[<sup>F5</sup>(4A) Where a person who is not a public prosecutor lays an information before a justice of the peace in respect of an offence to which this subsection applies, no warrant shall be issued under this section without the consent of the Director of Public Prosecutions.

(4B) In subsection (4A) “public prosecutor” has the same meaning as in section 29 of the Criminal Justice Act 2003.

(4C) Subsection (4A) applies to—

- (a) a qualifying offence which is alleged to have been committed outside the United Kingdom, or
- (b) an ancillary offence relating to a qualifying offence where it is alleged that the qualifying offence was, or would have been, committed outside the United Kingdom.

(4D) In subsection (4C) “qualifying offence” means any of the following—

- (a) piracy or an offence under section 2 of the Piracy Act 1837 (piracy where murder is attempted);
- (b) an offence under section 1 of the Geneva Conventions Act 1957 (grave breaches of Geneva conventions);
- (c) an offence which (disregarding the provisions of the Suppression of Terrorism Act 1978, the Nuclear Material (Offences) Act 1983, the United Nations Personnel Act 1997 and the Terrorism Act 2000) would not be an offence apart from section 1 of the Internationally Protected Persons Act 1978 (attacks and threats of attacks on protected persons);
- (d) an offence under section 1 of the Taking of Hostages Act 1982 (hostage-taking);
- (e) an offence under section 1, 2 or 6 of the Aviation Security Act 1982 (hijacking etc);
- (f) an offence which (disregarding the provisions of the Internationally Protected Persons Act 1978, the Suppression of Terrorism Act 1978, the United Nations Personnel Act 1997 and the Terrorism Act 2000) would not be an offence apart from sections 1 to 2A of the Nuclear Material (Offences) Act 1983 (offences relating to nuclear material);
- (g) an offence under section 134 of the Criminal Justice Act 1988 (torture);
- (h) an offence under section 1 of the Aviation and Maritime Security Act 1990 (endangering safety at aerodromes);
- (i) an offence under sections 9 to 14 of that Act (hijacking ships etc);
- (j) an offence which (disregarding the provisions of the Internationally Protected Persons Act 1978, the Suppression of Terrorism Act 1978, the Nuclear Material (Offences) Act 1983 and the Terrorism Act 2000) would not be an offence apart from sections 1 to 3 of the United Nations Personnel Act 1997 (attacks on UN workers etc).

- (a) an offence under Part 2 of the Serious Crime Act 2007 (encouraging or assisting crime) in relation to the offence (including, in relation to times before the commencement of that Part, an offence of incitement);

#### <sup>F62</sup> Trial of summary offences **E+W**

- (1) A magistrates' court has jurisdiction to try any summary offence.
- (2) A magistrates' court has jurisdiction [<sup>F7</sup>under sections 51 and 51A of the Crime and Disorder Act 1998 in respect of] any offence committed by a person who appears or is brought before the court.
- (3) Subject to—
- sections 18 to 22, and
  - any other enactment (wherever contained) relating to the mode of trial of offences triable either way,
- a magistrates' court has jurisdiction to try summarily any offence which is triable either way.
- (4) A magistrates' court has jurisdiction, in the exercise of its powers under section 24, to try summarily an indictable offence.

## *Committal proceedings*

### 4 General nature of committal proceedings. **E+W**

- (1) The functions of examining justices may be discharged by a single justice.
- (2) Examining justices shall sit in open court except where any enactment contains an express provision to the contrary and except where it appears to them as respects the whole or any part of committal proceedings that the ends of justice would not be served by their sitting in open court.

### 5 Adjourning of inquiry. **E+W**

## 7 Place of trial on indictment. **E+W**

## 8 Restrictions on reports of committal proceedings. **E+W+S**

## **8A Power to make rulings at pre-trial hearing** **E+W**

- (1) For the purposes of this section a hearing is a pre-trial hearing if—
- it relates to an information—
    - which is to be tried summarily, and
    - to which the accused has pleaded not guilty, and
  - it takes place before the start of the trial.

### 8B Effect of rulings at pre-trial hearing E+W

- (1) Subject to subsections (3) and (6), a ruling under section 8A has binding effect from the time it is made until the case against the accused or, if there is more than one, against each of them, is disposed of.
- (2) The case against an accused is disposed of if—
  - (a) he is acquitted or convicted,
  - (b) the prosecutor decides not to proceed with the case against him, or
  - (c) the information is dismissed.

## 8C Restrictions on reporting **E+W**

- (1) Except as provided by this section no report of matters falling within subsection (2) may be published in England and Wales.
- (2) The following matters fall within this subsection—

## **9 Procedure on trial. E+W**

- (1) On the summary trial of an information, the court shall, if the accused appears, state to him the substance of the information and ask him whether he pleads guilty or not guilty.
- (2) The court, after hearing the evidence and the parties, shall convict the accused or dismiss the information.
- (3) If the accused pleads guilty, the court may convict him without hearing evidence.

## **10 Adjournment of trial. E+W**

- (1) A magistrates' court may at any time, whether before or after beginning to try an information, adjourn the trial, and may do so, notwithstanding anything in this Act, when composed of a single justice.
- (2) The court may when adjourning either fix the time and place at which the trial is to be resumed, or, unless it remands the accused, leave the time and place to be determined later by the court; but the trial shall not be resumed at that time and place unless the court is satisfied that the parties have had adequate notice thereof.
- (3) A magistrates' court may, for the purpose of enabling inquiries to be made or of determining the most suitable method of dealing with the case, exercise its power to adjourn after convicting the accused and before sentencing him or otherwise dealing with him; but, if it does so, the adjournment shall not be for more than 4 weeks at a time unless the court remands the accused in custody and, where it so remands him, the adjournment shall not be for more than 3 weeks at a time.

## 11 Non-appearance of accused: general provisions. **E+W**

- (1) Subject to the provisions of this Act, where at the time and place appointed for the trial or adjourned trial of an information the prosecutor appears but the accused does not,  
 [F48(a) if the accused is under 18 years of age, the court may proceed in his absence; and  
 (b) if the accused has attained the age of 18 years, the court shall proceed in his absence unless it appears to the court to be contrary to the interests of justice to do so.

### 13 Non-appearance of accused: issue of warrant. **E+W**

(1) Subject to the provisions of this section, where the court, instead of proceeding in the absence of the accused, adjourns or further adjourns the trial, the court may, <sup>F66</sup> . . . , issue a warrant for his arrest.

**14 Proceedings invalid where accused did not know of them. E+W**

- (1) Where a summons has been issued under section 1 above and a magistrates' court has begun to try the information to which the summons relates, then, if—

## **15 Non-appearance of prosecutor.** E+W

## 19 **Court to begin by considering which mode of trial appears more suitable.** E

+W

- (1) The court shall consider whether, having regard to the matters mentioned in subsection (3) below and any representations made by the prosecutor or the accused, the offence appears to the court more suitable for summary trial or for trial on indictment.
- (2) Before so considering, the court—

## 22 **Certain offences triable either way to be tried summarily if value involved is small.** **E+W**

- (1) If the offence charged by the information is one of those mentioned in the first column of Schedule 2 to this Act (in this section referred to as “scheduled offences”) then, <sup>F89</sup> . . . the court shall, before proceeding in accordance with section 19 above, consider whether, having regard to any representations made by the prosecutor or the accused, the value involved (as defined in subsection (10) below) appears to the court to exceed the relevant sum.

## 24 Summary trial of information against child or young person for indictable offence. **E+W**

**32 Penalties on summary conviction for offences triable either way. E+W**

### 33 Maximum penalties on summary conviction in pursuance of section 22. **E+W**

## 61 Periodical payments payable by one person under more than one order. **E+W**

- (1) [<sup>F197</sup>Rules of court may] make provision—

## **62 Provisions as to payments required to be made to a child, etc.** **E+W**

(1) Where—

- (a) periodical payments are required to be made, or a lump sum is required to be paid, to a child under an order made by a magistrates’ court, or
- (b) periodical payments are required to be made to a child under an order which is registered in a magistrates’ court,

any sum required under the order to be paid to the child may be paid to the person with whom the child has his home, and that person—

### *Orders other than for payment of money*

## **63 Orders other than for payment of money. E+W**

(1) Where under any Act passed after 31st December 1879 a magistrates' court has power to require the doing of anything other than the payment of money, or to prohibit the doing of anything, any order of the court for the purpose of exercising that power may contain such provisions for the manner in which anything is to be done, for the time within which anything is to be done, or during which anything is not to be done, and generally for giving effect to the order, as the court thinks fit.

(2) The court may by order made on complaint suspend or rescind any such order as aforesaid.

- but a person who is ordered to pay a sum for every day during which he is in default or who is committed to custody until he has remedied his default shall not by virtue of this section be ordered to pay more than £1,000 or be committed for more than 2 months in all for doing or abstaining from doing the same thing contrary to the order (without prejudice to the operation of this section in relation to any subsequent default).
- (4) Any sum ordered to be paid under subsection (3) above shall for the purposes of this Act be treated as adjudged to be paid by a conviction of a magistrates' court.
- (5) The preceding provisions of this section shall not apply to any order for the enforcement of which provision is made by any other enactment.

## 69 **Sittings of magistrates' courts for domestic proceedings.** **E+W**

- (1) The business of magistrates' courts shall, so far as is consistent with the due dispatch of business, be arranged in such manner as may be requisite for separating the hearing and determination of [<sup>F256</sup>family proceedings] from other business.

[<sup>F268</sup>(1) In the case of [<sup>F269</sup>family proceedings] in a magistrates' court <sup>F270</sup>. . . it shall not be lawful for a person to whom this subsection applies—

## 76 Enforcement of sums adjudged to be paid. **E+W**

## 77 Postponement of issue of warrant. **E+W**

## 78 Defect in distress warrant and irregularity in its execution. **E+W**

- (1) A warrant of distress issued for the purpose of levying a sum adjudged to be paid by the conviction or order of a magistrates' court shall not, if it states that the sum has been so adjudged to be paid, be held void by reason of any defect in the warrant.
- (2) A person acting under a warrant of distress shall not be deemed to be a trespasser from the beginning by reason only of any irregularity in the execution of the warrant.
- (3) Nothing in this section shall prejudice the claim of any person for special damages in respect of any loss caused by a defect in the warrant or irregularity in its execution.
- (4) If any person removes any goods marked in accordance with [<sup>F287</sup>rules of court] as articles impounded in the execution of a warrant of distress, or defaces or removes any such mark, he shall be liable on summary conviction to a fine not exceeding [<sup>F288</sup>level 1 on the standard scale].
- (5) If any person charged with the execution of a warrant of distress wilfully retains from the proceeds of a sale of the goods on which distress is levied, or otherwise exacts, any greater costs and charges than those properly payable, or makes any improper charge,

## 79 Release from custody and reduction of detention on payment. **E+W**

- (1) Where imprisonment or other detention has been imposed on any person by the order of a magistrates' court in default of payment of any sum adjudged to be paid by the conviction or order of a magistrates' court or for want of sufficient distress to satisfy such a sum, then, on the payment of the sum, together with the costs and charges, if any, of the commitment and distress, the order shall cease to have effect; and if the person has been committed to custody he shall be released unless he is in custody for some other cause.
- (2) Where, after a period of imprisonment or other detention has been imposed on any person in default of payment of any sum adjudged to be paid by the conviction or order of a magistrates' court or for want of sufficient distress to satisfy such a sum, payment is made in accordance with [<sup>F289</sup>rules of court] of part of the sum, the period of detention shall be reduced by such number of days as bears to the total number of days in that period less one day the same proportion as the amount so paid bears to so much of the said sum, and the costs and charges of any distress levied to satisfy that sum, as was due at the time the period of detention was imposed.
- (3) In calculating the reduction required under subsection (2) above any fraction of a day shall be left out of account.

## 80 Application of money found on defaulter to satisfy sum adjudged. **E+W**

## **81 Enforcement of fines imposed on young offenders.** **E+W**

- (1) Where a magistrates' court would, but for [<sup>F291</sup>section 89 of the Powers of Criminal Courts (Sentencing) Act 2000], have power to commit to prison a person under [<sup>F292</sup>the age of 18] for a default consisting in failure to pay, or want of sufficient distress to satisfy, a sum adjudged to be paid by a conviction, the court may, subject to the following provisions of this section, make—
  - (a) an order requiring the defaulter's parent or guardian to enter into a recognizance to ensure that the defaulter pays so much of that sum as remains unpaid; or
  - (b) an order directing so much of that sum as remains unpaid to be paid by the defaulter's parent or guardian instead of by the defaulter.
- (2) An order under subsection (1) above shall not be made in respect of a defaulter—
  - (a) in pursuance of paragraph (a) of that subsection, unless the parent or guardian in question consents;
  - (b) in pursuance of paragraph (b) of that subsection, unless the court is satisfied in all the circumstances that it is reasonable to make the order.
- (3) None of the following orders, namely—
  - (a) an order under [<sup>F293</sup>section 60(1) of the said Act of 2000 <sup>M40</sup>] for attendance at an attendance centre; or
  - (b) any order under subsection (1) above,shall be made by a magistrates' court in consequence of a default of a person under [<sup>F292</sup>the age of 18] years consisting in failure to pay, or want of sufficient distress to satisfy, a sum adjudged to be paid by a conviction unless the court has since the conviction inquired into the defaulter's means in his presence on at least one occasion.
- (4) An order under subsection (1) above shall not be made by a magistrates' court unless the court is satisfied that the defaulter has, or has had since the date on which the sum in question was adjudged to be paid, the means to pay the sum or any instalment of it on which he has defaulted, and refuses or neglects or, as the case may be, has refused or neglected, to pay it.

## 82 Restriction on power to impose imprisonment for default. **E+W**

- (1) A magistrates' court shall not on the occasion of convicting an offender of an offence issue a warrant of commitment for a default in paying any sum adjudged to be paid by the conviction unless—

- (2) A magistrates' court shall not in advance of the issue of a warrant of commitment fix a term of imprisonment which is to be served by an offender in the event of a default in paying a sum adjudged to be paid by a conviction, except where it has power to issue a warrant of commitment forthwith, but postpones issuing the warrant under section 77(2) above.

## 90 Transfer of fines to Scotland or Northern Ireland. **U.K.**

**93 Complaint for arrears. E+W**

#### 97 **Summons to witness and warrant for his arrest.** **E+W**

[<sup>F385</sup>(1) Where a justice of the peace is satisfied that—

- (a) any person in England or Wales is likely to be able to give material evidence, or produce any document or thing likely to be material evidence, at the summary trial of an information or hearing of a complaint [<sup>F386</sup>or of an application [<sup>F387</sup>in family proceedings]] by a magistrates' court, and
- (b) it is in the interests of justice to issue a summons under this subsection to secure the attendance of that person to give evidence or produce the document or thing,

the justice shall issue a summons directed to that person requiring him to attend before the court at the time and place appointed in the summons to give evidence or to produce the document or thing.]

- (2) If a justice of the peace is satisfied by evidence on oath of the matters mentioned in subsection (1) above, and also that it is probable that a summons under that subsection would not procure the attendance of the person in question, the justice may instead of issuing a summons issue a warrant to arrest that person and bring him before such a court as aforesaid at a time and place specified in the warrant; but a warrant shall not be issued under this subsection where the attendance is required for the hearing of a complaint [<sup>F388</sup>or of an application [<sup>F389</sup>in family proceedings]] .

[<sup>F390</sup>(2A) A summons may also be issued under subsection (1) above if the justice is satisfied that the person in question is outside the British Islands but no warrant shall be issued under subsection (2) above unless the justice is satisfied by evidence on oath that the person in question is in England or Wales.]

(10) If in pursuance of this section a person produces an exhibit which is a document, the [<sup>F401</sup>designated officer for] the justice concerned shall as soon as is reasonably practicable send a copy of the document to the prosecutor.

(11) If in pursuance of this section a person produces an exhibit which is not a document, the [<sup>F401</sup>designated officer for] the justice concerned shall as soon as is reasonably practicable inform the prosecutor of the fact and of the nature of the exhibit.]

## 104 Proof of previous convictions. **E+W**

#### 107 False statements in declaration proving service, etc. **E+W**

**109 Abandonment of appeal. E+W**

- (6) Where justices refuse to state a case, the High Court may, on the application of the person who applied for the case to be stated, make an order of mandamus requiring the justices to state a case.

*Recognizances to keep the peace or be of good behaviour*

**115 Binding over to keep the peace or be of good behaviour. E+W**

- (1) The power of a magistrates' court on the complaint of any person to adjudge any other person to enter into a recognizance, with or without sureties, to keep the peace or to be of good behaviour towards the complainant shall be exercised by order on complaint.

## **118 Varying or dispensing with requirement as to sureties. E+W**

### 120 Forfeiture of recognizance. **E+W**

### 130 Transfer of remand hearings. **E+W**
