8A Power to make rulings at pre-trial hearing E+W

8B Effect of rulings at pre-trial hearing **E+W**

8C Restrictions on reporting **E+W**

11 Non-appearance of accused: general provisions. **E+W**

- (1) Subject to the provisions of this Act, where at the time and place appointed for the trial or adjourned trial of an information the prosecutor appears but the accused does not,

77 Postponement of issue of warrant. E+W

- (1) Where a magistrates' court has power to issue a [^{F278}warrant of control] under this Part of this Act, it may, if it thinks it expedient to do so, postpone the issue of the warrant until such time and on such conditions, if any, as the court thinks just.
- (2) Where a magistrates' court has power to issue a warrant of commitment under this Part of this Act, it may, if it thinks it expedient to do so, fix a term of imprisonment [^{F279}or detention under [^{F280}section 108 of the powers of Criminal Courts (Sentencing) Act 2000] (detention of persons aged [^{F280}18] to 20 for default)] and postpone the issue of the warrant until such time and on such conditions, if any, as the court thinks just.

78 Defect in distress warrant and irregularity in its execution. **E+W**

- (1) A warrant of distress issued for the purpose of levying a sum adjudged to be paid by the conviction or order of a magistrates' court shall not, if it states that the sum has been so adjudged to be paid, be held void by reason of any defect in the warrant.
- (2) A person acting under a warrant of distress shall not be deemed to be a trespasser from the beginning by reason only of any irregularity in the execution of the warrant.
- (3) Nothing in this section shall prejudice the claim of any person for special damages in respect of any loss caused by a defect in the warrant or irregularity in its execution.
- (4) If any person removes any goods marked in accordance with [^{F285}rules of court] as articles impounded in the execution of a warrant of distress, or defaces or removes any such mark, he shall be liable on summary conviction to a fine not exceeding [^{F286}level 1 on the standard scale].
- (5) If any person charged with the execution of a warrant of distress wilfully retains from the proceeds of a sale of the goods on which distress is levied, or otherwise exacts, any greater costs and charges than those properly payable, or makes any improper charge, he shall be liable on summary conviction to a fine not exceeding [^{F286}level 1 on the standard scale].

79 Release from custody and reduction of detention on payment. **E+W**

- (1) Where imprisonment or other detention has been imposed on any person by the order of a magistrates' court in default of payment of any sum adjudged to be paid by the conviction or order of a magistrates' court or for want of sufficient [^{F287}goods] to satisfy such a sum, then, on the payment of the sum, together with the costs and charges, if any, of the commitment[^{F288}, or (as the case may be) on the payment of the amount outstanding,] the order shall cease to have effect; and if the person has been committed to custody he shall be released unless he is in custody for some other cause.

80 Application of money found on defaulter to satisfy sum adjudged. **E+W**

- (1) Where a magistrates' court has adjudged a person to pay a sum by a conviction ^{F293} ..., the court may order him to be searched.

Recognizances to keep the peace or be of good behaviour

115 Binding over to keep the peace or be of good behaviour. E+W

- (1) The power of a magistrates' court on the complaint of any person to adjudge any other person to enter into a recognizance, with or without sureties, to keep the peace or to be of good behaviour towards the complainant shall be exercised by order on complaint.

- (1) Where a magistrates' court has power to remand any person, then, subject to section 4 of the ^{M27}Bail Act 1976 and to any other enactment modifying that power, the court may—
- (a) remand him in custody, that is to say, commit him to custody to be brought before the court [^{F529}, subject to subsection (3A) below,] at the end of the period of remand or at such earlier time as the court may require; or

TRANSITIONAL PROVISIONS AND SAVINGS

Interpretation

- 1 In this Schedule references to the old enactments are to enactments repealed or amended by this Act and references to the appointed day are to the day on which this Act comes into force.

Proceedings commenced before appointed day

- 2 (1) Where proceedings were commenced before the appointed day, the old enactments relating to the proceedings continue to apply and nothing in this Act affects those enactments.
