##### *Power to alter sums specified in certain provisions*

#### [<sup>F1</sup>143] Power to alter sums specified in certain provisions.

[<sup>F2</sup>(1) If it appears to the Secretary of State that there has been a change in the value of money since the relevant date, he may by order substitute for the sum or sums for the time being specified in any provision mentioned in subsection (2) below such other sum or sums as appear to him justified by the change.]

- (6) An order under subsection (1) <sup>F13</sup> above—
- (a) shall be made by statutory instrument subject to annulment in pursuance of a resolution of either House of Parliament and may be revoked by a subsequent order thereunder; and
