An Act to provide for compensation out of public funds for certain past cases of dismissal for failure to conform to the requirements of a union membership agreement; to amend the law relating to workers, employers, trade unions and employers' associations; to make provision with respect to awards by [FI employment tribunals] and awards by, and the procedure of, the Employment Appeal Tribunal; and for connected purposes. 
