Orders [Fland regulations]

120 Orders.

- (1) The power to make an order under [F1section 134(1)] is exercisable by statutory instrument, and different days may be appointed by such an order for different provisions or for different purposes.
- (2) An order under section ^{F2}... 134(1) (a), (b) or (c) below may contain such transitional provisions and savings as appear to the Secretary of State [F3 or Welsh Ministers] to be necessary or expedient in connection with the provisions thereby brought into force, including such adaptations of those provisions as appear to [F4 the Secretary of State or Welsh Ministers] necessary or expedient in consequence of the partial operation of this Act (whether before or after the day appointed by the order).
