# **1984 CHAPTER 55**

## PART I

## BUILDING REGULATIONS

Power to make building regulations

## [<sup>F1</sup>1A Buildings of special historical or architectural interest

- (1) In making building regulations the [<sup>F2</sup>appropriate national authority] shall have regard, in particular, to the desirability of preserving the character of protected buildings that are of special historical or architectural interest.
- (2) In this section "protected buildings" means—
  - (a) listed buildings within the meaning of the Planning (Listed Buildings and Conservation Areas) Act 1990 (see section 1(5) of that Act); and
  - (b) buildings situated in areas designated as conservation areas under section 69 of that Act.]
