# [F1 6A The Corporation

- (1) In this Act "the [F2Relevant Authority]" means the [F3Regulator of Social Housing], [F4the Secretary of State] or Scottish Homes, subject as follows.
- (2) In relation to a housing association which is—
  - (a) a registered charity which has its address for the purposes of registration by the [F5Charity Commission] in Wales,
  - (b) a [<sup>F6</sup>registered society within the meaning of the Co-operative and Community Benefit Societies Act 2014] which has its registered office for the purposes of that Act in Wales, or
  - (c) a company [F7 registered under the Companies Act 2006] which has its registered office for the purposes of that Act in Wales,
  - "the [F2Relevant Authority]" means [F4the Secretary of State].
- (3) In relation to a housing association which is a [F6 registered society within the meaning of the Co-operative and Community Benefit Societies Act 2014] which has its registered office for the purposes of that Act in Scotland, "the [F2Relevant Authority]" means Scottish Homes.
- (4) In relation to any other housing association which is a registered charity, a [F6 registered society within the meaning of the Co-operative and Community Benefit Societies Act 2014] or a company [F7 registered under the Companies Act 2006], "the [F2 Relevant Authority]" means the [F8 Regulator of Social Housing].
- [ This section is subject to any provision made elsewhere in this Act.]  $^{F9}(4A)$
