REGULATION OF HOUSING ASSOCIATIONS

Introductory

[^{F1}2B Meaning of “registered housing association”, “registered social landlord” etc.

In this Act, unless the context otherwise requires—

“registered housing association” means a housing association registered in the register [^{F2}of social landlords maintained under [^{F3}section 20(1) of the Housing (Scotland) Act 2010 (asp 17)],

[^{F4}“registered social landlord” has the same meaning as in Part I of the Housing Act 1996, and]

[^{F5}“unregistered”, in relation to a housing association, means [^{F6}not] registered in the register of social landlords maintained under [^{F7}section 20(1) of the Housing (Scotland) Act 2010 (asp 17)].]

[^{F5}“unregistered”, in relation to a housing association, means—

- (a) not registered as a provider of social housing under Part 2 of the Housing and Regeneration Act 2008,
- (b) not registered as a social landlord under Part 1 of the Housing Act 1996, and
- (c) not registered as a social landlord under [^{F8}Part 2 of the Housing (Scotland) Act 2010 (asp 17)].]
