[F1 THE HOUSING CORPORATION][F1 SOCIAL HOUSING IN WALES]

[FI Relevant Authority's] powers with respect to grants and loans

83 Power to guarantee loans.

- [F1(1) The Welsh Ministers may guarantee the repayment of the principal of, and the payment of interest on, sums borrowed by registered social landlords or unregistered self-build societies.
 - (2) A guarantee may be subject to terms and conditions.]
- [F2(3A) The aggregate amount outstanding in respect of—
 - (a) loans for [F3which the Welsh Ministers (or National Assembly for Wales, Secretary of State or Housing for Wales) have] given a guarantee under this section, and
 - (b) payments made [F4by the Welsh Ministers (or National Assembly for Wales, Secretary of State or Housing for Wales) in] meeting an obligation arising by virtue of such a guarantee and not repaid [F5 to the Welsh Ministers (or National Assembly for Wales, Secretary of State or Housing for Wales)],

shall not exceed £30 million or such greater sum not exceeding £50 million [^{F6}as the Welsh Ministers may specify by order].]

[^{F7}(4) An order under subsection (3A)—

- (a) shall be made by statutory instrument, and
- (b) shall not be made unless, a draft of the order has been laid before, and approved by a resolution of, the National Assembly for Wales.]
